### BILLS ON THIRD READING

#### **HJR 1723 (3R) by the Committee on Judiciary (JC), Representative Simmons and others—**

**Initiatives/60 Percent of Electors;** constitutional amendment to require that any proposed amendment to or revision of State Constitution, whether proposed by Legislature, by initiative, or by any other method, must be approved by at least 60 percent of voters of state voting on measure, rather than by simple majority, etc. Amends s. 5, Art. XI.

*Substituted for **CS/SJR 6 (SUB)** (King) and read the second time on May 2, 2005*

#### **HJR 1727 (3R) by the Committee on Judiciary (JC), Representative Simmons and others—**

**Constitution Amendments/Initiative;** constitutional amendment to provide that revision or amendment proposed by initiative must amend or repeal existing section of Constitution on same subject & matter; must address basic or fundamental right of citizen of this state; or must change basic structure of govt. as established in Articles II, III, IV, or V of Constitution, except that no revision or amendment may deprive branches of govt. of any existing powers, etc. Amends s. 3, Art. XI.

*Substituted for **CS/SJR 4 (SUB)** (King), read the second time and amended on May 2, 2005*

---

#### **HJR 1741 (3R) by the Committee on Judiciary (JC), Representative Simmons and others—**

**State Taxes or Fees;** constitutional amendment to require approval by at least two-thirds of voters of state voting in election on any proposed amendment or revision to State Constitution imposing or authorizing imposition of any new tax or fee, increasing or authorizing increase in any existing tax or fee, or imposing significant fiscal impact on state, counties, school districts, municipalities, or special districts, etc. Amends s. 7, Art. XI.

*Substituted for **CS/SJR 2200 (SUB)** (Atwater), read the second time and amended on May 2, 2005*

---

#### **HB 1471 (3R) by Representative Goodlette and others—**

**Petition Fraud/Voter Protection Act;** provides for certain petitions to be verified by certain method; requires certain provisions to be satisfied before signature on petition may be counted; revises requirements for placement of constitutional amendments proposed by initiative on ballot for general election; provides for regulation of initiative petition circulators, etc. Amends Chs. 99, 100, 101, 104. Effective Date: 08/01/2005.

*Substituted for **CS/CS/SB 1996 (SUB)** (Alexander), read the second time and amended on May 2, 2005*

---

**HB 1267 (3R) by Representative Stargel and others—**

**Nursing Homes;** provides for alternative bed locations in nursing home rooms & provides criteria for bed placement; requires signed statement from resident or representative if alternative bed placement is not in compliance with Fla. Building Code; requires facility to maintain log of alternative bed placements & to retain signed statements; requires nursing homes to be protected by certain automatic sprinkler systems, etc. Amends Chs. 400, 633. Effective Date: 07/01/2005.

*Substituted for **SB 2572 (SUB)** (Webster) and read the second time on May 4, 2005*

---

**CS/SB 2032 (3R) by the Committee on General Government Appropriations and Senator Atwater—**

**Tax Administration;** allows estate that is not required to file federal tax return to file with clerk of court affidavit attesting that no Florida estate tax is due, regardless of decedent's date of death; provides special provisions for imposition of tax on deeds or other instruments re real property or interests in real property imposed by this section on sale of timeshare interest in timeshare plan; amends provisions re fuel taxes, etc. Amends FS. Effective Date: 07/01/2005 except as otherwise provided.

*Read the second time and amended on May 4, 2005*

*Compare to **HB 1813 (HC)** in the Committees on Government Efficiency Appropriations, Commerce and Consumer Services, Criminal Justice, General Government Appropriations, and Ways and Means*

---

**HB 1907 (3R) by the Fiscal Council and others—**

**FRS/Payroll Contribution Rates;** revises payroll contribution rates for membership classes of Fla. Retirement System for state fiscal years effective July 1, 2005, & July 1, 2006. Amends 121.71. Effective Date: 07/01/2005.

*Read the second time and amended on May 4, 2005*

---

**HB 643 (3R) by Representative Bowen and others—**

**Sales Tax Exempt/Farm Equipment;** revises definitions; makes total a partial exemption for certain farm equipment; corrects cross reference to conform. Amends 212.02,.08,.12. Effective Date: 07/01/2005.

*Substituted for **CS/SB 696 (SUB)** (Smith) and read the second time on May 4, 2005*

---

**CS/CS/SB 2542 (3R) by the Committees on Justice Appropriations, Judiciary, Senator Smith and others—**

**State Judicial System;** revises requirements for private court-appointed counsel; requires that circuit Article V indigent services committee establish compensation rates for court-appointed counsel or in cases of indigency; provides funding for teen court through assessment of additional court cost against each person who pleads guilty or nolo contendere to, or is convicted of, violation of criminal law, ordinance, or traffic offense in county, etc. Amends FS. Effective Date: 07/01/2005 except as otherwise provided.

*Read the second time and amended on April 29, 2005*

---

**HB 1159 (3R) by Representative Bogdanoff and others—**

**Florida Retirement System;** permits, during specified period of time, local government employees who are members of Senior Management Service Class, who have withdrawn from FRS, to elect membership in defined benefit program or public employee optional retirement program of system; provides that any municipality that provides fire protection services to another municipality under interlocal agreement is eligible to receive premium taxes, etc. Amends Ch. 121.055, 175.041,.101. Effective Date: 10/01/2005.

*Substituted for **CS/SB 1624 (SUB)** (Campbell) and read the second time on May 4, 2005*

---

**HB 1717 (3R) by the Committee on Agriculture (SRC) and Representative Stansel—**

**Agriculture;** clarifies value for purpose of assessment for ad valorem taxes of certain property leased by DOACS; provides for investigation of complaints; revises provisions re packages on which information is required; prohibits cultivation of nonnative plants for purposes of fuel production or purposes other than agriculture in plantings greater than specified size, except under special permit issued by department, etc. Amends FS. Effective Date: 07/01/2005.

*Substituted for **CS/CS/CS/SB 858 (SUB)** (Smith), read the second time and amended on May 4, 2005*

---

**CS/CS/SB 2502 (3R) by the Committees on Governmental Oversight and Productivity, Environmental Preservation and Senator Dockery—**

**Water Management Districts;** authorizes each water management district to establish small business program to encourage small businesses, including those owned by women & minorities, to participate in procurement & contract activities; allows water management district government board member to serve until replacement has been appointed; extends deadline for water management districts to update certain regional water supply plans, etc. Amends Ch. 373; creates 373.1135. Effective Date: Upon becoming law.

---

**HJR 1843 (3R) by the Committee on Choice & Innovation (EDC), Representative Stargel and others—**

**School Classroom Size/Teacher's Pay;** constitutional amendment to provide that maximum class size requirements shall be based on district average number of students who are assigned to teacher in specified grades, to move forward date for implementation of class size requirements, to require that minimum salary for each public school teacher shall be no less than \$35,000 & shall be higher than national average beginning pay, etc. Amends s.1, Art. IX, s. 26, Art. XII.

---

**HB 1855 (3R) by the Committee on Environmental Regulation (SRC), Representative Needelman and others—**

**Natural Resources;** provides alternative to compensation schedule for calculating natural resources damages; revises procedures re damage assessment; revises factors for determining substantial deviation in developments of regional impact; revises federally licensed or permitted activities subject to consistency review under coastal management program, etc. Amends 376.121, 380.06,.23. Effective Date: Upon becoming law.

*Substituted for **CS/SB 2510 (SUB)** (Lawson), read the second time and amended on May 4, 2005*

---

**HB 1377 (3R) by Representative Ryan—**

**Ethics;** prohibits state or political subdivision employees from participating in political campaigns during on-duty hours or certain other hours; revises postemployment restrictions to apply to other-personal-services temporary employees; exempts certain agency employees from such restrictions; revises prohibition on lobbying by former local officers to preclude representation before government body or agency an officer has served, etc. Amends FS. Effective Date: 10/01/2005.

*Substituted for **CS/CS/SB's 1944 & 2008 (SUB)** (Posey), read the second time and amended on May 4, 2005*

---

**HB 1025 (3R) by Representative Waters and others—**

**Misuse of Laser Lighting Devices;** revises definition of "laser lighting device"; provides that any person who knowingly & willfully aims laser lighting device at person operating motor vehicle, vessel, or aircraft commits felony of third degree; provides that any person who causes bodily harm while improperly pointing said device at operator of motor vehicle, vessel, or aircraft commits felony of second degree; provides penalties. Amends 784.062. Effective Date: 07/01/2005.

---

**HB 1681 (3R) by the Committee on Transportation (SIC), Representative Sansom and others—**

**Transportation;** requires Fla. Seaport Transportation & Economic Development Council to establish matching funds program for certain dredging projects; requires adoption of rules & criteria for project evaluation; creates Northwest Fla. Transportation Corridor Authority encompassing Escambia, Santa Rosa, Okaloosa, Walton, Bay, Gulf, Franklin, & Wakulla Counties; creates Osceola Co. Expressway Authority as agency of state, etc. Amends FS. Effective Date: 07/01/2005.

*Substituted for **CS/CS/CS/SB 460 (SUB)** (Sebesta), read the second time and amended on May 4, 2005*

---

**HB 1325 (3R) by Representative Attkisson—**

**Local Govt. Economic Development;** specifies criteria for certification for remaining available certification slot for professional sports franchises; provides for notice of public hearings to consider whether local government will provide communications service; sets pricing standards; limits use of eminent-domain powers; requires local governmental provider of communications services to follow same prohibitions as other providers of same services, etc. Amends 288.1162. Effective Date: Upon becoming law.

*Substituted for **CS/CS/SB's 2072 & 1714 (SUB)** (Constantine), read the second time and amended on May 4, 2005*

---

**CS/SB 1184 (3R) by the Committee on Community Affairs and Senator Fasano—**

**Transportation Access;** provides that municipality may, by interlocal agreement with county, agree to transfer traffic regulatory authority over areas within municipality to county; revises criteria for establishing statutory way of necessity exclusive of common-law right; removes limitation on existence of certain easements; prohibits municipality from permanently closing road unless certain conditions are met, etc. Amends Ch. 704, 316.006; creates 166.0498. Effective Date: Upon becoming law.

*Read the second time and amended on May 4, 2005*

---

**HB 113 (3R) by Representative Dean and others—**

**Construction Contracting;** makes certain restrictions in bonds issued for public works projects unenforceable; postpones date for submitting application for certificate as registered contractor; prohibits private providers performing inspection services from performing or approving certain inspections under certain circumstances, etc. Amends Ch. 713, 255.05, 489.129, 533,.118. Effective Date: 10/01/2005.

*Substituted for **CS/CS/SB 1016 (SUB)** (Argenziano), read the second time and amended on May 4, 2005*

---

**HB 185 (3R) by Representative Harrell and others—**

**Public Records & Meetings Exemptions;** provides exemption from public records requirements for any information that reveals identity of surviving siblings, family members, or others living in home of deceased child who is subject of review by, & which information is held by, State Child Abuse Death Review Committee or local committee, or panel or committee assembled by state committee or local committee; provides statement of public necessity, etc. Creates 383.412. Effective Date: Upon becoming law.

*Substituted for CS/SB 676 (SUB) (Saunders) and read the second time on May 4, 2005*

---

**CS/CS/CS/SB 1062 (3R) by the Committees on Transportation and Economic Development Appropriations, Criminal Justice and the Committee on Domestic Security (Diaz de la Portilla)—**

**Seaport Security;** requires that FDLE establish waiver process for allowing individual, who is otherwise unqualified, to be allowed unescorted access to seaport or restricted access area; authorizes seaport authority or governing board of certain seaports to require that seaport security officers receive additional training & certification; provides continuing education requirements for certification, etc. Amends 311.12; creates 311.121, .122, .123. Effective Date: 07/01/2005.

*Read the second time and amended on May 4, 2005*

---

**HB 1659 (3R) by Representative Kottkamp and others—**

**Termination of Minor's Pregnancy;** provides that actual notice shall be given by physician who will perform termination of pregnancy procedure; specifies information required to be included in notices; provides circumstances in which prior notice is not required; provides that violation of notice requirements by physicians shall be considered medical malpractice; requires Supreme Court to ensure certain proceedings are conducted expeditiously & lawfully, etc. Amends 390.01115. Effective Date: 07/01/2005.

*Substituted for CS/SB 1908 (SUB) (Dockery), read the second time, third time, amended on April 27, 2005, and with pending amendments 1 (245870) and 1a (480528) by Senator Dockery on May 3, 2005*

---

**CS/CS/SB 1912 (3R) by the Committees on Judiciary, Banking and Insurance and Senator Argenziano—**

**Insurance Agents & Agencies;** includes insurance agencies among entities Financial Services Dept. is authorized to investigate; provides for electronic scanning in course of investigations & examinations; delays effective date by which agencies must obtain license; revises insurance agency licensure application requirements; revises examination requirements; authorizes dept. to disapprove use of certain names under certain circumstances, etc. Amends Chs. 624, 626, 648.50. Effective Date: 10/01/2005.

*Read the second time and amended on May 4, 2005*

**CS/SB 2348 (3R) by the Committee on Government Efficiency Appropriations, Senator Haridopolos and others—**

**Intangible Personal Property Tax;** reduces annual rate of tax. Amends 199.032. Effective Date: 01/01/2006.

*Read the second time on May 4, 2005*

---

**HB 579 (3R) by Representative Proctor and others—**

**Acceleration Mechanisms;** adds programs to list of public school choice options; adds programs to list of rigorous academic programs included in parent guide; specifies that dual enrollment courses are creditable toward high school completion; revises instructional time requirements & provides for FTE calculation; provides additional course weights for Fla. Bright Futures Scholarship Program eligibility determination, etc. Amends Chs. 1002, 1007, 1009, 1011.62. Effective Date: 07/01/2005.

*Substituted for CS/SB 664 (SUB) (Clary) and read the second time on May 4, 2005*

---

**HB 1129 (3R) by Representative D. Davis—**

**Economic Development/Entertainment;** changes term "television series" to "television programming" for purposes of definition of term "entertainment industry" in provisions establishing Film & Entertainment Office within Tourism, Trade, & Economic Development Office; revises program under which certain persons producing, or providing services for production of, filmed entertainment are eligible for state financial incentives for activities in or relocated to this state, etc. Amends Ch. 288. Effective Date: 07/01/2005.

*Substituted for CS/SB 1372 (SUB) (Saunders) and read the second time on May 4, 2005*

---

**HB 1567 (3R) by Representative Reagan and others—**

**Elections;** revises duties of Secretary of State as chief election officer; provides for applicant notification upon his or her failure to answer required information on voter registration application form; requires electors in line at official closing of polls to be allowed to vote; replaces paper ballots with marksense ballots & accompanying specifications; revises requirements re early voting locations, etc. Amends FS. Effective Date: 01/01/2006.

*Substituted for CS/CS/SB 2086 (SUB) (Posey), read the second time and amended on May 4, 2005*

---

**HB 315 (3R) by Representative Allen and others—**

**Home Inspection Services;** provides definitions; provides requirements for practice; provides exemptions; provides prohibited acts & penalties; requires liability insurance; exempts from duty to provide repair cost estimates; provides limitations; provides for enforcement of violations. Creates 501.935. Effective Date: 01/01/2006.

*Substituted for CS/SB 1830 (SUB) (Argenziano), read the second time and amended on May 4, 2005*



**CS/CS/SB 526 (3R) by the Committees on Governmental Oversight and Productivity, Communications and Public Utilities, Senator Klein and others—**

**Electric Utility Transmission;** creates Post Hurricane Utility Task Force & provides duties & membership; creates Post Hurricane Utility Task Force Advisory Panel to advise task force; provides for membership & duties; requires that task force submit report to Governor & Legislature; provides that task force be dissolved on specified date. Effective Date: Upon becoming law.

*Read the second time and amended on May 4, 2005*

**HB 1697 (3R) by the Committee on Transportation (SIC), Representative Evers and others—**

**Motor Vehicles;** revises provisions for suspension of driver's license of certain support obligors who are delinquent in payment; authorizes local governments to enact more restrictive golf cart equip. & operation regulations; defines term "off-highway vehicle" include two-rider ATV; establishes procedures for issuance of certificate of title for said vehicle; provides that mobile home dealers may provide cash bond or letter of credit, etc. Amends FS. Effective Date: 07/01/2005 except as otherwise provided.

*Substituted for CS/CS/CS/SB 454 (SUB) (Sebesta), read the second time and amended on May 4, 2005*

**HB 345 (3R) by Representatives Gardiner and Coley—**

**Capitol Police;** revises powers & duties of Capitol Police; revises duties of director of Capitol Police; revises provisions re investigations by said police; revises provisions re designation of other law enforcement officers as ex officio agents of Capitol Police; revises provisions re transportation & protective services of said police; revises provisions re safety & security needs of Historic Capitol & R.A. Gray Building, etc. Amends Ch. 943, 316.640. Effective Date: 07/01/2005.

*Substituted for SB 1746 (SUB) (Wise) and read the second time on May 4, 2005*

**HB 1347 (3R) by Representative Evers and others—**

**Controlled Substances;** revises definition of "listed precursor chemical" to include benzaldehyde, hydriodic acid, & nitroethane, & to remove anhydrous ammonia & benzyl chloride; prohibits person from selling, manufacturing, delivering, or attempting to sell, manufacture, or deliver controlled substance in, on, or within 1,000 feet of assisted living facility; limits retail sales of products containing more than specified amount of ephedrine, etc. Amends FS. Effective Date: 07/01/2005.

*Substituted for CS/SB 2352 (SUB) (Peaden) and read the second time on May 4, 2005*

**SB 1820 (3R) by Senator Klein—**

**Golf Cart Regulations;** grants local jurisdictions authority to enact ordinances governing use of golf carts which are more restrictive than state law; requires that use of golf carts upon any state, county, or municipal road located within local jurisdiction be in compliance with local ordinances governing use of golf carts. Amends 316.212, 2126. Effective Date: Upon becoming law.

*Read the second time on May 4, 2005*

**HB 937 (3R) by Representative Galvano and others—**

**Contamination Notification;** defines specified terms; requires notice when contamination is discovered as result of site rehabilitation activities; provides requirements for notice; requires notice when laboratory analytical results demonstrate that contamination exists in any medium beyond boundaries of property of site rehabilitation; provides requirements for notice; provides rulemaking authority, etc. Amends 376.301, 30702, 287.0595, 316.302. Effective Date: 09/01/2005.

*Substituted for CS/CS/SB 330 (SUB) (Dockery) and read the second time on May 4, 2005*

**HB 627 (3R) by Representative Detert—**

**Financial Reg. Office Info/Pub. Rec.;** creates exemption from public records requirements for information obtained by Financial Regulation Office of Financial Services Commission in connection with active investigations & examinations under Fla. Consumer Finance Act; provides exception; provides definition; provides for future legislative review & repeal; provides statement of public necessity. Creates 516.115. Effective Date: Contingent.

*Substituted for CS/CS/SB 698 (SUB) (Sebesta) and read the second time on May 4, 2005*

**HB 811 (3R) by Representative Kreegel and others—**

**Health Insurance;** authorizes carriers to offer coverage to certain employees without being subject to act under certain circumstances; authorizes insurers & HMOs to offer policies or contracts providing for high deductible plan meeting federal requirements & in conjunction with health savings account; revises provisions for healthy lifestyle rebates for individual health insurance policy, etc. Amends FS. Effective Date: 07/01/2005.

*Substituted for CS/CS/SB 1660 (SUB) (Fasano), read the second time and amended on May 4, 2005*

**HB 1231 (3R) by the Committee on Agriculture (SRC), Representatives Poppell, Stansel and others—**

**Agricultural Products Dealers;** expands list of products covered by law; defines terms "negotiating broker" & "producer's agent"; revises exceptions to provisions regulating dealers; amends provision re applications for dealer licensure to require dealers to provide mailing & location address information; increases minimum amount of bond or certificate of deposit for licensure; provides appropriation & authorizes full-time equivalent positions, etc. Amends Ch. 604. Effective Date: 10/01/2005.

*Substituted for **CS/SB 1780 (SUB)** (Smith) and read the second time on May 4, 2005*

---

**CS/CS/SB 838 (3R) by the Committees on Ways and Means, Health Care, Senator Peaden and others—**

**Sanford Airport Auth./Seminole Co.;** authorizes authority to enter into contracts, leases, franchises, or other arrangements with any person or persons granting privilege of using or improving any project of authority, or any portion thereof of space therein, for commercial purposes; provides requirements & limitations with respect thereto. Effective Date: Upon becoming law.

### **HB 857 (LB) by Representative Machek—**

**Pal-Mar Water Control District;** (Palm Beach & Martin Counties) codifies, amends, reenacts, & repeals special acts re district; provides boundaries; provides for board of supervisors; provides membership, terms of office, removal from office, & powers of board; repeals certain special acts; provides for severability. Effective Date: Upon becoming law.

### **HB 859 (LB) by Representative Kreegel—**

**East Co. Water Control District;** (Lee & Hendry Counties) authorizes district to sell, lease, or otherwise encumber surplus real property owned by district; provides exception. Effective Date: Upon becoming law.

Effective Date: Upon becoming law.

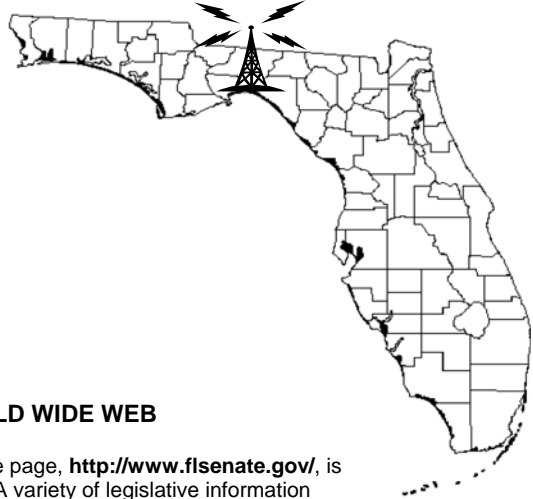
