Everglades Improvement and Management; Revises legislative findings for achieving water quality goals; revises definition of term "Long-Term Plan"; revises provisions for use of certain ad valorem tax proceeds; directs SFWMD to complete specified analysis; revises provisions for collection of agricultural privilege tax; provides for use of such tax proceeds; provides that payment of such tax & certain costs fulfills certain constitutional obligations; provides appropriations. Effective Date: Upon becoming a law

CS/CS/HB 617 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Pilon and others—

Juvenile Justice Circuit Advisory Boards and Juvenile Justice County Councils; Redesignates juvenile justice circuit boards as juvenile justice circuit advisory boards; requires each board to have county organization representing each county in the circuit; provides exception for single-county circuits; deletes provisions providing for juvenile justice county councils; revises provisions relating to duties & responsibilities of boards; requires submission of circuit plans by specified dates; revises membership of boards; provides for appointment of members; provides for terms of members; provides for quorums & for passage of measures or positions; revises provisions relating to bylaws; conforms provisions. Effective Date: 10/01/2013

Department of Business and Professional Regulation; Clarifies funding requirements for Florida Homeowners' Construction Recovery Fund; authorizes DBPR to transfer certain funds from Florida Building Code Administrators & Inspectors Board to Florida Homeowners' Construction Recovery Fund. Effective Date: 10/01/2013

CS/CS/SB 770, 1st Eng. (3R) by the Committees on Appropriations, Community Affairs and Senator Ring—

Neighborhood Improvement Districts; Providing that an ordinance that creates a neighborhood improvement district may authorize the district to exercise certain powers, in addition to those already granted to such districts; specifying such powers; conditioning the exercise of those powers on resolution and referendum, etc. Effective Date: 07/01/2013

CS/CS/HB 635, 1st Eng. (3R) by the Committees on Regulatory Affairs Committee, Insurance and Banking Subcommittee and Representative Edwards—

Insurance; Revises date of future repeal of exemption of medical malpractice insurance premiums from emergency assessments imposed to fund certain obligations, costs, & expenses of Florida Hurricane Catastrophe Fund & Florida Hurricane Catastrophe Fund Finance Corporation; authorizes uniform motor vehicle proof-of-insurance card to be in electronic format; provides construction with respect to parameters of person's consent to access information on electronic device presented to provide proof of insurance; provides immunity from liability to law enforcement officer for damage to electronic device presented to provide proof of insurance; authorizes DHSMV to adopt rules; authorizes insurers to furnish uniform proof-of-purchase cards in electronic format for use by insureds to prove purchase of required insurance coverage when registering motor vehicle; defines "authorized inspection agency"; requires chief inspector of state boiler inspection program to issue certificate of competency as special inspector to certain individuals; specifies how long certificate remains in effect; prohibits an insurance agency from conducting insurance business at location without designated agent in charge; revises date by which title insurance agencies & certain insurers must annually submit specified information to OIR. Effective Date: Upon becoming a law

CS/HB 157 (3R) by the Committee on Insurance and Banking Subcommittee and Representative Holder—

Delivery of Insurance Policies; Authorizes insurer to electronically transmit insurance policy to insured or other person entitled to receive policy; provides exception to electronic transmission for specified policies; provides requirements for electronic transmission of policy; requires that paper copy of policy be provided upon request of insured or other person entitled to receive policy. Effective Date: 07/01/2013

CS/CS/CS/HB 573 (3R) by the Committees on Regulatory Affairs Committee, Government Operations Appropriations Subcommittee, Insurance and Banking Subcommittee, Representative Hooper and others—

Manufactured & Mobile Homes; Requires Citizens Property Insurance Corporation to provide coverage for mobile homes & manufactured homes & related structures for specified minimum insured value; specifies procedure for requesting & obtaining funds from Florida Mobile Home Relocation Trust Fund to pay for operational costs of Florida Mobile Home Relocation Corporation & relocation costs of mobile home owners. Effective Date: Upon becoming a law

Substituted for CS/SB 378(SUB) (Bean) and read the second time on April 29, 2013

HB 7079 (3R) by the Committee on Government Operations Subcommittee, Representative Ahern and others—

Review Under Open Government Sunset Review Act; Removes scheduled repeal of public records exemption for certain information contained in records documenting act of domestic violence or sexual violence which are submitted to agency by agency employee. Effective Date: 10/01/2013

Substituted for CS/SB 304(SUB) (Evers) and read the second time on April 29, 2013

CS/HB 1071, 1st Eng. (3R) by the Committee on Health Innovation Subcommittee and Representative Antone—

Health Care Accrediting Organizations; Conforms provisions to revised definition of term "accrediting organizations," as amended by s. 4, ch. 2012-66, LOF, for purposes of hospital licensing & regulation by AHCA; specifies accrediting agencies for physical therapist assistant programs. Effective Date: 07/01/2013

Substituted for CS/CS/SB 594(SUB) (Bean) and read the second time on April 29, 2013

CS/CS/HB 1085 (3R) by the Committees on State Affairs Committee, Agriculture and Natural Resources Subcommittee, Representative Eagle and others—

Public Records/Natural Gas Storage Facility Permit; Creates exemption from public records requirements for certain information provided in application for natural gas storage facility permit to inject & recover gas into & from natural gas storage reservoir; authorizes specified disclosure of such information; provides for future review & repeal of public records exemption under the Open Government Sunset Review Act; provides statement of public necessity. Effective Date: 10/01/2013

Substituted for CS/CS/SB 984(SUB) (Richter) and read the second time on April 29, 2013

HB 7157 (3R) by the Committee on Rulemaking Oversight and Repeal Subcommittee and Representative Santiago—

Ratification of Rules Implementing Total Maximum Daily Loads for Impaired Water Bodies; Ratifies specified DEP rules implementing total maximum daily loads for impaired water bodies for sole & exclusive purpose of satisfying any condition on effectiveness that requires ratification of any rule meeting any of specified thresholds for likely adverse impact or increase in regulatory costs. Effective Date: Upon becoming a law

Substituted for SB 1864(SUB) (Dean) and read the second time on April 29, 2013

CS/HB 7135 (3R) by the Committees on State Affairs Committee, Insurance and Banking Subcommittee and Representative Nelson—

Pub. Rec./Money Services Businesses; Provides exemption from public records requirements for payment instrument transaction information held by OFR; provides for specified access to such information; authorizes office to enter into information-sharing agreements & provide access to information contained in database to certain governmental agencies; requires a department or agency that receives confidential information to maintain confidentiality of information, except as otherwise required by court order; provides for future review & repeal of exemption; provides statement of public necessity; provides contingent effective date. Effective Date: On the same date that HB 217 or similar legislation takes effect

CS/HB 357 (3R) by the Committee on Economic Development and Tourism Subcommittee, Representative Boyd and others—

Manufacturing Development; Authorizes local governments to establish local manufacturing development program that provides for master development approval for certain sites; requires DEO to develop model ordinance containing specified information & provisions; requires local manufacturing development program ordinance to include certain information; requires department, in cooperation with participating agencies, to establish manufacturing development coordinated approval process for certain manufacturers; requires department to convene meeting when requested by certain manufacturer; requires participating agencies to attend meetings convened by department; specifies that department is not required, but is authorized, to mediate between participating agencies & manufacturer; requires that coordinated approval process have no effect on department's approval of economic development incentives; provides for applicability with respect to permit applications governed by federally delegated or approved permitting programs; requires department to develop materials that identify local manufacturing development programs; requires Enterprise Florida, Inc., & authorizes other state agencies, to distribute such material. Effective Date: 07/01/2013

Massage Establishments; Revises definition of term "board-approved massage school"; provides additional grounds for denial of license or disciplinary action; revises penalties; prohibits operation of massage establishment during specified times; provides exceptions; prohibits use of massage establishment as principal domicile unless establishment is zoned for residential use under local ordinance; provides penalties; declares that massage establishment operating in violation of specified statutes is nuisance that may be abated or enjoined. Effective Date: 10/01/2013

CS/CS/HB 1355 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Watson and others—

Purchase of Firearms by Mentally Ill Persons; Provides conditions under which person who has been voluntarily admitted to mental institution for treatment & has undergone involuntary examination under Baker Act may be prohibited from purchasing firearm; provides requirements for examining physician; provides for judicial review of certain findings; provides specified notice requirements; provides form & contents of notice; provides requirements with respect to filing of specified records with court & presentation of such records to judge or magistrate; provides lawful authority of judge or magistrate to review specified records & order that such records be submitted to FDLE; provides a timeframe for submission of records to FDLE upon order of record by judge or magistrate. Effective Date: 07/01/2013

Medicaid Recoveries; Requires change in principal to be reported by Medicaid provider to AHCA; revises provisions relating to AHCA's onsite inspection responsibilities; revises provisions relating to background screening; authorizes AHCA to enroll provider who is licensed in this state & provides diagnostic services through telecommunications technology; revises provisions relating to settlements of Medicaid claims; provides procedures for contesting amount of medical expense damages; provides conditions regarding admissible evidence, venue, & attorney fees & costs; revises grounds for terminating provider from program, for seeking certain remedies for violations, & for imposing certain sanctions; provides limitation on information AHCA may consider when making determination of overpayment; specifies records provider must present to contest overpayment; clarifies provision regarding accrued interest on certain payments withheld from a provider; deletes requirement that agency place payments withheld from provider in suspended account & revising when provider must reimburse overpayments; revises membership requirements for Medicaid & Public Assistance Fraud Strike Force within DFS & provides for future review & repeal; amends provisions relating to interagency agreements to detect & deter Medicaid & public assistance fraud & provides for future review & repeal. Effective Date: 07/01/2013

CS/CS/HB 365, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee, Representatives Hudson, Jones and others—

Pharmacy; Permits class II institutional pharmacy formulary to include biologics, biosimilars, & biosimilar interchangeables; provides requirements for pharmacist to dispense substitute biological product that is determined to be biosimilar to & interchangeable for prescribed biological product; provides notification requirements for pharmacist in class II or modified class II institutional pharmacy; requires Board of Pharmacy to maintain current list of interchangeable biosimilar products. Effective Date: 07/01/2013

CS/HB 171 (3R) by the Committee on Health Quality Subcommittee, Representative Rooney and others—

Disposition of Human Remains; Revises various provisions relating to procedures for registration of certificates of death or fetal death & medical certification of causes of death; procedures for reporting & disposition of unclaimed remains; disposition of remains of deceased persons whose identities are not known; procedures for anatomical board's retention & use of human remains; final disposition of unclaimed remains of indigent persons; selling or buying of human remains or transmitting or conveying such remains outside state; limitations on liability of funeral directors, funeral or direct disposal establishments, & veterans' service organizations; and repeal of provisions relating to claims of bodies after delivery to anatomical board. Effective Date: 07/01/2013

CS/HB 837 (3R) by the Committee on Local and Federal Affairs Committee and Representative Mayfield—

Tax Deeds; Authorizes tax collector to charge for reimbursement of costs for providing online tax deed application services; provides that applicant's use of online application services is optional under certain circumstances. Effective Date: 07/01/2013

CS/SB 1350, 1st Eng. (3R) by the Committee on Criminal Justice and Senator Bradley—

Criminal Penalties; Providing criminal sentences applicable to a person who was under the age of 18 years at the time the offense was committed; requiring that a judge consider certain factors before determining if life imprisonment is an appropriate sentence; providing for review of certain sentences of offenders who were under the age of 18 at the time of the offense, etc. Effective Date: 07/01/2013

CS/CS/HB 247, 1st Eng. (3R) by the Committees on Local and Federal Affairs Committee, Government Operations Subcommittee and Representative Nelson—

Paper Reduction; Requires that uniform statewide voter registration application be designed to elicit e-mail address of applicant & whether applicant desires to receive sample ballots by e-mail; authorizes supervisor of elections to send sample ballot to registered elector by e-mail under certain circumstances; permits electronic filing of certain affidavits; authorizes clerk of court to mail or electronically transmit notice relating to bond forfeiture proceeding. Effective Date: 10/01/2013

Substituted for CS/CS/SB 1352(SUB) (Ring), read the second time, and amended on April 29, 2013

CS/HB 1075 (3R) by the Committee on Government Operations Subcommittee, Representative Rangel and others—

Public Records; Provides exemption from public record requirements for complaint of misconduct filed with agency against agency employee & all information obtained pursuant to investigation of complaint by agency; provides for limited duration of exemption; provides for future review & repeal of exemption; provides statement of public necessity. Effective Date: 07/01/2013

Substituted for CS/SB 1318(SUB) (Soto) and read the second time on April 29, 2013

CS/CS/CS/HB 1129, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Civil Justice Subcommittee, Health Quality Subcommittee, Representatives Pigman, Rodrigues and others—

Infants Born Alive; Provides that infant born alive during or immediately after attempted abortion is entitled to same rights, powers, & privileges as any other child born alive in course of natural birth; requires health care practitioners to preserve life & health of such infant born alive, if possible; provides for transport & admittance of infant to hospital; provides certain services for infant; requires health care practitioner or employees who have knowledge of any violations with respect to infants born alive after attempted abortion to report those violations to DOH; provides penalty; provides for construction; revises reporting requirements. Effective Date: 07/01/2013

Substituted for CS/CS/SB 1636(SUB) (Flores) and read the second time on April 29, 2013

CS/HB 311 (3R) by the Committee on Justice Appropriations Subcommittee and Representative Ray—

Costs of Prosecution, Investigation, and Representation; Provides for withholding of unpaid costs of prosecution & representation from return of cash bond posted on behalf of criminal defendant; requires notice on bond forms of such possible withholding; clarifies types of cases that are subject to collection & dispensing of cost payments by clerk of court; provides for assessment of costs of prosecution against juvenile who has been adjudicated delinquent or has adjudication of delinquency withheld; provides that child adjudicated delinquent may perform community service in lieu of certain costs & fees. Effective Date: 07/01/2013

Substituted for CS/SB 288(SUB) (Bradley) and read the second time on April 29, 2013

CS/CS/HB 665 (3R) by the Committees on Regulatory Affairs Committee, Insurance and Banking Subcommittee, Representative LaRosa and others—

Licensure by Office of Financial Regulation; Authorizes, rather than requires, OFR to deny mortgage broker license application if applicant had mortgage broker license revoked previously; authorizes, rather than requires, OFR to deny mortgage lender license application if applicant had mortgage lender license revoked previously; revises procedures & requirements for submitting fingerprints as part of an application to sell, or offer to sell, securities; removes conflicting language; revises procedures & requirements for submitting fingerprints to apply for license as money services business; requires OFR to pay annual fee to DLE; removes conflicting language; requires certain licensees to submit live-scan fingerprints before next renewal period. Effective Date: 10/01/2013

Substituted for CS/SB 644(SUB) (Richter) and read the second time on April 29, 2013

CS/HB 7169, 1st Eng. (3R) by the Committees on Appropriations Committee, Select Committee on PPACA, Representatives Cummings and Hudson—

Florida Health Choices Plus Program; Provides that employers who meet requirements of Florida Health Choices Program are eligible to enroll in Florida Health Choices Plus Program; requires participating employers to make defined contribution with certain conditions; provides that individuals & employees of enrolled employers are eligible to participate in program; provides criteria for products offered by program; creates Florida Health Choices Plus Program & provides enrollment requirements; requires individual contribution & provides for disenrollment; requires report to Governor & Legislature; creates task force; authorizes prepaid health clinic to offer certain hospital services; provides appropriations. Effective Date: 07/01/2013

*Substituted for **CS/SB 1816(SUB)** (Negron), read the second time, and amended on April 29, 2013*

CS/CS/HB 1325 (3R) by the Committees on Justice Appropriations Subcommittee, Criminal Justice Subcommittee, Representative Spano and others—

Victims of Human Trafficking; Revises mental, emotional, or developmental age of child victim whose out-of-court statement describing specified criminal acts is admissible in evidence in certain instances; provides for expungement of criminal history record of victim of human trafficking; designates what offenses may be expunged; provides that conviction expunged under this act is deemed to have been vacated due to substantive defect in underlying criminal proceedings; provides for period in which such expungement must be sought; provides that official documentation of victim's status as human trafficking victim creates presumption; provides standard of proof absent such documentation; provides requirements for petitions; provides for parties & service; provides for electronic appearances of petitioners & attorneys; provides for orders of relief; provides for physical destruction of records; authorizes person whose records are expunged to lawfully deny or fail to acknowledge arrests covered by expunged record; provides exceptions; provides that such lawful denial is not perjury or subject person to liability. Effective Date: 01/01/2014

CS/CS/HB 867, 1st Eng. (3R) by the Committees on Education Committee, Choice and Innovation Subcommittee, Representatives Trujillo, Bileca and others—

Parent Empowerment in Education; Authorizes parents who have students in public school that is implementing turnaround option to petition to have particular turnaround option implemented; requires school district to notify parent of student taught by out-of-field teacher or teacher with unsatisfactory performance rating; authorizes parent of student to consent to assignment of that student to teacher with performance evaluation rating of less than effective under certain circumstances. Effective Date: 07/01/2013

*Substituted for **CS/SB 862(SUB)** (Stargel), read the second time, and amended on April 29, 2013*

CS/CS/HB 269 (3R) by the Committees on Regulatory Affairs Committee, Energy and Utilities Subcommittee and Representative Beshears—

Public Construction Projects; Requires governmental entities to specify certain products associated with public works projects; requires state agencies to use certain building rating systems & building codes for each new construction & renovation project. Effective Date: 07/01/2013

HB 685 (3R) by Representative McBurney and others—

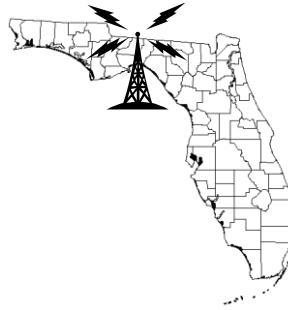
