Consumer Collection Practices; Deletes provision entitling prospective consumer collection agency registrants to registration when specified conditions are met; provides powers & duties of OFR & FSC; requires fees, charges, & fines to be deposited in specified trust fund; authorizes OFR to make investigations or examinations to determine violations; revises registration procedures & application requirements for consumer collection agencies; requires applicants & certain registrants to submit fingerprints; provides that registrations are not transferable or assignable; requires consumer collection agencies to report changes in specified information within specified period; provides registration renewal & fingerprint retention fees; provides notification requirements for consumer collection agencies; authorizes office to bring administrative action; provides grounds for disciplinary action; provides penalties. Controlled Substances; Adds to list of Schedule I controlled substances specified materials, compounds, mixtures, or preparations that contain hallucinogenic substances, or any of their salts, isomers, & salts of isomers, if existence of such salts, isomers, & salts of isomers is possible within specific chemical designation; provides reduced penalties for possession of 3 grams or less of specified controlled substances; provides that person who knowingly sells, purchases, manufactures, delivers, or brings into this state specified quantities of specified chemicals commits trafficking in Phenethylamines; provides that person who knowingly sells, purchases, manufactures, delivers, or brings into this state specified chemicals commits capital manufacture or importation of Phenethylamines; reenacts provisions. Effective Date: Upon becoming a law

Home Health Care; Exempting certain home health agencies from specified licensure application requirements; requiring a licensed nurse registry to ensure that each certified nursing assistant and home health aide referred by the registry present certain credentials; requiring that certain records be kept in accordance with rules set by the Agency for Health Care Administration; providing that a nurse registry does not have an obligation to review and act upon such records except under certain circumstances, etc. Effective Date: 07/01/2014

Ratification of Rules/Department of Juvenile Justice; Ratifies specified DJJ rules relating to provision of health services to youth in facilities or programs, for sole & exclusive purpose of satisfying any condition on effectiveness pursuant to s. 120.541(3), F.S. Effective Date: Upon becoming a law

CS/CS/HB 409 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Passidomo and others—

Offenses Against Vulnerable Persons; Revises when out of court statement by elderly person or disabled adult is admissible in certain proceedings; expands application of prohibition on fraudulent use of personal identification information of specified victims without consent to include persons 60 years of age or older; deletes requirement that property of elderly person or disabled adult be obtained by deception or intimidation in order to constitute exploitation of such person; specifies additional circumstances that constitute breach of fiduciary duty & specifies when unlawful appropriation occurs; creates presumption that certain inter vivos transfers are result of exploitation; provides exceptions; provides for jury instructions concerning presumption; revises valuation of funds, assets, or property involved for various degrees of offenses of exploitation of elderly person or disabled adult; provides for return of property seized from defendant to victim before trial in certain circumstances; conforms provisions. Effective Date: 10/01/2014

Substituted for **CS/CS/SB 588(SUB)** (Richter) and read the second time on April 23, 2014. Passed on April 25, 2014, and on motion by Senator Richter reconsidered on April 25, 2014.

Civil Liability of Farmers; Expanding an existing exemption from civil liability for farmers who gratuitously allow a person to enter upon their land for the purpose of removing farm produce or crops left in the field after harvesting to include farmers who gratuitously allow a person to enter upon their land to remove any farm produce or crops, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Judiciary

Similar to **CS/CS/HB 7037, 2nd Eng.(HC)** in the Committees on Regulated Industries; and Judiciary

SB 592 (SO) by the Committee on Criminal Justice (Evers)—

Criminal Justice; Requiring the Department of Corrections to verify the authenticity of certain court orders before releasing a person from incarceration, etc. Effective Date: 07/01/2014

Reported favorably by the Committee on Judiciary

CS/SB 142 (SO) by the Committee on Appropriations and Senator Hays—

Access to Health Care for the Underserved; Revising the definition of the term "contract"; extending the period of time for which a health care provider remains an agent of the state after an individual under his or her care is deemed ineligible; requiring that a contract with a governmental contractor for health care services include a provision allowing a voluntary contribution toward certain dental laboratory work; prohibiting the contribution from exceeding the actual amount of the dental laboratory charges; delaying the future repeal of provisions authorizing the health access dental license, etc. Effective Date: 07/01/2014

Reported favorably by the Committee on Health Policy; recommended favorably by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to **HB 97(HC)** in the Committees on Health Policy; Judiciary; Appropriations Subcommittee on Health and Human Services; and Appropriations

CS/CS/CS/SB 364 (SO) by the Committees on Appropriations, Criminal Justice, Communications, Energy, and Public Utilities and Senator Brandes—

Computer Crimes; Providing that a person who willfully, knowingly, and without authorization introduces a computer contaminant or modifies or destroys data, programs, or supporting documentation residing or existing internal or external to a computer, computer system, computer network, or electronic device commits an offense against intellectual property; prohibiting a person from willfully, knowingly, and without authorization engaging in specified activities against a computer, computer system, computer network, or electronic device owned, operated, or used by a public utility; providing criminal penalties, etc. Effective Date: 10/01/2014

Reported favorably as a committee substitute by the Committee on Communications, Energy, and Public Utilities; reported favorably as a committee substitute by the Committee on Criminal Justice; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 408 (SO) by the Committee on Health Policy, Senator Braynon and others—

Infectious Disease Elimination Pilot Program; Creating the "Miami-Dade Infectious Disease Elimination Act (IDEA)"; requiring the Department of Health to establish a sterile needle and syringe exchange pilot program in Miami-Dade County; providing that the distribution of needles and syringes under the pilot program is not a violation of the Florida Comprehensive Drug Abuse Prevention and Control Act or any other law; providing conditions under which a pilot program staff member or participant may be prosecuted; prohibiting the collection of participant identifying information, etc. Effective Date: 07/01/2014

Reported favorably as a committee substitute by the Committee on Health Policy; the Committee on Criminal Justice reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/SB 510 (SO) by the Committee on Appropriations and Senator Ring—

Local Government Neighborhood Improvement Districts; Providing that an ordinance that creates a local government neighborhood improvement district may authorize the district to incur certain debts and pledge the special assessment power of the district to pay such debts for the purpose of financing certain capital projects; providing conditions on the exercise of such power, etc. Effective Date: 07/01/2014
