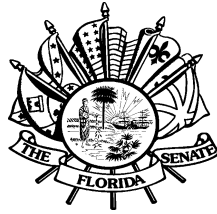

## BILLS ON THE CALENDAR

### BILLS ON THIRD READING

#### **CS/CS/SB 1446 (3R) by the Committees on Rules, Governmental Oversight and Accountability and Senator Richter—**

**Public Records/Department of Agriculture and Consumer Services;** Providing an exemption from public records requirements for criminal or civil intelligence or investigative information, or any other information, held by the Department of Agriculture and Consumer Services as part of an investigation with another state or federal regulatory, administrative, or criminal justice agency; providing exceptions to the public records exemption; providing for future legislative review and repeal of the exemption under the Open Government Sunset Review Act; providing a statement of public necessity, etc. Effective Date: Upon becoming a law if SB 1444 or similar legislation is adopted in the same legislative session or an extension thereof and becomes law

*Read the second time on April 14, 2015*

#### **CS/SB 960 (3R) by the Committee on Fiscal Policy, Senator Lee and others—**

**Florida Bright Futures Scholarship Program;** Providing that the initial award period and the renewal period for students who are unable to accept an initial award immediately after completion of high school due to a full-time religious or service obligation begin upon the completion of the religious or service obligation; requiring a student, as a prerequisite for the Florida Academic Scholars award, the Florida Medallion Scholars award, or the Florida Gold Seal Vocational Scholars award, to identify a social or civic issue or a professional area of interest and develop a plan for his or her personal involvement in addressing the issue or learning about the area, etc. Effective Date: 07/01/2015

*Read the second time on April 14, 2015*

*Similar to CS/CS/HB 747(HC) in the Committees on Higher Education; Appropriations Subcommittee on Education; and Fiscal Policy*

#### **CS/CS/SB 1024 (3R) by the Committees on Fiscal Policy, Transportation and Senator Simmons—**

**Central Florida Expressway Authority;** Requiring the chairs of the boards of specified county commissions each to appoint one member from their respective counties who is a commission member or chair or a county mayor to serve on the governing body of the authority; specifying that the Central Florida Expressway Authority is a party to a certain lease-purchase agreement between the department and the Orlando-Orange County Expressway Authority; removing the requirement that title in fee simple absolute to the former Orlando-Orange County Expressway System be transferred to the state upon the completion of the faithful performance and termination of a specified lease-purchase agreement, etc. Effective Date: 07/01/2015

*Read the second time on April 14, 2015. Amended on April 22, 2015, with pending amendment #2 (621812).*

#### **CS/CS/SB 998, 1st Eng. (3R) by the Committees on Commerce and Tourism, Regulated Industries and Senator Margolis—**

**Alcoholic Beverages;** Defining the term “powdered alcohol”; prohibiting the sale, offer for sale, purchase, use, offer for use, or possession of powdered alcohol; exempting sparkling wine and champagne from a specified volume restriction; requiring the calculation of a specified excise tax to be based on the advertised volume per drink, etc. Effective Date: 07/01/2015

*Read the second time and amended on April 14, 2015*

**CS/SB 7068, 1st Eng. (3R) by the Committees on Children, Families, and Elder Affairs, and Appropriations (Lee)—**

**Mental Health and Substance Abuse Services;** Revising the definition of “mental illness” to exclude dementia and traumatic brain injuries; requiring the Agency for Health Care Administration and the Department of Children and Families to develop a plan to obtain federal approval for increasing the availability of federal Medicaid funding for behavioral health care; requiring that, by a specified date, the department, in consultation with the Agency for Health Care Administration, modify certain licensure rules and procedures, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2015

*Read the second time and amended on April 14, 2015*

---

**CS/SB 1298, 1st Eng. (3R) by the Committee on Appropriations and Senator Simmons—**

**Minimum Insurance Requirements;** Requiring a transportation network company driver to have proof of certain insurance in his or her possession during a specified timeframe; establishing insurance requirements for short-term rental network companies during certain timeframes; requiring a transportation network company driver or such company on the driver's behalf, or a combination thereof, to maintain primary automobile insurance issued by specified insurers with certain coverages in specified amounts during certain timeframes, etc. Effective Date: 01/01/2016

*Read the second time and amended on April 22, 2015*

---

**CS/HB 715 (3R) by the Committee on Insurance and Banking Subcommittee and Representative Raschein—**

**Eligibility for Coverage by Citizens Property Insurance Corporation;** Removes provision that prohibited certain improvements to major structures from being eligible for Citizens Property Insurance coverage; revises provisions regarding coverage for major structures that have undergone specified changes after a date certain. Effective Date: 07/01/2015

*Substituted for CS/SB 842(SUB) (Benacquisto) and read the second time on April 22, 2015*

---

**CS/CS/SB 596, 1st Eng. (3R) by the Committees on Commerce and Tourism, Regulated Industries and Senator Hays—**

**Craft Distilleries;** Defining the term “branded product”; revising the current limitation on the number of containers that may be sold to consumers by craft distilleries; applying such limitation to individual containers for each branded product; prohibiting a craft distillery from shipping or arranging to ship any of its distilled spirits to consumers; requiring the Department of Transportation to install directional signs at specified locations in accordance with Florida's Highway Guide Sign Program upon the request of a craft distillery licensed in this state, etc. Effective Date: 07/01/2015

*Read the second time and amended on April 22, 2015*

---

**CS/HB 79 (3R) by the Committee on Health Care Appropriations Subcommittee, Representative Cummings and others—**

**Crisis Stabilization Services;** Requires DCF to develop standards & protocols for collection, storage, transmittal, & analysis of utilization data from public receiving facilities; requires compliance by managing entities by specified date; requires DCF to create statewide database; provides appropriation. Effective Date: Upon becoming a law

*Substituted for CS/SB 340(SUB) (Grimsley) and read the second time on April 22, 2015*

---

**CS/CS/SB 420 (3R) by the Committees on Appropriations, Community Affairs and Senator Grimsley—**

**Animal Control;** Providing a procedure for adopting or humanely disposing of impounded stray livestock, except cattle, as an alternative to sale or auction; requiring a county animal control center to establish fees and be responsible for damages caused while impounding livestock; authorizing certain municipal animal control officers to take custody of an animal found neglected or cruelly treated or to order the owner of such an animal to provide certain care at the owner's expense, etc. Effective Date: 07/01/2015

*Read the second time on April 22, 2015*

---

**CS/SB 526 (3R) by the Committee on Commerce and Tourism and Senator Grimsley—**

**Notaries Public;** Revising the methods available for verifying documents; defining the term “reliable electronic means”; authorizing specified officers to administer oaths by reliable electronic means when engaged in the performance of official duties, etc. Effective Date: 07/01/2015

*Read the second time on April 22, 2015*

---

**CS/CS/CS/SB 252, 1st Eng. (3R) by the Committees on Rules, Judiciary, Banking and Insurance and Senator Smith—**

**Insurance;** Increasing the number of years that a specified examination report remains valid and may be considered for the purpose of applying for a certificate of authority; providing that the absence of a countersignature does not affect the validity of a policy or contract of insurance; providing that the term “financial guaranty insurance” does not include guarantees of higher education loans unless written by a financial guaranty insurance corporation, etc. Effective Date: 07/01/2015

*Read the second time and amended on April 22, 2015*

---

**CS/CS/HB 329 (3R) by the Committees on Economic Affairs Committee, Highway and Waterway Safety Subcommittee, Representative Ingram and others—**

**Special License Plates;** Authorizes DHSMV to issue Combat Action Ribbon, Air Force Combat Action Medal, Distinguished Flying Cross, World War II Veteran, Woman Veteran, Navy Combat Veteran, Marine Corps Combat Veteran, Air Force Combat Veteran and Navy Submariner license plates. Effective Date: 07/01/2015

*Substituted for CS/CS/SB 112(SUB) (Hays), read the second time, and amended on April 22, 2015*

---

**CS/CS/SB 538 (3R) by the Committees on Rules, Criminal Justice, Senator Simmons and others—**

**Disclosure of Sexually Explicit Images;** Prohibiting an individual from electronically disclosing a sexually explicit image of an identifiable person with the intent to harass such person if the individual knows or should have known that such person did not consent to the disclosure; requiring a court to order that a person convicted of such offense be prohibited from having contact with the victim, etc. Effective Date: 10/01/2015

*Read the second time on April 22, 2015*

---

**CS/CS/SB 872, 1st Eng. (3R) by the Committees on Banking and Insurance, Judiciary and Senator Hukill—**

**Estates;** Authorizing the court, if costs and attorney fees are to be paid from the estate under specified sections of law, to direct payment from a certain part of the estate or, under specified circumstances, to direct payment from a trust; requiring a personal representative to be removed and the letters of administration revoked if he or she was not qualified to act at the time of appointment; providing that a governing instrument may not direct that taxes be paid from property other than property passing under the governing instrument, except under specified conditions, etc. Effective Date: 07/01/2015

*Read the second time and amended on April 22, 2015*

---

**CS/CS/SB 766, 1st Eng. (3R) by the Committees on Appropriations, Judiciary and Senator Hukill—**

**Surveillance by a Drone;** Prohibiting a person, a state agency, or a political subdivision from using a drone to capture an image of privately owned real property or of the owner, tenant, occupant, invitee, or licensee of such property with the intent to conduct surveillance without his or her written consent if a reasonable expectation of privacy exists; authorizing the use of a drone by a person or entity engaged in a business or profession licensed by the state in certain circumstances, etc. Effective Date: 07/01/2015

*Read the second time and amended on April 22, 2015*

---

**CS/SB 836 (3R) by the Committee on Banking and Insurance and Senator Latvala—**

**Florida Insurance Guaranty Association;** Revising provisions relating to the levy of assessments on insurers by the Florida Insurance Guaranty Association; requiring charges or recoupments to be displayed separately on premium statements to policyholders and prohibiting their inclusion in rates, etc. Effective Date: 07/01/2015

*Read the second time on April 22, 2015*

---

**CS/CS/HB 209 (3R) by the Committees on Finance and Tax Committee, Local Government Affairs Subcommittee, Representative Artilles and others—**

**Emergency Fire Rescue Services & Facilities Surtax;** Revises distribution of surtax proceeds; deletes provision requiring county governing authority to develop & execute interlocal agreements with local government entities providing emergency fire & rescue services; requires local government entity requesting & receiving certain personnel or equipment from another service provider to pay for such personnel or equipment from its share of surtax proceeds; provides for application of funds if local government entity receiving share of surtax is unable to further reduce ad valorem taxes; deletes provision requiring local government entities to enter into interlocal agreement in order to receive surtax proceeds. Effective Date: 07/01/2015

*Substituted for CS/CS/SB 668(SUB) (Latvala), read the second time, and amended on April 22, 2015*

---

**CS/SB 954, 1st Eng. (3R) by the Committee on Fiscal Policy and Senator Garcia—**

**Involuntary Examinations of Minors;** Requiring school health services plans to include notification requirements when a student is removed from school, school transportation, or a school-sponsored activity for involuntary examination; including health care surrogates and proxies as individuals who may act on behalf of an individual involuntarily admitted to a facility; requiring a receiving facility to immediately notify the parent, guardian, caregiver, or guardian advocate of the whereabouts of a minor who is being held for involuntary examination; providing circumstances when notification may be delayed, etc. Effective Date: 07/01/2015

*Read the second time and amended on April 22, 2015*

---

**CS/SB 682 (3R) by the Committee on Appropriations and Senator Grimsley—**

**Transitional Living Facilities;** Providing requirements for transitional living facility policies and procedures governing client admission, transfer, and discharge; prohibiting a licensee or employee of a facility from serving notice upon a client to leave the premises or taking other retaliatory action under certain circumstances; providing a penalty for certain misuse of a client's personal funds, property, or personal needs allowance; requiring the agency, the Department of Health, the Agency for Persons with Disabilities, and the Department of Children and Families to develop electronic information systems for certain purposes, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2015

*Read the second time on April 22, 2015*

---

**HB 755 (3R) by Representative Stone—**

**Convenience Business Security;** Revises definition of term "convenience business" to delete exception for certain businesses in which owner or family members work between specified hours; exempts businesses in which owner or family members work between specified hours from specified requirements; deletes requirement for reapproval by AG of robbery deterrence & safety training curriculum for convenience store employees. Effective Date: 07/01/2015

*Substituted for SB 684(SUB) (Grimsley) and read the second time on April 22, 2015*

---

**CS/HB 243 (3R) by the Committee on Health Quality Subcommittee, Representative Roberson and others—**

**Vital Statistics;** Revises duties & responsibilities of DOH with respect to production & maintenance of death certificates & burial transit permits; requires electronic filing & transmission of certain death records. Effective Date: 07/01/2015

*Substituted for CS/CS/SB 640(SUB) (Detert) and read the second time on April 22, 2015*

---

**CS/CS/HB 217 (3R) by the Committees on Regulatory Affairs Committee, Business and Professions Subcommittee, Representative Van Zant and others—**

**Engineers;** Prohibits person who is not licensed as engineer or structural engineer from using specified names & titles or practicing engineering or structural engineering; exempts certain persons from licensing requirements; establishes various fees for examination & licensure of structural engineers; provides licensure & application requirements for structural engineer license; exempts under certain conditions structural engineer who applies for licensure before specified date from passage of certain national examination; requires board to certify certain applicants for licensure by endorsement; prohibits specified persons from using specified names & titles; provides various acts which constitute grounds for disciplinary action against structural engineer, to which penalties apply. Effective Date: 07/01/2015

*Substituted for CS/CS/SB 338(SUB) (Altman), read the second time, and amended on April 22, 2015*

---

**HB 213 (3R) by Representative Moraitis—**

**Property Appraisers;** Provides that property appraiser's budget shall be funded once DOR makes its final budget amendments; obligates county commission to fund DOR's final property appraiser budget during pendency of appeal to Administration Commission. Effective Date: 07/01/2015

*Substituted for SB 266(SUB) (Ring) and read the second time on April 22, 2015*

---

**CS/CS/CS/HB 185 (3R) by the Committees on Local and Federal Affairs Committee, Government Operations Subcommittee, Veteran and Military Affairs Subcommittee, Representative Gaetz and others—**

**Public Records/Active Duty Servicemembers and Families;** Provides exemption from public records requirements for certain identification & location information of current or former servicemembers of United States Armed Forces, Reserve Forces, or National Guard, & spouses & children; provides applicability; provides for future review & repeal of exemption; provides statement of public necessity. Effective Date: Upon becoming a law

*Substituted for CS/CS/SB 674(SUB) (Evers) and read the second time on April 22, 2015*

---

**CS/CS/SB 278 (3R) by the Committees on Appropriations, Finance and Tax and Senator Diaz de la Portilla—**

**Downtown Development Districts;** Authorizing municipalities larger than a certain population and located in certain counties to levy an ad valorem tax on real and personal property in downtown development districts, etc. Effective Date: 07/01/2015

*Read the second time on April 22, 2015*

---

**CS/SB 746 (3R) by the Committee on Criminal Justice, Senator Lee and others—**

**Diabetes Awareness Training for Law Enforcement Officers;** Citing this act as the "Arthur Green, Jr., Act"; requiring the Department of Law Enforcement to establish an online continued employment training component relating to diabetic emergencies, etc. Effective Date: 10/01/2015

*Read the second time on April 22, 2015*

*Similar to CS/HB 201(HC) in the Committees on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice; and Fiscal Policy*

---

**CS/HB 309 (3R) by the Committee on Health Care Appropriations Subcommittee, Representative Harrison and others—**

**Patient Admission Status Notification;** Provides requirements for licensed medical facilities for patient notification regarding admission status. Effective Date: 07/01/2015

*Substituted for CS/SB 768(SUB) (Gaetz) and read the second time on April 22, 2015*

---

**SB 996 (3R) by Senator Richter—**

**Home Medical Equipment;** Exempting allopathic, osteopathic, and chiropractic physicians who sell or rent electrostimulation medical equipment and supplies to their patients in the course of their practice from licensure as home medical equipment providers, etc. Effective Date: 07/01/2015

*Read the second time on April 22, 2015*

*Identical to HB 1305(HC) in the Committees on Health Policy; Appropriations Subcommittee on Health and Human Services; and Fiscal Policy*

---

**CS/SB 1098 (3R) by the Committee on Criminal Justice and Senator Bradley—**

**Controlled Substances;** Adding certain substances to the Schedule I list of controlled substances, etc. Effective Date: Upon becoming a law

*Read the second time on April 22, 2015*
