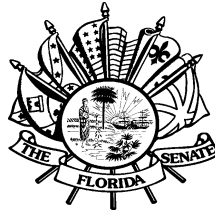

CS/CS/SB 1446 (3R) by the Committees on Rules, Governmental Oversight and Accountability and Senator Richter—

Public Records/Department of Agriculture and Consumer Services; Providing an exemption from public records requirements for criminal or civil intelligence or investigative information, or any other information, held by the Department of Agriculture and Consumer Services as part of an investigation with another state or federal regulatory, administrative, or criminal justice agency; providing exceptions to the public records exemption; providing for future legislative review and repeal of the exemption under the Open Government Sunset Review Act; providing a statement of public necessity, etc. Effective Date: Upon becoming a law if SB 1444 or similar legislation is adopted in the same legislative session or an extension thereof and becomes law

CS/SB 960 (3R) by the Committee on Fiscal Policy, Senator Lee and others—

Florida Bright Futures Scholarship Program; Providing that the initial award period and the renewal period for students who are unable to accept an initial award immediately after completion of high school due to a full-time religious or service obligation begin upon the completion of the religious or service obligation; requiring a student, as a prerequisite for the Florida Academic Scholars award, the Florida Medallion Scholars award, or the Florida Gold Seal Vocational Scholars award, to identify a social or civic issue or a professional area of interest and develop a plan for his or her personal involvement in addressing the issue or learning about the area, etc. Effective Date: 07/01/2015

CS/CS/SB 382, 1st Eng. (3R) by the Committees on Appropriations, Health Policy, Senator Sobel and others—

Assisted Living Facilities; Providing that Medicaid managed care plans are responsible for enrolled mental health residents; providing that managing entities under contract with the Department of Children and Families are responsible for mental health residents who are not enrolled with a Medicaid managed care plan; requiring the Agency for Health Care Administration to impose a fine if a facility is not in compliance with certain background screening requirements; directing the agency to create an assisted living facility consumer information website, etc. Effective Date: 07/01/2015

CS/CS/HB 1069 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee, Representative Perry and others—

Defendants in Specialized Courts; Requires trial court to transfer certain criminal cases involving participants in specified programs to another jurisdiction having such program under certain conditions. Effective Date: 07/01/2015

Substituted for CS/SB 1170(SUB) (Bradley) and read the second time on April 23, 2015

CS/HB 145 (3R) by the Committee on Highway and Waterway Safety Subcommittee and Representative Beshears—

Commercial Motor Vehicle Review Board; Provides for appeal to Commercial Motor Vehicle Review Board of citation for excess weight; provides for appointment of additional members to the board by Governor & Commissioner of Agriculture & provides for action by quorum of board; provides for removal of members by Governor; provides for action by quorum of board. Effective Date: 07/01/2015

Substituted for CS/CS/CS/SB 220(SUB) (Simpson), read the second time, and amended on April 24, 2015

CS/CS/HB 361, 1st Eng. (3R) by the Committees on Local and Federal Affairs Committee, Finance and Tax Committee, Representatives Trumbull, Smith and others—

Military Housing Ad Valorem Tax Exemptions; Grants certain leasehold interests & improvements to land owned by U.S. or agency thereof, branch of U.S. Armed Forces, or quasi-governmental agency exemption from ad valorem taxation; exempts such leasehold interests & improvements without need to apply for exemption or property appraiser approving exemption; provides nonapplicability & retroactive applicability. Effective Date: 07/01/2015

Substituted for CS/SB 686(SUB) (Lee) and read the second time on April 24, 2015

CS/CS/CS/SB 1372 (3R) by the Committees on Rules, Community Affairs, Ethics and Elections and Senator Gaetz—

Government Accountability; Specifying that the Governor, the Commissioner of Education, or the designee of the Governor or of the Commissioner of Education may notify the Legislative Auditing Committee of an entity's failure to comply with certain auditing and financial reporting requirements; revising reporting requirements applicable to the Auditor General; specifying that prohibitions on conflicting employment or contractual relationships for public officers or employees of an agency apply to contractual relationships held by certain business entities; expanding the types of governmental entities that are subject to lobbyist registration requirements, etc. Effective Date: 10/01/2015

Read the second time on April 24, 2015

CS/CS/SB 564 (3R) by the Committees on Governmental Oversight and Accountability, Commerce and Tourism and Senator Richter—

Trade Secrets; Including financial information in provisions prohibiting the theft, embezzlement, or unlawful copying of trade secrets; providing criminal penalties, etc. Effective Date: 10/01/2015

Read the second time on April 24, 2015

CS/CS/CS/SB 566 (3R) by the Committees on Rules, Governmental Oversight and Accountability, Commerce and Tourism and Senator Richter—

Public Records and Meetings/Trade Secrets; Expanding public records exemptions for certain data processing software obtained by an agency, certain information held by a county tourism promotion agency, information related to trade secrets held by specified entities, and specified data, programs, or supporting documentation held by an agency; providing for future legislative review and repeal of the exemptions; providing a statement of public necessity, etc. Effective Date: On the same date that SB 564 or similar legislation relating to trade secrets takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

CS/SB 678 (3R) by the Committee on Banking and Insurance and Senator Diaz de la Portilla—

Reciprocal Insurers; Authorizing domestic reciprocal insurers to return a portion of unassigned funds to their subscribers; providing limitations, etc. Effective Date: 07/01/2015

Read the second time on April 24, 2015

CS/CS/SB 798, 1st Eng. (3R) by the Committees on Appropriations, Commerce and Tourism and Senator Lee—

Household Moving Services; Removing a prohibition that precludes a mover from limiting its liability for the loss or damage of household goods to a specified valuation rate; requiring a mover to conduct a physical survey and provide a binding estimate in certain circumstances unless waived by the shipper, etc. Effective Date: 07/01/2015

Read the second time and amended on April 24, 2015

CS/SB 568 (3R) by the Committee on Banking and Insurance and Senator Richter—

Family Trust Companies; Revising the purposes of the Family Trust Company Act; specifying the applicability of other chapters of the financial institutions codes to family trust companies; revising the requirements for investigations of license applicants by the Office of Financial Regulation; deleting a provision that authorizes the office to immediately revoke the license of a licensed family trust company under certain circumstances; authorizing a family trust company to have its terminated registration or revoked license reinstated under certain circumstances, etc. Effective Date: 10/01/2015

Read the second time on April 24, 2015

CS/CS/HB 1309 (3R) by the Committees on State Affairs Committee, Government Operations Subcommittee and Representative Drake—

Publicly Funded Retirement Plans; Requires that actuarial reports for certain retirement plans include mortality tables; specifies requirements; revises information to be included in defined benefit system or plan's annual report to DMS; provides declaration of important state interest; provides effective dates. Effective Date: 07/01/2015

CS/SB 630 (3R) by the Committee on Banking and Insurance and Senator Joyner—

Transfers to Minors; Specifying that certain transfers from a trust are considered as having been made directly by the grantor of the trust; authorizing custodianships established by irrevocable gift and by irrevocable exercise of power of appointment to terminate when a minor attains the age of 25, subject to the minor's right in such custodianships to compel distribution of the property upon attaining the age of 21, etc. Effective Date: 07/01/2015

CS/CS/SB 1048 (3R) by the Committees on Rules, Transportation and Senator Garcia—

Motor Vehicle Manufacturer Licenses; Providing that a motor vehicle dealer who received approval of a facility from an applicant or licensee within a specified timeframe is deemed to be in full compliance with facility-related requirements; revising provisions related to an applicant or licensee who has undertaken or engaged in an audit of service-related payments or incentive payments; reducing the timeframe for the performance of such audits, etc. Effective Date: Upon becoming a law

CS/HB 105 (3R) by the Committee on Government Operations Subcommittee, Representative Eagle and others—

Publicly Funded Retirement Programs; Revises applicability of Marvin B. Clayton Firefighters Pension Trust Fund Act; authorizes municipality that provides fire protection services under an interlocal agreement with another municipality to impose excise tax on property insurance premiums; requires municipal services taxing units to provide Division of Retirement with certified copy of ordinance assessing & imposing certain taxes; revises provisions relating to limitation of disbursement; authorizes municipal services taxing unit, under certain conditions, to revoke participation & cease to receive property insurance premium taxes. Effective Date: 07/01/2015

HB 7061 (3R) by the Committee on Civil Justice Subcommittee and Representative Passidomo—

Pub. Rec./Florida RICO Act; Provides exemption from public records requirements for certain documents & information held by investigative agency pursuant to investigation relating to activity prohibited under Florida RICO Act; authorizes disclosure of such documents & information under certain conditions; provides for future legislative review & repeal of exemption; provides statement of public necessity; provides for contingent effect. Effective Date: On the same date that HB 7059 or similar legislation relating to offenses concerning racketeering and illegal debts takes effect

CS/CS/HB 655 (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee and Representative Roberson—

Clinical Laboratories; Revises definition of term "licensed practitioner" to include consultant pharmacists or doctors of pharmacy licensed under ch. 465, F.S.; requires clinical laboratories to make services available to specified licensed practitioners; prohibits such clinical laboratory from charging different prices for services based upon chapter under which practitioner is licensed. Effective Date: Upon becoming a law

CS/CS/HB 149 (3R) by the Committees on Judiciary Committee, Children, Families and Seniors Subcommittee, Representative Rouson and others—

Rights of Grandparents; Authorizes grandparent of minor child to petition court for visitation; provides for application of Uniform Child Custody Jurisdiction & Enforcement Act; provides conditions under which court may terminate grandparent visitation. Effective Date: 07/01/2015

CS/HB 565 (3R) by the Committee on Government Operations Subcommittee and Representative Beshears—

Retirement; Authorizes local agency employers to reassess designation of positions for inclusion in SMS Class; provides for removal of certain positions. Effective Date: 07/01/2015

*Substituted for **CS/SB 1054(SUB)** (Evers) and read the second time on April 24, 2015*

CS/CS/CS/SB 1172 (3R) by the Committees on Fiscal Policy, Judiciary, Regulated Industries and Senator Latvala—

Termination of a Condominium Association; Providing and revising procedures and requirements for termination of a condominium property; revising requirements relating to the right to contest a plan of termination, etc. Effective Date: 07/01/2015

HB 887 (3R) by Representative Trumbull—

Unclaimed Property; Provides for escheatment to state of unclaimed U.S. savings bonds; provides for judicial determination of escheatment; provides procedures for challenging escheatment; provides for deposit of proceeds of escheatment; provides that person claiming a U.S. savings bond may file claim. Effective Date: 07/01/2015

CS/HB 1151 (3R) by the Committee on Business and Professions Subcommittee and Representative Ingoglia—

Residential Master Building Permit Programs; Requires local governments, if requested by certain contractors, to create master building permit programs by specified date to assist builders who expect to construct specific dwellings & townhomes repeatedly; provides requirements for submitting master building permit applications, general construction plans, & site-specific building permit applications; authorizes builders to submit master building permit numbers unlimited number of times under certain conditions; limits revisions to approved master building permits; requires governing body of applicable local government to set fees; provides for penalties; authorizes local governments to adopt procedures to effectuate master building permit programs. Effective Date: 07/01/2015

Emergency Treatment for Opioid Overdose; Designates act as "Emergency Treatment & Recovery Act"; authorizes certain health care practitioners to prescribe emergency opioid antagonist to patient or caregiver; authorizes storage, possession, & administration of emergency opioid antagonist by patient or caregiver & certain emergency responders; provides immunity from professional sanction or disciplinary action for certain health care practitioners & pharmacists. Effective Date: Upon becoming a law
