**Housing Assistance;** Revising the powers that the Florida Housing Finance Corporation may exercise in developing and administering the State Apartment Incentive Loan Program; requiring that State Apartment Incentive Loan Program funds be made available through a competitive solicitation process, subject to certain requirements; requiring that the State Office on Homelessness coordinate among certain agencies and providers to produce a statewide consolidated inventory for the state's entire system of homeless programs which incorporates regionally developed plans, etc. Effective Date: 07/01/2016

**Health Care Providers;** Revising the definitions of the terms "contract" and "health care provider"; extending sovereign immunity to employees or agents of a health care provider that executes a contract with a governmental contractor; requiring the posting of notice that a specified health care provider is an agent of a governmental contractor; revising the definition of the term "officer, employee, or agent" to include employees or agents of a health care provider, etc. Effective Date: 07/01/2016

#### **CS/CS/SB 938 (3R) by the Committees on Commerce and Tourism, Health Policy and Senator Benacquisto—**

**Retail Sale of Dextromethorphan;** Prohibiting a manufacturer, distributor, or retailer, or its employees and representatives, from knowingly or willfully selling a finished drug product containing dextromethorphan to a person younger than 18 years of age; prohibiting a person younger than 18 years of age from purchasing a finished drug product containing dextromethorphan, etc. Effective Date: 01/01/2017

**CS/CS/SB 772, 1st Eng. (3R) by the Committees on Appropriations, Commerce and Tourism and Senator Richter—**

**Regulated Service Providers;** Revising the composition of the Board of Professional Surveyors and Mappers; requiring the department to waive the initial registration fee for an intrastate mover for certain veterans, the spouses of such veterans, or certain business entities that have a majority ownership held by such veterans or spouses; exempting water-related amusement rides operated by lodging and food service establishments and membership campgrounds, amusement rides at private, membership-only facilities, and nonprofit permanent facilities from certain safety standards; authorizing certain tax collector offices, upon approval and confirmation of license issuance by the department, to print and deliver concealed weapon or firearm licenses, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming law, this act shall take effect July 1, 2016

**CS/SB 754 (3R) by the Committee on Commerce and Tourism and Senator Richter—**

**Public Records/Department of Agriculture and Consumer Services Criminal or Civil Intelligence or Investigative Information;** Providing an exemption from public records requirements for criminal or civil intelligence or investigative information or any other information held by the Department of Agriculture and Consumer Services as part of an examination or investigation with another state or federal regulatory, administrative, or criminal justice agency; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: Upon becoming a law if SB 772 or similar legislation is adopted in the same legislative session or an extension thereof and becomes a law

**HB 7101, 1st Eng. (3R) by the Committee on Criminal Justice Subcommittee, Representatives Trujillo, Spano and others—**

**Sentencing for Capital Felonies;** Requiring the prosecutor to give notice to the defendant and to file the notice with the court within a certain timeframe if the prosecutor intends to seek the death penalty; requiring juries to determine the existence of aggravating factors, if any, in the penalty phase of capital cases; requiring a certain determination by at least 10 jurors to support a recommendation of a sentence of death; deleting provisions relating to advisory sentencing by juries and findings by the court in support of sentences of death, etc. Effective Date: Upon becoming a law

**SB 908, 1st Eng. (3R) by Senator Lee—**

**Organization of the Department of Financial Services;** Authorizing the Chief Financial Officer, rather than the Division of Accounting and Auditing, to audit and adjust accounts of officers and those indebted to the state; revising the divisions and the location of bureaus within the divisions; amending provisions relating to the transfer of certain functions to the Division of Investigative and Forensic Services; amending provisions relating to the renaming of the Bureau of Unclaimed Property, etc. Effective Date: 07/01/2016

---

**CS/HB 793, 1st Eng. (3R) by the Committee on Education Appropriations Subcommittee, Representative O'Toole and others—**

**Florida Bright Futures Scholarship Program;** Provides that initial award period & renewal period for students who are unable to accept initial award immediately after high school due to specific obligations begins upon completion of obligation; requires student, as prerequisite for certain awards, to identify social or civic issue or professional area of interest & develop specified plan; creates Florida Gold Seal CAPE Scholars award; provides appropriation. Effective Date: Upon becoming a law

**CS/SB 986 (3R) by the Committee on Banking and Insurance and Senator Simpson—**

**Workers' Compensation System Administration;** Deleting a required item to be listed on a notice of election to be exempt; requiring that the Department of Financial Services allow an employer who has not previously been issued an order of penalty assessment to receive a specified credit to be applied to the penalty; eliminating the certification requirements when an expert medical advisor is selected by a judge of compensation claims; deleting the requirement that employers notify the department within 24 hours of any injury resulting in death, etc. Effective Date: 10/01/2016

**HB 967 (3R) by Representative Stevenson and others—**

**Family Law;** Designates act as "Collaborative Law Process Act"; provides that collaborative law process begins when parties enter into collaborative law participation agreement; prohibits tribunal from ordering party to participate in collaborative law process over party's objection; provides conditions under which collaborative law process concludes, terminates, or continues; provides for confidentiality of communications made during collaborative law process; provides exceptions. Effective Date: 07/01/2016

**CS/SB 960 (3R) by the Committee on Transportation and Senator Bradley—**

**Protection of Motor Vehicle Dealers' Consumer Data;** Requiring that a licensee or a third party comply with certain restrictions on reuse or disclosure of consumer data received from a motor vehicle dealer; requiring that upon request of a motor vehicle dealer a licensee provide a list of the consumer data obtained and all persons to whom any of the data has been disclosed, subject to certain requirements; requiring the licensee to indemnify the motor vehicle dealer for certain claims or damages, etc. Effective Date: Upon becoming a law

**CS/SB 1508, 1st Eng. (3R) by the Committee on Community Affairs and Senator Simpson—**

**Growth Management;** Providing that a proposed development that is consistent with certain comprehensive plans is not required to undergo review pursuant to the state coordinated review process; revising the requirements relating to permits required for obstructions; revising the circumstances under which a political subdivision owning or controlling an airport and another political subdivision adopt, administer, and enforce airport protection zoning regulations or create a joint airport protection zoning board; repealing provisions relating to guidelines regarding land use near airports, etc. Effective Date: 07/01/2016

**CS/CS/SB 436 (3R) by the Committees on Appropriations, Criminal Justice, Senator Simpson and others—**

**Crime of Making Threats of Terror or Violence;** Creating the crime of falsely reporting the use of firearms in a violent manner against a person or persons; defining the terms “family member of a person” and “law enforcement officer”, etc. Effective Date: 10/01/2016

**SB 1402, 1st Eng. (3R) by Senator Simmons—**

**Ratification of Department of Financial Services Rules;** Ratifying a specified rule relating to the Florida Workers' Compensation Health Care Provider Reimbursement Manual for the sole and exclusive purpose of satisfying any condition on effectiveness pursuant to s. 120.541(3), F.S., which requires ratification of any rule exceeding the specified thresholds for likely adverse impact or increase in regulatory costs; providing applicability, etc. Effective Date: 07/01/2016

**CS/CS/CS/SB 948 (3R) by the Committees on Rules, Fiscal Policy, Commerce and Tourism and Senator Richter—**

**Secondhand Dealers;** Requiring that the record of a secondhand dealer transaction include digital photos of the items; requiring a different method of identification when certain numbers are not available; revising the required holding period for certain goods acquired by a dealer; authorizing an action in replevin against a secondhand dealer based on a right of possession to stolen goods; revising the period of time a secondhand dealer must hold secondhand goods at a registered location, etc. Effective Date: 07/01/2016

**CS/CS/SB 1432 (3R) by the Committees on Rules, Judiciary and Senator Stargel—**

**Service of Process;** Expanding the locations at which substitute service of process may be made when such location is the only discoverable address for the person to be served; providing that orders issued by agencies of other states are not enforceable under certain circumstances, etc. Effective Date: 07/01/2016

**HB 43, 1st Eng. (3R) by Representatives Plakon, Cortes, B. and others—**

**Churches or Religious Organizations;** Provides that churches or religious organizations, related organizations, or certain individuals may not be required to solemnize any marriage or provide services, accommodations, facilities, goods, or privileges for related purposes if such action would violate sincerely held religious belief; prohibits certain legal actions, penalties, or governmental sanctions against such individuals or entities. Effective Date: 07/01/2016

**CS/SB 1538 (3R) by the Committee on Military and Veterans Affairs, Space, and Domestic Security and Senator Evers—**

**Veterans Employment;** Requiring each state agency and authorizing other political subdivisions of the state to develop and implement a veterans recruitment plan; requiring specified goals for veterans recruitment plans; requiring the Department of Management Services to collect specified data and to include the data in its annual workforce report and on its website, etc. Effective Date: 10/01/2016

**SB 1412 (3R) by Senator Simmons—**

**Conditions of Pretrial Release;** Requiring that a defendant be notified in writing if a court issues an order of no contact rather than receive a copy of the order, etc. Effective Date: 07/01/2016

**CS/CS/SB 1604, 1st Eng. (3R) by the Committees on Appropriations, Health Policy and Senator Grimsley—**

**Drugs, Devices, and Cosmetics;** Providing, revising, and deleting definitions for purposes of the Florida Drug and Cosmetic Act; revising prohibited acts related to the distribution of prescription drugs; providing that a restricted prescription drug distributor permit is not required for distributions between certain pharmacies; providing for the expiration, renewal, and issuance of certain drug, device, and cosmetic product registrations, etc. Effective Date: 07/01/2016

*Read the second time and amended on March 2, 2016*

---

**CS/SB 1570 (3R) by the Committee on Transportation and Senator Simmons—**

**School Bus Stop Safety;** Revising the terms of violation and the penalties for failure to stop a vehicle upon approaching a school bus that displays a stop signal; requiring an additional fee to be added to a fine imposed for a specified violation, etc. Effective Date: 10/01/2016

**CS/CS/CS/SB 912, 1st Eng. (3R) by the Committees on Rules, Fiscal Policy, Criminal Justice, Senator Flores and others—**

**Fraudulent Activities Associated with Payment Systems;** Revising the felony classification for unlawful conveyance of fuel; requiring retail petroleum fuel measuring devices fitted with scanning devices to have certain security measures; requiring the owner or operator of a device to have certain security measures in place within a specified timeframe upon notice from the Department of Agriculture and Consumer Services; revising the prohibition against trafficking in or possession of counterfeit credit cards, etc. Effective Date: 10/01/2016

*Read the second time and amended on March 2, 2016*

---

**CS/CS/SB 718 (3R) by the Committees on Appropriations, Transportation and Senator Sobel—**

**Identification Cards;** Requiring the Department of Highway Safety and Motor Vehicles to issue an identification card exhibiting a special designation for a person who has a developmental disability under certain circumstances; requiring payment of an additional fee and proof of diagnosis by a licensed physician; requiring the fee to be deposited into the Agency for Persons with Disabilities Operations and Maintenance Trust Fund; requiring the department to develop rules to facilitate the issuance, requirements, and oversight of developmental disability identification cards, etc. Effective Date: 10/01/2016

**CS/CS/SB 400 (3R) by the Committees on Appropriations, Environmental Preservation and Conservation and Senator Hays—**
