Consumer Protection; Citing this act as "Terry's Law"; requiring retail sales establishments that sell goods to the public to grant a refund within a specified time for goods costing more than a specified amount if returned by a consumer who has been adjudicated incapacitated, is subject to a certain type of guardianship, or has a certain medical condition, if specified requirements are satisfied; providing penalties for a violation of the requirements, etc. Effective Date: 07/01/2016

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 160 (2R) by the Committees on Fiscal Policy, Community Affairs and Senator Gaetz—

Ad Valorem Tax Exemption for Deployed Servicemembers; Revising the military operations that qualify a servicemember deployed in support of such an operation in the previous calendar year for an additional ad valorem tax exemption; providing an extended deadline and specifying procedures for filing an application for such tax exemption for a qualifying deployment during the 2014 and 2015 calendar years; providing refund procedures for servicemembers who were on qualifying deployments for more than 365 days during the 2014 and 2015 calendar years, etc. Effective Date: Upon becoming a law, and first applies to ad valorem tax rolls for 2016

Reported favorably as a committee substitute by the Committee on Community Affairs; the Committee on Finance and Tax reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 242 (2R) by the Committees on Fiscal Policy, Health Policy, Senator Braynon and others—

Infectious Disease Elimination Pilot Program; Citing this act as the "Miami-Dade Infectious Disease Elimination Act (IDEA)"; authorizing the University of Miami and its affiliates to establish a sterile needle and syringe exchange pilot program in Miami-Dade County; providing that the possession, distribution, or exchange of needles and syringes under the pilot program is not a violation of the Florida Comprehensive Drug Abuse Prevention and Control Act or any other law; requiring the pilot program to collect certain data for reporting purposes; prohibiting the collection of personal identifying information from program participants, etc. Effective Date: 07/01/2016

CS/CS/SB 286 (2R) by the Committees on Fiscal Policy, Banking and Insurance and Senator Brandes—
