Dredge and Fill Activities; Revising the acreage of wetlands and other surface waters subject to impact by dredge and fill activities under a state programmatic general permit; providing that seeking to use such a permit consents to specified federal wetland jurisdiction criteria; deleting certain conditions limiting when the department may assume federal permitting programs for the discharge of dredged or fill material, etc. Effective Date: Upon becoming a law

Jury Service; Providing that certain persons permanently incapable of caring for themselves may be permanently excused from jury service upon request; providing requirements for such a request, etc. Effective Date: 07/01/2016

Financial Transactions; Exempting a private school from the prohibition against charging certain convenience fees to a student or family paying tuition, fees, or other student account charges by credit card under certain circumstances; prohibiting a licensee from making payments to a person as compensation, inducement, or reward for referring loan applications to the licensee under certain circumstances; providing that chapter 670, F.S., governs certain funds transfers that are remittance transfers; reducing the time limit for a mortgagee or an assignee to cancel a mortgage, except in cases where the loan is an open-end mortgage, etc. Effective Date: 07/01/2016

Reimbursement to Health Access Settings for Dental Hygiene Services for Children; Authorizing reimbursement for children’s dental services provided by licensed dental hygienists in certain circumstances, etc. Effective Date: 07/01/2016

Solid Waste Management; Providing for the funding of a waste tire abatement program from the Solid Waste Management Trust Fund up to a specified percentage of total funds; authorizing the Department of Environmental Protection to use account funds to contract with a third party for the closing and long-term care of solid waste management facilities under specified circumstances; authorizing waste tire abatement programs under the small county consolidated grant program, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall become effective upon this act becoming a law, this act shall take effect July 1, 2016

Title Insurance; Revises reserves that certain title insurers must set aside after certain date; revises manner in which reserves must be released; revises reserve requirements for title insurer who transfers domicile to this state; requires calculation of adjusted statutory premium reserve; requires increases to statutory premium reserves under certain circumstances; authorizes release of reserves to surplus in certain circumstances. Effective Date: 07/01/2016

At-risk Vessels; Prohibiting a vessel that is at risk of becoming derelict from anchoring on, mooring on, or occupying the waters of this state; providing that a person who anchors or moors such a vessel or allows it to occupy waters of this state commits a noncriminal infraction, etc. Effective Date: 07/01/2016

Housing Assistance; Revising the powers that the Florida Housing Finance Corporation may exercise in developing and administering the State Apartment Incentive Loan Program; requiring that State Apartment Incentive Loan Program funds be made available through a competitive solicitation process, subject to certain requirements; requiring that the State Office on Homelessness coordinate among certain agencies and providers to produce a statewide consolidated inventory for the state's entire system of homeless programs which incorporates regionally developed plans, etc. Effective Date: 07/01/2016

Reported favorably by the Committee on Community Affairs; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 514 (SO) by the Committees on Community Affairs, Ethics and Elections and Senator Richter—

Supervisor of Elections Salaries; Revising the base salaries and group rates used to calculate additional compensation for a supervisor of elections based on population increments, etc. Effective Date: 10/01/2016

Reported favorably as a committee substitute by the Committee on Ethics and Elections; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/SB 1034 (SO) by the Committee on Judiciary and Senator Simmons—

Health Care Providers; Revising the definitions of the terms "contract" and "health care provider"; extending sovereign immunity to employees or agents of a health care provider that executes a contract with a governmental contractor; requiring the posting of notice that a specified health care provider is an agent of a governmental contractor; revising the definition of the term "officer, employee, or agent" to include employees or agents of a health care provider, etc. Effective Date: 07/01/2016

Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

CS/CS/SB 938 (SO) by the Committees on Commerce and Tourism, Health Policy and Senator Benacquisto—

Retail Sale of Dextromethorphan; Prohibiting a manufacturer, distributor, or retailer, or its employees and representatives, from knowingly or willfully selling a finished drug product containing dextromethorphan to a person younger than 18 years of age; prohibiting a person younger than 18 years of age from purchasing a finished drug product containing dextromethorphan, etc. Effective Date: 01/01/2017

Reported favorably as a committee substitute by the Committee on Health Policy; reported favorably as a committee substitute by the Committee on Commerce and Tourism; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/CS/SB 772 (SO) by the Committees on Appropriations, Commerce and Tourism and Senator Richter—

Regulated Service Providers; Revising the composition of the Board of Professional Surveyors and Mappers; requiring the department to waive the initial registration fee for an intrastate mover for certain veterans, the spouses of such veterans, or certain business entities that have a majority ownership held by such veterans or spouses; exempting water-related amusement rides operated by lodging and food service establishments and membership campgrounds, amusement rides at private, membership-only facilities, and nonprofit permanent facilities from certain safety standards; authorizing certain tax collector offices, upon approval and confirmation of license issuance by the department, to print and deliver concealed weapon or firearm licenses, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2016

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 754 (SO) by the Committee on Commerce and Tourism and Senator Richter—

Public Records/Department of Agriculture and Consumer Services Criminal or Civil Intelligence or Investigative Information; Providing an exemption from public records requirements for criminal or civil intelligence or investigative information or any other information held by the Department of Agriculture and Consumer Services as part of an examination or investigation with another state or federal regulatory, administrative, or criminal justice agency; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: Upon becoming a law if SB 772 or similar legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/SB 7068 (SO) by the Committees on Appropriations, and Criminal Justice (Evers)—

Sentencing for Capital Felonies; Requiring the prosecutor to give notice to the defendant and to file the notice with the court within a certain timeframe if the prosecutor intends to seek the death penalty; requiring juries to determine the existence of aggravating factors, if any, in the penalty phase of capital cases; requiring the court to enter an order meeting specified requirements in each case in which it imposes a death sentence, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Appropriations

Similar to HB 7101, 1st Eng.(HC) in the Committees on Criminal Justice; and Appropriations

SB 908 (SO) by Senator Lee—

Organization of the Department of Financial Services; Authorizing the Chief Financial Officer, rather than the Division of Accounting and Auditing, to audit and adjust accounts of officers and those indebted to the state; revising the divisions and the location of bureaus within the divisions; amending provisions relating to the transfer of certain functions to the Division of Investigative and Forensic Services; amending provisions relating to the renaming of the Bureau of Unclaimed Property, etc. Effective Date: 07/01/2016

Reported favorably by the Committee on Banking and Insurance; recommended favorably by Appropriations Subcommittee on General Government; and reported favorably by the Committee on Appropriations

CS/SB 520 (SO) by the Committee on Fiscal Policy, Senator Lee and others—

Florida Bright Futures Scholarship Program; Providing that the initial award period and the renewal period for students who are unable to accept an initial award immediately after completion of high school due to a full-time religious or service obligation begin upon the completion of the religious or service obligation; requiring a student, as a prerequisite for the Florida Gold Seal Vocational Scholars award, to identify a civic issue or a professional area of interest and develop a plan for his or her personal involvement in addressing the issue or learning about the area, etc. Effective Date: 07/01/2016

Reported favorably by the Committee on Higher Education; recommended favorably as a committee substitute by Appropriations Subcommittee on Education; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/HB 793, 1st Eng.(HC) in the Committees on Higher Education; Appropriations Subcommittee on Education; and Fiscal Policy

CS/SB 986 (SO) by the Committee on Banking and Insurance and Senator Simpson—

Workers' Compensation System Administration; Deleting a required item to be listed on a notice of election to be exempt; requiring that the Department of Financial Services allow an employer who has not previously been issued an order of penalty assessment to receive a specified credit to be applied to the penalty; eliminating the certification requirements when an expert medical advisor is selected by a judge of compensation claims; deleting the requirement that employers notify the department within 24 hours of any injury resulting in death, etc. Effective Date: 10/01/2016

Reported favorably as a committee substitute by the Committee on Banking and Insurance; Appropriations Subcommittee on General Government recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

SB 972 (SO) by Senator Lee—

Family Law; Citing this act as the “Collaborative Law Process Act”; providing that a collaborative law process begins when the parties enter into a collaborative law participation agreement; prohibiting a tribunal from ordering a party to participate in a collaborative law process over the party’s objection; providing for confidentiality of communications made during the collaborative law process, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2016

Reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

*Identical to **HB 967(HC)** in the Committees on Judiciary; and Rules*

CS/SB 960 (SO) by the Committee on Transportation and Senator Bradley—

Protection of Motor Vehicle Dealers’ Consumer Data; Requiring that a licensee or a third party comply with certain restrictions on reuse or disclosure of consumer data received from a motor vehicle dealer; requiring that upon request of a motor vehicle dealer a licensee provide a list of the consumer data obtained and all persons to whom any of the data has been disclosed, subject to certain requirements; requiring the licensee to indemnify the motor vehicle dealer for certain claims or damages, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Transportation; the Committee on Commerce and Tourism reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/SB 1508 (SO) by the Committee on Community Affairs and Senator Simpson—

Airport Zoning; Revising the requirements relating to permits required for obstructions; revising the circumstances under which a political subdivision owning or controlling an airport and another political subdivision adopt, administer, and enforce airport protection zoning regulations or create a joint airport protection zoning board; repealing provisions relating to guidelines regarding land use near airports, etc. Effective Date: 07/01/2016

Reported favorably by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Appropriations reports the committee substitute favorably

CS/CS/SB 436 (SO) by the Committees on Appropriations, Criminal Justice, Senator Simpson and others—

Crime of Making Threats of Terror or Violence; Creating the crime of falsely reporting the use of firearms in a violent manner against a person or persons; defining the terms “family member of a person” and “law enforcement officer”, etc. Effective Date: 10/01/2016

Reported favorably as a committee substitute by the Committee on Criminal Justice; and reported favorably as a committee substitute by the Committee on Appropriations

SB 1402 (SO) by Senator Simmons—

Ratification of Department of Financial Services Rules; Ratifying a specified rule relating to the Florida Workers’ Compensation Health Care Provider Reimbursement Manual for the sole and exclusive purpose of satisfying any condition on effectiveness pursuant to s. 120.541(3), F.S., which requires ratification of any rule exceeding the specified thresholds for likely adverse impact or increase in regulatory costs; providing applicability, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Banking and Insurance

CS/CS/CS/SB 948 (SO) by the Committees on Rules, Fiscal Policy, Commerce and Tourism and Senator Richter—

Secondhand Dealers; Requiring that the record of a secondhand dealer transaction include digital photos of the items; requiring a different method of identification when certain numbers are not available; revising the required holding period for certain goods acquired by a dealer; authorizing an action in replevin against a secondhand dealer based on a right of possession to stolen goods; revising the period of time a secondhand dealer must hold secondhand goods at a registered location, etc. Effective Date: 07/01/2016

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Committee on Judiciary reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 1432 (SO) by the Committees on Rules, Judiciary and Senator Stargel—

Service of Process; Expanding the locations at which substitute service of process may be made when such location is the only discoverable address for the person to be served; providing that orders issued by agencies of other states are not enforceable under certain circumstances, etc. Effective Date: 07/01/2016

Reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules

SB 110 (SO) by Senator Bean and others—
