#### **CS/CS/SB 7040 (3R) by the Committees on Appropriations, Governmental Oversight and Accountability, and Ethics and Elections (Baxley)—**

**Financial Disclosure;** Requiring the Commission on Ethics to procure and test an electronic filing system by a certain date; requiring certain forms to be filed electronically beginning on a specified date; providing that the commission is not liable for the release of certain information under certain circumstances; requiring the commission to redact certain information under certain circumstances, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

#### **CS/SB 7042 (3R) by the Committees on Governmental Oversight and Accountability, and Ethics and Elections (Baxley)—**

**Public Records/Commission on Ethics;** Providing exemptions from public records requirements for secure login credentials held by the Commission on Ethics and certain information entered into the electronic filing system for financial disclosure forms; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: On the same date that SB 7040 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

#### **CS/HB 6525 (3R) by the Committee on Civil Justice Subcommittee and Representative Fernandez—**

**Relief/Dominguez Family/Hillsborough County;** Provides appropriation from Hillsborough County to compensate the Dominguez family for wrongful death of Darcia Lynn Dominguez caused by negligence of Hillsborough County & its employee; provides limit on payment of compensation, attorney fees, lobbying fees, & costs. Effective Date: Upon becoming a law

*Substituted for CS/SB 42(SUB) (Taddeo) and read the second time on April 23, 2019*

#### **CS/CS/CS/CS/SB 76 (3R) by the Committees on Rules, Judiciary, Innovation, Industry, and Technology, Infrastructure and Security, Senator Simpson and others—**

**Driving While Using a Wireless Communications Device;** Prohibiting a person from operating a motor vehicle while using a wireless communications device; authorizing a law enforcement officer during a specified period to stop motor vehicles to issue warnings to persons who are driving while using a wireless communications device; providing that a user's billing records for a wireless communications device or the testimony of or written statements from certain authorities are admissible as evidence in crashes involving serious bodily injury, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

**CS/SB 7068, 1st Eng. (3R) by the Committees on Appropriations, and Infrastructure and Security (Lee)—**

**Transportation;** Creating the Multi-use Corridors of Regional Economic Significance Program within the Department of Transportation; specifying that projects undertaken in the corridors are tolled facilities and certain approved turnpike projects, and are considered as Strategic Intermodal System facilities; requiring the department to identify certain opportunities to accommodate or colocate multiple types of infrastructure-addressing issues during the project development phase, etc. Effective Date: 07/01/2019

*Read the second time and amended on April 23, 2019*

**CS/SB 354, 1st Eng. (3R) by the Committee on Education and Senator Montford—**

**Immunization Registry;** Revising provisions relating to the communicable disease prevention and control programs under the Department of Health; establishing that a certain student who obtains a vaccination from a Florida college or university student health center may refuse to be included in the immunization registry; revising school-entry health requirements to require students to have a certificate of immunization on file with the department's immunization registry, etc. Effective Date: 01/01/2021

**SB 446 (3R) by Senator Mayfield and others—**

**Coastal Management;** Revising the criteria the Department of Environmental Protection must consider in determining and assigning annual funding priorities for beach management and erosion control projects; revising the ranking criteria to be used by the department to establish certain funding priorities for certain inlet-caused beach erosion projects; revising requirements for the comprehensive long-term management plan; requiring the plan to include a strategic beach management plan, a critically eroded beaches report, and a statewide long-range budget plan, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

**SB 530 (3R) by Senator Brandes and others—**

**Alcohol or Drug Overdose Prosecutions;** Prohibiting the arrest, charge, prosecution, or penalization under specified provisions of a person acting in good faith who seeks medical assistance for an individual experiencing, or believed to be experiencing, an alcohol-related overdose; prohibiting the arrest, charge, prosecution, or penalization under specified provisions of a person acting in good faith who seeks medical assistance for an individual experiencing, or believed to be experiencing, a drug-related overdose, etc. Effective Date: 07/01/2019

**CS/SB 920 (3R) by the Committee on Criminal Justice and Senator Pizzo—**

**DNA Database;** Revising legislative findings relating to the use of the DNA database, etc. Effective Date: 07/01/2019

**CS/CS/HB 7065, 1st Eng. (3R) by the Committees on Judiciary Committee, Insurance and Banking Subcommittee, Civil Justice Subcommittee, Representative Rommel and others—**

**Insurance Assignment Agreements;** Providing requirements and limitations for property insurance assignment agreements; providing a burden of proof; providing that an assignment agreement does not affect managed repair arrangements under a property insurance policy; providing that an acceptance by an assignee of an assignment agreement is a waiver by the assignee and its subcontractors of certain claims against an insured; specifying an insured's payment obligations under an assignment agreement; requiring notice of intent to initiate litigation, etc. Effective Date: 07/01/2019

**SB 2502 (SO) by the Committee on Appropriations (Bradley)—**

**Implementing the 2019-2020 General Appropriations Act;** Incorporating by reference certain calculations of the Florida Education Finance Program; providing that funds for instructional materials must be released and expended as required in specified proviso language; deleting a provision providing for the carrying forward of undisbursed funds allocated for the Schools of Hope Revolving Loan Program; creating the Community School Grant Program within the Department of Education, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2019; or, if this act fails to become a law until after that date, it shall take effect upon becoming a law and shall operate retroactively to July 1, 2019

**CS/SB 94 (SO) by the Committee on Rules, Senator Stewart and others—**

**Child Care Facilities;** Citing this act as the "Child Safety Alarm Act"; requiring that, by a specified date, vehicles used by child care facilities and large family child care homes to transport children be equipped with a reliable alarm system that prompts the driver to inspect the vehicle for children before exiting the vehicle; requiring the Department of Children and Families to adopt by rule minimum safety standards and to maintain a list of approved alarm manufacturers and alarm systems, etc. Effective Date: 10/01/2019

*Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably by the Committee on Infrastructure and Security; and reported favorably as a committee substitute by the Committee on Rules*

---

**CS/SB 190 (SO) by the Committee on Appropriations and Senator Stargel—**

**Higher Education;** Requiring the Auditor General to verify the accuracy of unexpended amounts in specified funds certified by university and Florida College System institution chief financial officers; requiring the Board of Governors to develop and annually deliver a training program for members of state university boards of trustees; prohibiting a Florida College System institution direct-support organization from giving, directly or indirectly, any gift to a political committee; requiring, by a specified academic year, Florida College System institutions and state universities to execute agreements to establish “2+2” targeted pathway programs, etc. Effective Date: 07/01/2019

---

**SB 198 (SO) by Senator Berman—**

**Trademark Classifications;** Revising classes of goods and services to conform to the classifications adopted by the United States Patent and Trademark Office, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Commerce and Tourism; reported favorably by the Committee on Innovation, Industry, and Technology; and reported favorably by the Committee on Rules*

*Identical to **HB 445(HC)** in the Committees on Commerce and Tourism; Innovation, Industry, and Technology; and Rules*

---

**CS/CS/SB 322 (SO) by the Committees on Health Policy, Banking and Insurance and Senator Simpson—**

**Preexisting Conditions;** Defining the terms “operative date” and “preexisting medical condition” with respect to individual and group health insurance policies, respectively; requiring insurers, contingent upon the occurrence of either of two specified events, to make at least one comprehensive major medical health insurance policy available to all residents of this state within a specified timeframe; prohibiting such insurers from excluding, limiting, denying, or delaying coverage under such policies due to preexisting medical conditions, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Health Policy; and the Committee on Rules reports the committee substitute favorably*

---

**SB 342 (SO) by Senator Lee—**

**Public Records/Voters and Voter Registration;** Providing an exemption from public records requirements for information concerning preregistered voter registration applicants who are minors; providing for future legislative review and repeal; providing for retroactive application; providing a statement of public necessity, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Ethics and Elections; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules*

---

**CS/CS/SB 418 (SO) by the Committees on Rules, Banking and Insurance and Senator Simpson—**

**Essential Health Benefits Under Health Plans;** Requiring the Office of Insurance Regulation to conduct a study evaluating this state’s current benchmark plan for essential health benefits under the federal Patient Protection and Affordable Care Act (PPACA) and options for changing the benchmark plan for future plan years; requiring the office, in conducting the study, to consider plans and certain benefits used by other states and to compare costs with those of this state, etc. Effective Date: Upon becoming a law

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Health Policy reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules*

---

**CS/CS/CS/SB 452 (SO) by the Committees on Governmental Oversight and Accountability, Judiciary, Children, Families, and Elder Affairs and Senator Gibson—**

**Elder Abuse Fatality Review Teams;** Authorizing the establishment of elder abuse fatality review teams in each judicial circuit and housing the review teams, for administrative purposes only, in the Department of Elderly Affairs; assigning responsibility for paying the administrative costs of review team operations to the team members or the entities they represent, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Appropriations reports the committee substitute favorably*

---

**CS/CS/SB 494 (SO) by the Committees on Rules, Governmental Oversight and Accountability, Senator Hooper and others—**

**Firefighters’ Bill of Rights;** Requiring that witnesses be interviewed and certain information be provided to a firefighter subjected to interrogation before the interrogation is conducted; prohibiting a firefighter from being threatened with certain disciplinary action during the course of an interrogation; requiring that a firefighter be notified and provided certain information before certain disciplinary actions are taken, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Rules*

---

**SM 852 (SO) by Senator Diaz and others—**

**VA MISSION Act of 2018;** Urging Congress and the Department of Veterans Affairs to ensure that the VA MISSION Act of 2018 is implemented in a manner consistent with the legislative intent and purpose of the act, etc.

*Reported favorably by the Committee on Military and Veterans Affairs and Space; and reported favorably by the Committee on Rules*

---

**CS/CS/CS/SB 862 (SO) by the Committees on Rules, Judiciary, Banking and Insurance and Senator Stargel—**

**Lessor Liability Under Special Mobile Equipment Leases;**

Providing that a lessor of special mobile equipment that causes injury, death, or damage is not liable for certain acts of the lessee or lessee's agent if the lease agreement requires documented proof of specified insurance coverage; providing that a lessee's failure to have in effect the required coverage does not impose liability on the lessor, etc. Effective Date: 07/01/2019

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules*

---

**SB 910 (SO) by Senator Gainer and others—**

**Court-ordered Treatment Programs;** Providing that veterans who were discharged or released under any condition, individuals who are current or former United States Department of Defense contractors, and individuals who are current or former military members of a foreign allied country are eligible in a certain Military Veterans and Servicemembers Court Program, etc. Effective Date: 10/01/2020

*Reported favorably by the Committee on Judiciary; recommended favorably by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably by the Committee on Appropriations*

---

**CS/CS/SB 1020 (SO) by the Committees on Appropriations, Agriculture, Senator Bradley and others—**

**State Hemp Program;** Creating the state hemp program within the Department of Agriculture and Consumer Services; providing requirements for program registration and for the distribution and retail sale of hemp and hemp products; directing the Commissioner of Agriculture, in consultation with the Governor and Attorney General, to submit a specified plan within a specified timeframe to the United States Secretary of Agriculture; revising the schools at which the department is required to authorize and oversee the development of industrial hemp pilot projects, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Innovation, Industry, and Technology; reported favorably as a committee substitute by the Committee on Agriculture; and reported favorably as a committee substitute by the Committee on Appropriations*

---

**CS/SB 1128 (SO) by the Committee on Rules and Senator Diaz—**

**Emotional Support Animals;** Providing that an individual with a disability who has an emotional support animal or obtains an emotional support animal is entitled to full and equal access to all housing accommodations; prohibiting a housing accommodation from requiring such individual to pay extra compensation for such animal; specifying that an individual with a disability is liable for certain damage done by her or his emotional support animal, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Agriculture; reported favorably by the Committee on Innovation, Industry, and Technology; and reported favorably as a committee substitute by the Committee on Rules*

**SB 1136 (SO) by Senator Harrell and others—**

**Cyberharassment;** Redefining the terms "personal identifying information" and "sexually cyberharass"; providing criminal penalties, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Criminal Justice; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules*

---

**SB 1552 (SO) by Senator Gruters and others—**

**Florida Red Tide Mitigation and Technology Development Initiative;** Establishing the Florida Red Tide Mitigation and Technology Development Initiative; requiring the initiative to submit an annual report by a specified date to the Governor, the Legislature, the Secretary of Environmental Protection, and the executive director of the Fish and Wildlife Conservation Commission; establishing the Initiative Technology Advisory Council, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Environment and Natural Resources; recommended favorably by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably by the Committee on Appropriations*

---

**CS/SB 7070 (SO) by the Committees on Appropriations, and Education (Diaz)—**

**K-12 Education;** Revising the programs through which certain parents may seek private educational choice options; providing that charters may include a provision for charter schools to be held responsible for all costs incurred by the district in connection with complaints to the Office of Civil Rights or the Equal Employment Opportunity Commission; establishing the Family Empowerment Scholarship Program; revising eligibility requirements under the Florida Tax Credit Scholarship Program for certain students; creating the Florida Best and Brightest Teacher and Principal Allocation, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect July 1, 2019

---

**SB 7076 (SO) by the Committee on Education (Diaz)—**

**State University Building Designations;** Requiring the Board of Governors to adopt regulations regarding the naming or renaming of state university facilities; specifying elements that must be addressed in the naming or renaming process; providing applicability; repealing a provision relating to the designation of a Florida State University facility, etc. Effective Date: 07/01/2019

*Reported favorably by the Committee on Rules*

**CS/SB 7098 (SO) by the Committees on Appropriations, and Governmental Oversight and Accountability (Hooper)—**

**Death Benefits;** Amending provisions relating to death benefits for law enforcement, correctional, and correctional probation officers and for firefighters, respectively; revising the payment amounts of death benefits; establishing a death benefit for emergency medical technicians and paramedics to conform to s. 31, Art. X of the State Constitution; specifying eligibility and payment amounts for such death benefits, etc. Effective Date: 07/01/2019

*Recommended favorably by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations*

---

**SB 7102 (SO) by the Committee on Innovation, Industry, and Technology (Simpson)—**

**Hemp;** Providing requirements for the distribution and retail sale of hemp extract; revising the term “cannabis” to exclude hemp for purposes of ch. 893, F.S., etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Appropriations*

---

**CS/CS/SB 732 (SO) by the Committees on Appropriations, Health Policy and Senator Flores—**

**Clinics and Office Surgery;** Requiring the Department of Health to deny or revoke the registration of or impose certain penalties against a facility where certain office surgeries are performed under certain circumstances; authorizing the department to issue an emergency order suspending or restricting the registration of a certain office if it makes certain findings; requiring a physician who performs certain office surgery and the office in which the surgery is performed to maintain specified levels of financial responsibility, etc. Effective Date: Upon becoming a law

*Reported favorably as a committee substitute by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations*
