Child Care Facilities; Citing this act as the "Child Safety Alarm Act"; requiring that, by a specified date, vehicles used by child care facilities and large family child care homes to transport children be equipped with a reliable alarm system that prompts the driver to inspect the vehicle for children before exiting the vehicle; requiring the Department of Children and Families to adopt by rule minimum safety standards and to maintain a list of approved alarm manufacturers and alarm systems, etc. Effective Date: 10/01/2019

CS/SB 190, 1st Eng. (3R) by the Committee on Appropriations and Senator Stargel—

Higher Education; Requiring the Auditor General to verify the accuracy of unexpended amounts in specified funds certified by university and Florida College System institution chief financial officers; requiring the Board of Governors to develop and annually deliver a training program for members of state university boards of trustees; prohibiting a Florida College System institution direct-support organization from giving, directly or indirectly, any gift to a political committee; requiring, by a specified academic year, Florida College System institutions and state universities to execute agreements to establish "2+2" targeted pathway programs, etc. Effective Date: 07/01/2019

HB 445 (3R) by Representative Diamond and others—

Trademark Classifications; Revises classes of goods & services to conform to classifications adopted by United States Patent & Trademark Office. Effective Date: 07/01/2019

CS/CS/SB 322, 1st Eng. (3R) by the Committees on Health Policy, Banking and Insurance and Senator Simpson—

Health Plans; Revising eligibility requirements for multiple-employer welfare arrangements; authorizing health insurers and health maintenance organizations to create new health insurance policies and health maintenance contracts meeting certain criteria for essential health benefits under the federal Patient Protection and Affordable Care Act (PPACA); revising applicability of requirements relating to preexisting conditions, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

CS/CS/CS/SB 452 (3R) by the Committees on Governmental Oversight and Accountability, Judiciary, Children, Families, and Elder Affairs and Senator Gibson—

Elder Abuse Fatality Review Teams; Authorizing the establishment of elder abuse fatality review teams in each judicial circuit and housing the review teams, for administrative purposes only, in the Department of Elderly Affairs; assigning responsibility for paying the administrative costs of review team operations to the team members or the entities they represent, etc. Effective Date: 07/01/2019

CS/CS/SB 494 (3R) by the Committees on Rules, Governmental Oversight and Accountability, Senator Hooper and others—

Firefighters' Bill of Rights; Requiring that witnesses be interviewed and certain information be provided to a firefighter subjected to interrogation before the interrogation is conducted; prohibiting a firefighter from being threatened with certain disciplinary action during the course of an interrogation; requiring that a firefighter be notified and provided certain information before certain disciplinary actions are taken, etc. Effective Date: 07/01/2019

Florida Red Tide Mitigation and Technology Development Initiative; Establishing the Florida Red Tide Mitigation and Technology Development Initiative; requiring the initiative to submit an annual report by a specified date to the Governor, the Legislature, the Secretary of Environmental Protection, and the executive director of the Fish and Wildlife Conservation Commission; establishing the Initiative Technology Advisory Council, etc. Effective Date: 07/01/2019

SB 7076 (3R) by the Committee on Education (Diaz)—

State University Building Designations; Requiring the Board of Governors to adopt regulations regarding the naming or renaming of state university facilities; specifying elements that must be addressed in the naming or renaming process; providing applicability; repealing a provision relating to the designation of a Florida State University facility, etc. Effective Date: 07/01/2019

CS/SB 7098 (3R) by the Committees on Appropriations, and Governmental Oversight and Accountability (Hooper)—

Death Benefits; Amending provisions relating to death benefits for law enforcement, correctional, and correctional probation officers and for firefighters, respectively; revising the payment amounts of death benefits; establishing a death benefit for emergency medical technicians and paramedics to conform to s. 31, Art. X of the State Constitution; specifying eligibility and payment amounts for such death benefits, etc. Effective Date: 07/01/2019

K-12 Education; Revising the programs through which certain parents may seek private educational choice options; providing that charters may include a provision for charter schools to be held responsible for all costs incurred by the district in connection with complaints to the Office of Civil Rights or the Equal Employment Opportunity Commission; establishing the Family Empowerment Scholarship Program; revising eligibility requirements under the Florida Tax Credit Scholarship Program for certain students; creating the Florida Best and Brightest Teacher and Principal Allocation, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon becoming a law, this act shall take effect July 1, 2019

CS/SB 116 (SO) by the Committee on Rules and Senator Stewart—

Motor Vehicle Racing; Authorizing a law enforcement officer to arrest a person without a warrant upon probable cause that the person committed a criminal racing violation; authorizing a law enforcement officer to arrest a person without a warrant upon probable cause that the person committed a criminal racing violation, etc. Effective Date: 07/01/2019

SB 120 (SO) by Senator Perry—

Early Childhood Music Education Incentive Pilot Program; Extending the scheduled expiration of the pilot program, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Education; recommended favorably by Appropriations Subcommittee on Education; and reported favorably by the Committee on Appropriations

CS/SB 236 (SO) by the Committee on Criminal Justice and Senator Book—

Public Records and Public Meetings; Providing an exception to the expiration of certain public records and public meetings exemptions under specified circumstances; prohibiting the disclosure of the personal identifying information of an alleged victim of sexual harassment or sexual misconduct, or information that could assist an individual in determining the identity of such alleged victim, in any portion of a proceeding conducted by the Commission on Ethics, a commission on ethics and public trust, or a county or a municipality that has established a local investigatory process which is open to the public; providing for future legislative review and repeal; providing statements of public necessity, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/SB 262 (SO) by the Committee on Judiciary, Senator Albritton and others—

Child Welfare; Providing for the name of a child's guardian ad litem or attorney ad litem to be entered on court orders in dependency proceedings; requiring cooperation between certain parties and the court to achieve permanency for a child as soon as possible; requiring the court during an adjudicatory hearing to advise parents in plain language of certain requirements to achieve permanency with their child, etc. Effective Date: 10/01/2019

Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

SJR 362 (SO) by Senator Brandes—

Abolishing the Constitution Revision Commission; Proposing amendments to the State Constitution to abolish the Constitution Revision Commission, etc.

Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules

CS/SB 442 (SO) by the Committee on Military and Veterans Affairs and Space, Senator Lee and others—

Postsecondary Education for Certain Military Personnel; Requiring the Board of Governors and State Board of Education, in consultation with the Department of Veterans' Affairs, to create a uniform system for the award of postsecondary credit to certain servicemembers and veterans of the United States Armed Forces; requiring specified postsecondary institutions to waive the transcript fee for active duty members of the Armed Forces of the United States, certain veterans, and their spouses and dependents, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Education; reported favorably as a committee substitute by the Committee on Military and Veterans Affairs and Space; and the Committee on Appropriations reports the committee substitute favorably

CS/CS/SB 642 (SO) by the Committees on Appropriations, Criminal Justice, Senator Brandes and others—

Public Safety; Authorizing certain Supreme Court justices to have an appropriate facility in their district of residence designated as their official headquarters; increasing the number of circuit judges in certain judicial circuits; increasing threshold amounts for certain theft offenses; expanding the scope of unlawful acts by a person infected with a sexually transmissible disease; prohibiting certain lewd or lascivious acts in the presence of county correctional personnel, etc. Effective Date: Except as otherwise expressly provided in this act, and except for this section, which shall take effect upon this act becoming a law, this act shall take effect October 1, 2019

Reported favorably as a committee substitute by the Committee on Criminal Justice; recommended favorably as a committee substitute by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Appropriations

SB 742 (SO) by Senator Braynon—

Designation of Eligible Telecommunications Carriers; Including certain commercial mobile radio service providers within the definition of the term "eligible telecommunications carrier"; authorizing the Public Service Commission to designate any commercial mobile radio service provider as an eligible telecommunications carrier for the limited purpose of providing Lifeline service; deleting a provision requiring carriers to allow subscribers to demonstrate continued eligibility for Lifeline service under certain conditions, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Innovation, Industry, and Technology; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules

CS/SB 828 (SO) by the Committee on Criminal Justice, Senator Rader and others—

Lewd or Lascivious Exhibition; Prohibiting certain lewd or lascivious acts in the presence of county correctional personnel; providing criminal penalties, etc. Effective Date: 07/01/2019

Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

CS/CS/CS/SB 908 (SO) by the Committees on Rules, Community Affairs, Banking and Insurance and Senator Hooper—

Firesafety Systems; Requiring, beginning on a certain date, that a uniform fire alarm permit application, along with certain other information, be used and submitted to the local enforcement agency for any project requiring a fire alarm permit; authorizing local authorities having jurisdiction to accept uniform summary inspection reports of certain fire hydrants and fire protection systems by certain means; requiring that condominium association bylaws provide requirements for the association's reasonable compliance with the Florida Fire Prevention Code; extending the date before which a local authority having jurisdiction may not require completion of a condominium's retrofitting with a fire sprinkler system, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/CS/SB 168 (SO) by the Committees on Rules, Infrastructure and Security, Judiciary, Senator Gruters and others—

Federal Immigration Enforcement; Prohibiting sanctuary policies; requiring state entities, local governmental entities, and law enforcement agencies to use best efforts to support the enforcement of federal immigration law; authorizing a law enforcement agency to transport an alien unlawfully present in the United States under certain circumstances; prohibiting discrimination on specified grounds, etc. Effective Date: Section 908.107, Florida Statutes, as created by this act, shall take effect October 1, 2019, and, except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

Reported favorably as a committee substitute by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Infrastructure and Security; and reported favorably as a committee substitute by the Committee on Rules

SB 1098 (SO) by Senator Lee—

Sales Tax Refund for Eligible Job Training Organizations; Providing that eligible job training organizations are entitled to receive a refund of a specified percentage of certain sales taxes remitted to the Department of Revenue; requiring such organizations to use the refund only for specified purposes; requiring that refunds be granted on a first-come, first-served basis, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Commerce and Tourism; reported favorably by the Committee on Finance and Tax; and reported favorably by the Committee on Appropriations

CS/CS/CS/SB 1180 (SO) by the Committees on Rules, Health Policy, Banking and Insurance, Senator Mayfield and others—

Prescription Drug Formulary Consumer Protection; Requiring insurers issuing individual or group health insurance policies to provide certain notices to current and prospective insureds within a certain timeframe before the effective date of any change to a prescription drug formulary during a policy year; specifying requirements for a notice of medical necessity that an insured's treating physician may submit to the insurer within a certain timeframe; requiring small employer carriers to comply with certain requirements for any change to a prescription drug formulary under the health benefit plan, etc. Effective Date: 01/01/2020

Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Health Policy; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 1278 (SO) by the Committees on Appropriations, Environment and Natural Resources and Senator Mayfield—

Biosolids Management; Requiring the Department of Environmental Protection, subject to appropriation, to establish a real-time water quality monitoring program; defining the term "biosolids"; prohibiting the land application of biosolids on certain sites, etc. Effective Date: 07/01/2019

Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; recommended favorably as a committee substitute by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 1306 (SO) by the Committee on Appropriations, Senator Book and others—

Women's Suffrage Centennial Commission; Creating the commission adjunct to the Department of State; prescribing duties of the commission in order to ensure a suitable statewide observance of the centennial of women's suffrage; requiring the Division of Historical Resources of the department to provide administrative and staff support, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Governmental Oversight and Accountability; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

SB 1338 (SO) by Senator Rodriguez—

Guardianship; Applying provisions relating to the determination of venue in proceedings for the appointment of a guardian to minors; requiring that a court dismiss a petition for determination of incapacity if all members of the examining committee conclude that the person is not incapacitated, unless a certain motion is filed within a specified period, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Children, Families, and Elder Affairs; and reported favorably by the Committee on Rules

CS/CS/SB 1400 (SO) by the Committees on Judiciary, Community Affairs and Senator Albritton—

Private Property Rights; Deleting a provision that authorizes electric utilities to perform certain right-of-way tree maintenance only if a property owner has received local government approval; prohibiting certain local government ordinances or regulations from requiring a permit, application, notice, fee, or fine for certain activities regarding trees on residential property; establishing a property owner bill of rights; requiring each county property appraiser office to provide information regarding the property owner bill of rights on the appraiser's website, etc. Effective Date: 07/01/2019

Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

SB 1422 (SO) by Senator Gruters—

Health Plans; Revising eligibility requirements for multiple-employer welfare arrangements; revising applicability of requirements relating to preexisting conditions; providing disclosure requirements for short-term individual, group, blanket, and franchise health insurance policies; revising requirements for, and applicability relating to, association and small employer policies, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Commerce and Tourism; and reported favorably by the Committee on Rules

CS/CS/SB 1460 (SO) by the Committees on Appropriations, Health Policy, Senator Book and others—

Stroke Centers; Revising the criteria for hospitals to be included on the state list of stroke centers by the Agency for Health Care Administration; revising provisions relating to the statewide stroke registry to conform to changes made by the act; revising provisions prohibiting the advertisement of a hospital as a state-listed stroke center, unless certain conditions are met, to conform to changes made by the act, etc. Effective Date: 07/01/2019

Reported favorably as a committee substitute by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations
