#### **CS/SB 1622 (3R) by the Committee on Children, Families, and Elder Affairs and Senator Montford—**

**Public Records/Foster Parent and Foster Parent Applicant Names;** Providing an exemption from public records requirements for the names of foster parent applicants and licensed foster parents, and the names of the spouses, minor children, and adult household members of such applicants and foster parents, which are held by the Department of Children and Families; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2019

*Similar to CS/CS/HB 1249(HC) in the Committees on Children, Families, and Elder Affairs; Governmental Oversight and Accountability; and Rules*

#### **CS/CS/HB 95 (3R) by the Committees on State Affairs Committee, Agriculture and Natural Resources Subcommittee, Representative Jacobs and others—**

**C-51 Reservoir Project;** Revises portions of C-51 reservoir project for which South Florida Water Management District may negotiate; revises water storage & use requirements for project; specifies funding sources for Phase II of project; authorizes district to enter into certain agreements & request waiver for certain loan repayment; authorizes DEP to waive loan repayment under certain conditions. Effective Date: 07/01/2019

*Substituted for CS/CS/SB 92(SUB) (Book), read the second time, and amended on April 29, 2019*

#### **CS/HB 411, 1st Eng. (3R) by the Committee on Health Market Reform Subcommittee and Representative Perez—**

**Nonemergency Medical Transportation Services;** Authorizes certain nonemergency medical transportation services to be provided to Medicaid recipient by certain transportation network companies; requires AHCA to update Florida Medicaid Non-Emergency Transportation Services Coverage Policy & other regulations by certain date; specifies requirements for transportation network companies & transportation network company drivers. Effective Date: 07/01/2019

*Substituted for CS/CS/SB 302(SUB) (Brandes), read the second time, and amended on April 29, 2019*

#### **CS/CS/HB 547 (3R) by the Committees on Education Committee, Higher Education and Career Readiness Subcommittee, Representative Clemons and others—**

**Stanley G. Tate Florida Prepaid College Program;** Authorizes transfer of fees associated with dormitory residency to approved qualified nonprofit organizations; prohibits transferred fees from exceeding specified amount; revises membership of a certain direct-support organization's board of directors. Effective Date: 07/01/2019

*Substituted for CS/CS/SB 464(SUB) (Flores) and read the second time on April 29, 2019*

**CS/CS/HB 441 (3R) by the Committees on Commerce Committee, Energy and Utilities Subcommittee, Representatives DuBose, Toledo and others—**

**E911 Systems;** Requires counties to develop & implement plan for text-to-911 system; requires DMS to develop plan to upgrade 911 public safety answer points to allow transfer of emergency calls; requires each sheriff to enter into specified written agreements regarding PSAPs; requires each PSAP to broadcast emergency communications & public safety information; requires county sheriff to certify compliance in writing with FDLE by specified date. Effective Date: 07/01/2019

*Substituted for CS/CS/SB 536(SUB) (Brandes) and read the second time on April 29, 2019*

**CS/CS/HB 451, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Health Quality Subcommittee, Representative Plakon and others—**

**Nonopioid Alternatives;** Requires DOH to develop & publish on its website educational pamphlet regarding use of nonopioid alternatives for treatment of pain; provides requirements for health care practitioners. Effective Date: 07/01/2019

*Substituted for CS/SB 630(SUB) (Perry) and read the second time on April 29, 2019*

---

**CS/CS/HB 427 (3R) by the Committees on State Affairs Committee, Local, Federal and Veterans Affairs Subcommittee, Representative Gregory and others—**

**Honor and Remember Flag;** Designates Honor & Remember flag as state emblem; authorizes display of flag at specified locations, on specified days, & in specified manner; requires flags to be manufactured in U.S.; provides for adoption of certain regulations. Effective Date: 01/01/2020

*Substituted for CS/SB 718(SUB) (Gruters) and read the second time on April 29, 2019*

---

**CS/HB 487 (3R) by the Committee on Criminal Justice Subcommittee, Representatives Smith, D., Gottlieb and others—**

**Carrying of Firearms by Tactical Medical Professionals;** Exempts certain licensed medical professionals from specified provisions concerning carrying of firearms; requires certain policies & procedures for law enforcement agencies; provides such professionals have no duty to retreat in certain circumstances; provides limitation on liability. Effective Date: 07/01/2019

*Substituted for CS/CS/SB 722(SUB) (Hooper), read the second time, and amended on April 29, 2019*

**CS/CS/HB 437 (3R) by the Committees on State Affairs Committee, Local, Federal and Veterans Affairs Subcommittee and Representative Buchanan—**

**Community Development Districts;** Authorizes certain lands within county or municipality which petitioner anticipates adding to a new community development district to be identified in petition to establish new district; provides detailed procedures for amending boundaries of a district to add land; authorizes community development districts to merge with another type of special district created by special act or by filing petition for establishment of new district; authorizes community development district merging with another type of district to enter into merger agreements for certain purposes. Effective Date: Upon becoming a law

*Substituted for CS/SB 728(SUB) (Lee) and read the second time on April 29, 2019*

**CS/CS/CS/HB 431, 1st Eng. (3R) by the Committees on Judiciary Committee, Transportation and Infrastructure Subcommittee, Civil Justice Subcommittee and Representative Fischer—**

**Liens Against Motor Vehicles and Vessels;** Authorizes person claiming lien against motor vehicle to obtain release of vehicle from lien claimed by motor vehicle repair shop; prohibits repair shop from violating certain provisions; revises notice requirements for enforcing lien by sale of motor vehicle; revises requirements for notice of lien & notice of sale; requires lienor to make motor vehicle available for inspection; revises requirements for transfer of title; authorizes lienor to charge administrative fee; revises requirements for notice of lien for recovering, towing, or storing vehicle or vessel; revises requirements for notice of sale; revises requirements for transfer of title; requires certain entities to use third-party service to provide notices. Effective Date: 01/01/2020

**CS/CS/HB 771, 1st Eng. (3R) by the Committees on State Affairs Committee, Local, Federal and Veterans Affairs Subcommittee, Representative Overdorf and others—**

**Environmental Regulation;** Requires counties & municipalities to address contamination of recyclable material in specified contracts; prohibits counties & municipalities from requiring collection or transport of contaminated recyclable material by residential recycling collectors; specifies required contract provisions; prohibits local governments from requiring certain project verification from DEP; revises types of dock & pier replacements & repairs that are exempt from verification & certain permitting requirements; prohibits local government entities from adopting or enforcing ordinances & regulations relating to single-use plastic straws; provides for lift of moratorium. Effective Date: 07/01/2019

**CS/CS/HB 1009, 1st Eng. (3R) by the Committees on Judiciary Committee, Civil Justice Subcommittee and Representative Byrd—**

**Business Organizations;** Amends requirements relating to entities under Florida Business Corporation Act, Florida Revised Limited Liability Company Act; & corporations not for profit, & limited partnership laws. Effective Date: 01/01/2020

**CS/HB 845 (3R) by the Committee on Oversight, Transparency and Public Management Subcommittee, Representatives Hage and Andrade—**

**Pub. Rec./ Petition for Certain Protective Injunctions;** Provides exemption from public records requirements for information used to identify petitioner or respondent in petition for certain protective injunctions, & any related affidavit, notice of hearing, & temporary injunction, until respondent has been personally served; provides statement of public necessity. Effective Date: 07/01/2019

*Substituted for **CS/SB 980(SUB)** (Harrell) and read the second time on April 29, 2019*

**CS/HB 563, 1st Eng. (3R) by the Committee on Commerce Committee, Representative Joseph and others—**

**Unemployment Compensation;** Prohibits certain victims of domestic violence from being disqualified for benefits; prohibits employment records of employing units & employers from being charged in certain circumstances. Effective Date: 07/01/2019

*Substituted for **CS/SB 990(SUB)** (Gibson) and read the second time on April 29, 2019*

**CS/CS/HB 593 (3R) by the Committees on Education Committee, Higher Education Appropriations Subcommittee, Representative Trumbull and others—**

**Postsecondary Fee Waivers;** Authorizes certain Florida College System institutions serving counties directly impacted by hurricane to waive out-of-state fees for students for specified time period; provides reporting requirements; provides that students enrolled under such fee waivers may not be included in certain enrollment totals. Effective Date: 07/01/2019

**CS/HB 1209 (3R) by the Committee on Children, Families and Seniors Subcommittee, Representative Buchanan and others—**

**Caregivers for Children in Out-of-Home Care;** Establishes goals for DCF relating to caregivers; provides responsibilities of department; provides for dispute resolution. Effective Date: 07/01/2019

*Substituted for **CS/CS/SB 1432(SUB)** (Baxley) and read the second time on April 29, 2019*

---

**CS/SB 1618, 1st Eng. (3R) by the Committee on Innovation, Industry, and Technology, Senator Simmons and others—**

**Tobacco and Nicotine Products;** Citing this act as the "Tobacco 21 Act"; preempting the establishment of the minimum age for the sale or delivery of tobacco products, nicotine products, or nicotine dispensing devices to the state; revising the age under which it is unlawful to smoke in, on, or near school property; defining the terms "the minimum age for purchase" and "any person under the minimum age for purchase"; providing that it is unlawful to sell or deliver tobacco products to persons under the minimum age for purchase, etc. Effective Date: 10/01/2019

**CS/HB 7099 (3R) by the Committees on Health and Human Services Committee, Children, Families and Seniors Subcommittee and Representative Stevenson—**

**Child Welfare;** Revises provisions relating to extended foster care & licensure of family foster homes & certain child-caring & child-placing agencies; revises certain court requirements relating to proceedings for dependent children; authorizes psychiatric nurses to prescribe psychotropic medications to certain children; revises membership of Children & Youth Cabinet; directs department to establish direct-support organization; provides responsibilities, requirements, membership, & term limits of such organization; provides for repeal of organization by specified date; revises eligibility for & termination of certain funding and exemptions. Effective Date: 07/01/2019

**HB 7001 (3R) by the Committee on Oversight, Transparency and Public Management Subcommittee and Representative Aloupis—**

**OGSR/State University DSO Research Funding;** Removes scheduled repeal of exemption relating to exemption from public meeting requirements for portions of certain state university DSO meetings at which proposal seeking research funding or plan for initiating or supporting research is discussed. Effective Date: 10/01/2019

**CS/SB 7024 (3R) by the Committees on Appropriations, and Environment and Natural Resources (Montford)—**

**Department of Environmental Protection Citizen Support Organizations;** Requiring the department to submit a report to the Legislature by a specified date; abrogating the scheduled repeal of provisions governing citizen support organizations established under the department; abrogating the scheduled repeal of provisions governing citizen support organizations established under the department for the benefit of the state park system, etc. Effective Date: 07/01/2019

**HB 7011 (3R) by the Committee on Oversight, Transparency and Public Management Subcommittee and Representative Daniels—**

**OGSR/Division of Emergency Management;** Removes scheduled repeal of exemption from public meeting requirements for information provided to DEM for purpose of being provided assistance with emergency planning. Effective Date: 10/01/2019

*Substituted for **SB 7032(SUB)** (Lee) and read the second time on April 29, 2019*

---

**HB 7059 (3R) by the Committee on Oversight, Transparency and Public Management Subcommittee and Representative Yarborough—**

**OGSR/Concealed Carry License/DACS;** Removes scheduled repeal of exemption from public records requirements for certain personal identifying information held by tax collector when individual applies for license to carry concealed weapon or firearm. Effective Date: 10/01/2019

**CS/HB 7107 (3R) by the Committees on Judiciary Committee, Criminal Justice Subcommittee and Representative Sabatini—**

**Controlled Substances;** Schedules certain drug product containing cannabidiol to Schedule V. Effective Date: Upon becoming a law

**CS/CS/CS/HB 1393, 1st Eng. (3R) by the Committees on Commerce Committee, Government Operations and Technology Appropriations Subcommittee, Insurance and Banking Subcommittee, Representative Clemons and others—**

**Department of Financial Services;** Revises requirements for cemetery companies licenses, combination funeral director & embalmer internships, funeral establishments, embalming facilities, disposition of proceeds from preneed contracts, preneed contracts, direct disposal establishments, & cinerator facilities; requires preneed licensees to provide certain persons with written notice of intent to distribute funds under preneed contract; revises requirements for nonrenewable temporary license, lines insurance licenses, & nonresident public adjuster's licenses; authorizes luxury ground transportation network companies to elect to be regulated as transportation network companies; establishes Florida Blockchain Task Force. Effective Date: 07/01/2019

**Support Organizations;** Removing the scheduled repeal of provisions governing citizen support organizations established under the Department of Environmental Protection; removing the scheduled repeal of provisions governing the citizen support organization providing support for the Division of Library and Information Services of the Department of State; extending the scheduled repeal of the provisions governing the citizen support organizations operating to the benefit of the Babcock Ranch Preserve; defining the terms "convicted" and "conviction"; authorizing a court to order persons convicted of certain violations to pay an additional assessment, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

**CS/CS/SB 524 (SO) by the Committees on Appropriations, Banking and Insurance, Senator Diaz and others—**

**Health Insurance;** Authorizing the inclusion in the state group insurance program of products and services offered by entities providing optional participation in the Medicare Advantage Prescription Drug Plan; requiring the Department of Management Services to implement formulary management cost-saving measures beginning with the 2020 plan year; creating the "Patient Savings Act"; authorizing health insurers, which include health maintenance organizations, to offer shared savings incentive programs to insureds, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

**Mobility Devices and Motorized Scooters;** Defining the term "micromobility device"; revising the definition of the term "motorized scooter"; providing that the operator of a motorized scooter or micromobility device has all of the rights and duties applicable to the rider of a bicycle, except the duties imposed by specified provisions that by their nature do not apply; exempting electric personal assistive mobility devices and motorized scooters from certain emblem requirements, etc. Effective Date: Upon becoming a law

**Registered Contractor Licensing;** Extending the date by which an applicant must make application for a license to be grandfathered, etc. Effective Date: 07/01/2019

**County Court Judges;** Revises number of county court judges in certain counties. Effective Date: 07/01/2019

**CS/CS/CS/SB 616 (SO) by the Committees on Rules, Community Affairs, Innovation, Industry, and Technology, Senator Perry and others—**

**Engineering;** Deleting a provision requiring a delinquent status licensee to apply for active or inactive status; revising licensure certification requirements to include active engineering experience and a minimum age; decreasing the amount of time a local building official has to take certain actions after receiving a permit application and affidavit from a private provider, etc. Effective Date: 10/01/2019
