Relief/Robert Allan Smith/Orange County; Provides for appropriation to compensate Robert Allan Smith for injuries sustained as result of negligence of Orange County employee; provides legislative intent regarding lien interests held by state; provides limitation on payment of fees & costs. Effective Date: Upon becoming a law

Child Protection Teams; Revising the definition of the term "officer, employee, or agent," as it applies to immunity from personal liability in certain actions, to include any member of a child protection team established by the Department of Health in certain circumstances, etc. Effective Date: 07/01/2019

CS/CS/HB 409 (3R) by the Committees on Judiciary Committee, Civil Justice Subcommittee, Representatives Perez, Grant, J. and others—

Electronic Legal Documents; Authorizes online notarizations; specifies requirements & standards for performance of such online notarizations; requires DOS to adopt rules by specified date. Effective Date: 01/01/2020

HB 7127 (3R) by the Committee on Ways and Means Committee and Representative Avila—

Corporate Income Tax; Adopts IRC provisions in effect on January 1, 2019; extends period during which specified automatic refunds & downward adjustments to tax rates apply; revises subtractions to be made in calculating taxable income requiring submission of certain corporate tax information to DOR; requires DOR to create secure online application form to allow taxpayers to submit such information; provides deadlines; provides audit & investigation authority; provides for penalty; provides repeal date; authorizes emergency rules; provides appropriation. Effective Date: Upon becoming a law

CS/HB 591 (3R) by the Committee on Energy and Utilities Subcommittee, Representatives Yarborough, Davis and others—

Pub. Rec./Public Utility Held Customer Information and Data; Exempts from public records requirements customer meter-derived data and billing information in increments of less than one billing cycle that is held by certain utilities; provides statement of public necessity. Effective Date: 07/01/2019

CS/CS/HB 673 (3R) by the Committees on Commerce Committee, Insurance and Banking Subcommittee and Representative Fischer—

Insurer Guaranty Associations; Revises membership of Florida Life & Health Insurance Guaranty Association's board; specifies requirements relating to director of Florida Health Maintenance Organization Consumer Assistance Plan to be confirmed to association's board; specifies duties of association as to potential long-term care insurer impairments or insolvencies, sharing information, & providing assistance to plan's board; requires that DFS, rather than receivership court, approve certain alternative policies or contracts; authorizes association's board to file directly for actuarially justified rate or premium increases; specifies calculation & allocation of Class B assessments for long-term care insurance; specifies limit on certain assessments on member insurer or member HMO. Effective Date: Upon becoming a law

Effective Date: 07/01/2019

SB 1616 (SO) by Senator Baxley and others—

Local Government Financial Reporting; Requiring county and municipal budget officers, respectively, to submit certain information to the Office of Economic and Demographic Research within a specified timeframe; requiring adopted budget amendments and final budgets to remain posted on each entity's official website for a specified period of time, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Governmental Oversight and Accountability; and reported favorably by the Committee on Rules

CS/SB 1690 (SO) by the Committee on Banking and Insurance and Senator Broxson—

Warranty Associations; Revising the basis for calculating the required assets in a home warranty association's premium reserve account; requiring that such reserve account be a separate auditable account for contracts in force in this state; prohibiting home warranties from excluding coverage because of the presence of rust or corrosion, except under certain circumstances; revising the basis for calculating the required assets in a service warranty association's premium reserve account, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2019

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Commerce and Tourism reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/CS/CS/SB 1730 (SO) by the Committees on Rules, Infrastructure and Security, Community Affairs and Senator Lee—

Community Development and Housing; Authorizing an inclusionary housing ordinance to require a developer to provide a specified number or percentage of affordable housing units to be included in a development or allow a developer to contribute to a housing fund or other alternatives; requiring that a county review the application for completeness and issue a certain letter within a specified period after receiving an application for approval of a development permit or development order; providing requirements for a comprehensive plan adopted after a specified date and all land development regulations adopted to implement the comprehensive plan, etc. Effective Date: Upon becoming a law

CS/CS/SB 1412 (SO) by the Committees on Appropriations, Commerce and Tourism, Senator Gruters and others—

Taxation; Specifying a requirement for the Department of Revenue in reviewing assessment rolls in certain counties in assessment years following a natural disaster; authorizing the department to use the best information available to estimate levels of assessment; providing sales tax exemptions for specified disaster preparedness supplies during a certain timeframe; providing sales tax exemptions for certain clothing, wallets, bags, school supplies, personal computers, and personal computer-related accessories during a certain timeframe, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2019

Commercial Motor Vehicles; Revising regulations applicable to owners and drivers of commercial motor vehicles; exempting persons who operate a commercial motor vehicle solely in intrastate commerce which does not transport hazardous materials in amounts that require placarding from certain requirements related to electronic logging devices and hours of service supporting documents until a specified date; revising length and load extension limitations for stinger-steered automobile transporters; providing for the calculation of specified fines for vehicles fueled by electric batteries, etc. Effective Date: 10/01/2019

Reported favorably as a committee substitute by the Committee on Infrastructure and Security; the Committee on Commerce and Tourism reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

SB 7072 (SO) by the Committee on Appropriations (Bradley)—

Justice System; Authorizing certain Supreme Court justices to have an appropriate facility in their district of residence designated as their official headquarters; increasing the number of circuit judges in certain judicial circuits; revising the circumstances under which an offense of retail theft constitutes a felony of the second or third degree, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect October 1, 2019

Recommended favorably as a committee substitute by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably by the Committee on Appropriations

CS/CS/SB 7086 (SO) by the Committees on Rules, Judiciary, and Criminal Justice (Perry)—

Voting Rights Restoration; Revising terminology regarding voting rights restoration to conform to the State Constitution; requiring the voting disqualification of certain felons to be removed and voting rights restored pursuant to s. 4, Art. VI of the State Constitution; authorizing the supervisor of elections to verify whether a person who has been convicted of a felony offense is eligible to register to vote, including if he or she has completed all the terms of his or her sentence; prohibiting a person from being charged or convicted for certain violations, etc. Effective Date: Upon becoming a law

SB 72 (2R) by Senator Passidomo and others—

Alligator Alley Toll Road; Requiring specified fees to be used indefinitely, instead of temporarily, to reimburse a local governmental entity for the direct actual costs of operating a specified fire station, etc. Effective Date: 07/01/2019

Reported favorably by the Committee on Infrastructure and Security; recommended favorably by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably by the Committee on Appropriations

CS/SB 114 (2R) by the Committee on Rules, Senator Hutson and others—
