#### BILLS ON THIRD READING

#### CS/CS/HB 221 (3R) by the Committees on Judiciary Committee, Criminal Justice and Public Safety Subcommittee, Representative Sirois and others—

**Recovery of Spaceflight Assets;** Provides spaceflight entity retains ownership of spaceflight asset after launch or upon reentry; requires person who finds item reasonably identifiable as spaceflight asset to report description & location to law enforcement; requires law enforcement to notify owner of spaceflight asset; authorizes owner of spaceflight asset to enter private property; prohibits person from appropriating spaceflight asset to his or her own use or refusing to surrender spaceflight asset to law enforcement or owner; provides criminal penalties. Effective Date: 07/01/2021

Substituted for **CS/SB 936(SUB)** (Wright) and read the second time on April 22, 2021

#### CS/CS/HB 485, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Finance and Facilities Subcommittee, Representatives Garrison, Rayner and others—

Personal Care Attendants; Authorizes nursing home facilities to employ personal care attendants if certain training requirement is met; requires AHCA, in consultation with Board of Nursing, to develop certain training program; provides minimum requirements for such program; provides certain requirements & prohibitions applicable to personal care attendants; authorizes certain persons to be employed by nursing home facility as personal care attendants for specified period if certain training requirement is met; defines "personal care attendants." Effective Date: Upon becoming a law

Substituted for **CS/CS/SB 1132(SUB)** (Bean) and read the second time on April 22, 2021

#### CS/CS/SB 1080, 1st Eng. (3R) by the Committees on Health Policy, Regulated Industries and Senator Hutson—

**Tobacco and Nicotine Products;** Revising age limitations relating to mail order, Internet, and remote sales of tobacco products; providing that it is unlawful for persons under 21 years of age to smoke tobacco or vape in, on, or within 1,000 feet of the real property comprising a public or private elementary, middle, or secondary school during specified hours; preempting the establishment of the minimum age for purchasing and possessing, and the regulation for the marketing, sale, or delivery of, tobacco products to the state; requiring proof of age for certain purchases of tobacco products; requiring retail nicotine product dealers to acquire a permit, etc. Effective Date: 10/01/2021

Read the second time and amended on April 22, 2021

#### CS/CS/CS/SB 90, 1st Eng. (3R) by the Committees on Rules, Governmental Oversight and Accountability, Ethics and Elections and Senator Baxley—

**Election Administration;** Revising requirements for the uniform statewide voter registration application; revising requirements governing the acceptance of voter registration applications; revising requirements for third-party voter registration organizations; requiring a person seeking to qualify for office as a candidate with no party affiliation to subscribe to an oath or affirmation that he or she is registered without party affiliation and has not been a registered member of a political party for a specified timeframe; limiting the duration of requests for vote-by-mail ballots to all elections through the end of the calendar year of the next regularly scheduled general election; specifying applicability, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2021

Read the second time and amended on April 22, 2021

#### CS/CS/CS/HB 337 (3R) by the Committees on State Affairs Committee, Ways and Means Committee, Local Administration and Veterans Affairs Subcommittee, Representative DiCeglie and others—

**Impact Fees;** Requires local governments & special districts to credit against collection of impact fees any contribution related to public facilities or infrastructure; provides conditions under which credits may not be applied; provides limitations on impact fee increases; provides retroactive operation; requires specified entities to submit affidavit attesting that impact fees were appropriately collected & expended; provides retroactive application; requires school districts to report specified information regarding impact fees. Effective Date: Upon becoming a law

Substituted for **CS/CS/CS/SB 750(SUB)** (Gruters) and read the second time on April 22, 2021

#### CS/CS/SB 1786, 1st Eng. (3R) by the Committees on Appropriations, Health Policy, Senator Burgess and others—

Florida Birth-Related Neurological Injury Compensation Plan; Requiring the Florida Birth-Related Neurological Injury Compensation Association to administer the Florida Birth-Related Neurological Injury Compensation Plan in a specified manner; revising requirements for the award for compensation for claims under the plan; increasing the maximum amount that may be awarded to the parents or legal guardians of an infant found to have sustained a birth-related neurological injury, as of a specified date; requiring association employees to annually sign and submit a conflict-of-interest statement as a condition of employment, etc. Effective Date: Upon becoming a law

Read the second time and amended on April 22, 2021

#### CS/CS/SB 566 (3R) by the Committees on Appropriations, Banking and Insurance and Senator Perry—

**Motor Vehicle Rentals;** Specifying the applicable sales tax rate on motor vehicle leases and rentals by motor vehicle rental companies and peer-to-peer car-sharing programs; specifying applicability of the surcharge; requiring motor vehicle rental companies to collect specified surcharges; specifying the applicable rental car surcharge on peer-to-peer car-sharing program agreements involving shared vehicles; specifying motor vehicle insurance requirements for peer-to-peer car-sharing programs, etc. Effective Date: 01/01/2022

Read the second time on April 22, 2021

#### CS/SB 1944 (3R) by the Committee on Appropriations and Senator Albritton—

Utility and Communications Poles; Exempting certain rules adopted by the Public Service Commission from legislative ratification requirements; requiring the commission to regulate and enforce rates, charges, terms, and conditions for pole attachments under certain circumstances; providing situations under which a pole owner may deny access to the owner's pole on a nondiscriminatory basis; requiring the commission to hear and resolve complaints concerning rates, charges, terms, conditions, voluntary agreements, and denial of access relative to pole attachments; requiring the commission by rule to create a process requiring advance hardening project notice, etc. Effective Date: Upon becoming a law

Read the second time on April 22, 2021

#### CS/CS/HB 839 (3R) by the Committees on Local Administration and Veterans Affairs Subcommittee, Tourism, Infrastructure and Energy Subcommittee, Representative Fabricio and others—

Express Preemption of Fuel Retailers and Related Transportation Infrastructure; Prohibits municipality, county, special district, or political subdivision from taking certain actions to prohibit siting, development, or redevelopment of fuel retailers & related transportation infrastructure & from requiring fuel retailers to install or invest in particular fueling infrastructure. Effective Date: Upon becoming a law

Substituted for **CS/CS/SB 856(SUB)** (Hutson) and read the second time on April 22, 2021

#### SB 7072 (3R) by the Committee on Governmental Oversight and Accountability (Rodrigues)—

**Social Media Platforms;** Prohibiting a social media platform from knowingly deplatforming a candidate; providing requirements for public contracts and economic incentives related to entities that have been convicted or held civilly liable for antitrust violations; providing that social media platforms that fail to comply with specified requirements and prohibitions commit an unfair or deceptive act or practice; authorizing the Department of Legal Affairs to investigate suspected violations under the Deceptive and Unfair Trade Practices Act and bring specified actions for such violations, etc. Effective Date: 07/01/2021

Read the second time on April 22, 2021

#### SB 7074 (3R) by the Committee on Governmental Oversight and Accountability (Rodrigues)—

Public Records/Social Media Platform Activities; Providing a public records exemption for information received by the Attorney General pursuant to an investigation by the Attorney General or a law enforcement agency into certain social media platform activities; providing a public records exemption for information received by the Department of Legal Affairs pursuant to an investigation by the department or a law enforcement agency into violations by certain social media platforms; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: July 1, 2021, if SB 7072 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

#### CS/CS/SB 1028, 1st Eng. (3R) by the Committees on Appropriations, Education, Senator Hutson and others—

**Charter Schools;** Providing that the limitation on lab schools does not apply to a school serving a military installation; authorizing state universities and Florida College System institutions to solicit applications and sponsor charter schools under certain circumstances; revising provisions relating to Florida College System institutions that are operating charter schools; revising requirements for a charter school to be a high-performing charter school, etc. Effective Date: 07/01/2021

Read the second time and amended on April 22, 2021

# CS/CS/SB 896, 1st Eng. (3R) by the Committees on Rules, Regulated Industries, Senator Brodeur and others—

**Renewable Energy;** Defining the term "solar facility"; providing that solar facilities are a permitted use in local government comprehensive plan agricultural land use categories and certain agricultural zoning districts; authorizing the Florida Public Service Commission to approve cost recovery by a gas public utility for certain contracts for the purchase of renewable natural gas, etc. Effective Date: 07/01/2021

Read the second time and amended on April 22, 2021

#### CS/CS/HB 919 (3R) by the Committees on Commerce Committee, Tourism, Infrastructure and Energy Subcommittee, Representative Tomkow and others—

**Preemption Over Restriction of Utility Services;** Prohibits municipalities, counties, special districts, or other political subdivisions from restricting or prohibiting types or fuel sources of energy production used, delivered, converted, or supplied by certain entities to customers; voids existing specified documents & policies that are preempted by this act. Effective Date: 07/01/2021

Substituted for **CS/CS/CS/SB 1128(SUB)** (Hutson) and read the second time on April 22, 2021

#### CS/HB 7045, 1st Eng. (3R) by the Committees on Appropriations Committee, Education and Employment Committee, Representatives Fine, Fischer and others—

School Choice; Revises student eligibility requirements under Family Empowerment Scholarship program to include students with disabilities; revises provisions related to calculation of maximum amount of scholarship funds granted to a student with disabilities; revises provisions related to funding and payment of scholarships awarded under program; providing requirements for use of funds under program; revising program administration obligations; repeals Gardiner Scholarship Program; provides for future repeal of John M. McKay Scholarships for Students with Disabilities Program; providing certain students with disabilities are eligible for enrollment in transition-to-work programs; revising amount of eligible contributions used for administrative expenses by an eligible nonprofit scholarship-funding organization under Florida Tax Credit Scholarship Program. Effective Date: 07/01/2021

Substituted for **CS/CS/SB 48(SUB)** (Diaz) and read the second time on April 22, 2021

#### CS/CS/HB 401 (3R) by the Committees on Commerce Committee, Regulatory Reform Subcommittee, Representatives Fetterhoff, Overdorf and others—

Florida Building Code; Authorizes substantially affected person to file petition with Florida Building Commission to review local government regulations; provides requirements for such petition; provides requirements for commission when considering petition; requires commission to issue nonbinding advisory opinion within specified timeframe; authorizes commission to issue errata to code; prohibits local government from requiring certain contracts for issuance of building permit; authorizes certain local entities to use private providers under certain circumstances; revises how certain excess funds may be used by local government; requires evaluation entities that meet certain criteria to comply with certain standards; authorizing commission to suspend or revoke certain approvals under certain circumstances. Effective Date: 07/01/2021

Substituted for CS/CS/CS/SB 1146(SUB) (Brodeur), read the second time, and amended on April 22, 2021

#### SB 1884 (3R) by Senator Rodrigues-

**Preemption of Firearms and Ammunition Regulation;** Providing that written or unwritten policies are subject to provisions allowing for recovery of damages if such policies violate specified provisions; providing that a plaintiff challenging a local government regulation concerning firearms is considered a prevailing plaintiff for certain purposes in specified circumstances, etc. Effective Date: 07/01/2021

Read the second time on April 22, 2021

#### SPECIAL ORDER CALENDAR FOR MONDAY, APRIL 26, 2021

#### CS/CS/SB 938 (SO) by the Committees on Appropriations, Education and Senator Wright—

**Purple Star Campuses**; Requiring the Department of Education to establish the Purple Star Campus program; specifying program criteria for participating schools; authorizing schools to partner with school districts to meet such criteria, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Education; the Committee on Military and Veterans Affairs, Space, and Domestic Security reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

#### CS/SB 1482 (SO) by the Committee on Appropriations, Senator Garcia and others—

**Biscayne Bay;** Establishing the Biscayne Bay Commission; providing for commission purpose, membership, duties, and authority; prohibiting sewage disposal facilities from disposing of any wastes into Biscayne Bay without providing advanced waste treatment, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Environment and Natural Resources; recommended favorably as a committee substitute by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations

Identical to CS/HB 1177, 1st Eng.(HC) in the Committee on Appropriations

# CS/SB 1282 (SO) by the Committee on Appropriations and Senator Harrell—

**Early Learning and Early Grade Success**; Revising approved child care or early education settings for the placement of certain children; providing for a type two transfer of the Gold Seal Quality Care program in the Department of Children and Families to the Office of Early Learning; revising the performance standards for the Voluntary Prekindergarten Education Program; authorizing certain students enrolled in the Voluntary Prekindergarten Education Program to receive intensive reading interventions using specified funds, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Education; recommended favorably as a committee substitute by Appropriations Subcommittee on Education; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to **CS/CS/HB 419, 2nd Eng.(HC)** in the Committee on Appropriations

#### CS/CS/SB 414 (SO) by the Committees on Appropriations, Children, Families, and Elder Affairs, Senator Perry and others—

**Economic Self-sufficiency;** Requiring an early learning coalition to give priority for participation in a school readiness program to certain children; requiring the Office of Early Learning within the Department of Education to coordinate with the University of Florida Anita Zucker Center for Excellence in Early Childhood Studies to conduct an analysis of certain assistance programs, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; Appropriations Subcommittee on Health and Human Services recommends the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

Identical to CS/CS/HB 1349(HC) in the Committee on Appropriations

#### SB 280 (SO) by Senator Baxley and others-

**Cardiopulmonary Resuscitation Training in Public Schools;** Providing that school districts are encouraged to provide basic training in first aid, including cardiopulmonary resuscitation, in specified grades; requiring school districts to provide basic training in first aid, including cardiopulmonary resuscitation, in specified grades; revising requirements for instruction in cardiopulmonary resuscitation, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Education; recommended favorably by Appropriations Subcommittee on Education; and reported favorably by the Committee on Appropriations

#### CS/CS/SB 368 (SO) by the Committees on Appropriations, Judiciary and Senator Baxley—

**Elder-focused Dispute Resolution Process;** Authorizing the courts to appoint an eldercaring coordinator and refer certain parties and elders to eldercaring coordination; prohibiting the courts from referring certain parties to eldercaring coordination without the consent of the elder and other parties to the action; requiring the courts to conduct intermittent review hearings regarding the conclusion or extension of such appointments; requiring prospective eldercaring coordinators to submit fingerprints for purposes of criminal history background screening; requiring that notice of hearing on removal of a coordinator be timely served, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to **CS/CS/HB 441, 1st Eng.(HC)** in the Committee on Appropriations

#### SJR 1182 (SO) by Senator Brandes—

#### Limitation on the Assessment of Real Property/Residential

**Purposes;** Proposing amendments to the State Constitution, effective January 1, 2023, to authorize the Legislature, by general law, to prohibit the consideration of any change or improvement made to real property used for residential purposes to improve the property's resistance to flood damage in determining the assessed value of such property for ad valorem taxation purposes, etc.

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Finance and Tax; and reported favorably by the Committee on Appropriations

Identical to HJR 1377(HC) in the Committee on Appropriations

#### CS/CS/CS/SB 1186 (SO) by the Committees on Appropriations, Finance and Tax, Community Affairs and Senator Brandes—

**Property Assessments for Elevated Properties**; Specifying that changes to elevate certain homestead and nonhomestead residential property, respectively, do not increase the assessed value of the property; requiring property owners to provide certification for such property; prohibiting certain areas from being included in square footage calculation, etc. Effective Date: On the effective date of the amendment to the State Constitution proposed by SJR 1182 or a similar joint resolution having substantially the same specific intent and purpose, if such amendment to the State Constitution is approved at the general election held in November 2022 or at an earlier special election specifically authorized by law for that purpose

Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Finance and Tax; and reported favorably as a committee substitute by the Committee on Appropriations

Identical to CS/CS/HB 1379(HC) in the Committee on Appropriations

#### CS/CS/SB 1530 (SO) by the Committees on Appropriations, Criminal Justice and Senator Book—

Victims of Sexual Offenses; Requiring counties to establish sexual assault response teams; requiring the Criminal Justice Standards and Training Commission, in consultation with the Florida Council Against Sexual Violence, to establish minimum standards for basic and advanced career development training programs for law enforcement officers that include a culturally responsive trauma-informed response to sexual assault; requiring the Criminal Justice Standards and Training Commission to incorporate a culturally responsive trauma-informed response to sexual assault into a certain course curriculum, etc. Effective Date: 07/01/2021

Reported favorably as a committee substitute by the Committee on Criminal Justice; recommended favorably as a committee substitute by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Appropriations

#### CS/SB 1976 (SO) by the Committee on Appropriations and Senator Brodeur—

**Freestanding Emergency Departments**; Deleting an obsolete provision relating to a prohibition on new emergency departments located off the premises of licensed hospitals; prohibiting a freestanding emergency department from holding itself out to the public as an urgent care center; requiring a freestanding emergency department to clearly identify itself as a hospital emergency department using certain signage; requiring a freestanding emergency department to post signs in certain locations which contain specified statements, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to CS/HB 1157, 1st Eng.(HC) in the Committee on Appropriations

#### HB 1359, 1st Eng. (SO) by Representative Brannan-

**Pub. Rec./Department of Highway Safety and Motor Vehicles;** Provides exemption from public records requirements for information received by DHSMV as result of investigation or examination conducted pursuant to certain provisions; authorizes DHSMV to release such information under certain circumstances; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: On the same date that CS/HB 1151 or similar legislation takes effect

Reported favorably by the Committee on Appropriations

#### SB 586 (SO) by Senator Wright and others-

Veterans Employment and Training; Directing Florida Is For Veterans, Inc., to serve as the state's principal assistance organization under the United States Department of Defense's SkillBridge program; prescribing duties of the corporation to facilitate the administration of the SkillBridge program, etc. Effective Date: 07/01/2021

Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; reported favorably by the Committee on Commerce and Tourism; and reported favorably by the Committee on Appropriations

Identical to HB 435(HC) in the Committee on Appropriations

#### CS/CS/SB 894 (SO) by the Committees on Appropriations, Health Policy and Senator Diaz—

**Physician Assistants**; Deleting a limitation on the number of physician assistants a physician may supervise at one time; deleting a requirement that a physician assistant inform his or her patients that they have the right to see a physician before the physician assistant prescribes or dispenses a prescription; authorizing physician assistants to procure drugs and medical devices; authorizing physician assistants to bill for and receive direct payment for services they deliver, etc. Effective Date: 07/01/2021
