SB 1402, 1st Eng. (3R) by Senator Burgess-

Domestic Surplus Lines Insurers; Providing that specified nonadmitted insurers are eligible to transact insurance as domestic surplus lines insurers under certain circumstances; requiring domestic surplus lines insurers to maintain a minimum surplus amount; authorizing domestic surplus lines insurers to write only surplus lines insurance under a specified circumstance; prohibiting such insurers from simultaneously holding any certificate of authority to operate as admitted insurers; providing exemptions from specified requirements for surplus lines insurance policies issued by such insurers, etc. Effective Date: 07/01/2022

Read the second time and amended on March 2, 2022

CS/HB 5 (3R) by the Committee on Health Care Appropriations Subcommittee, Representatives Grall, Persons-Mulicka and others—

Reducing Fetal and Infant Mortality; Revises purpose & requirements for Comprehensive Statewide Tobacco Education & Use Prevention Program; requires DOH to contract with local healthy start coalitions for creation of fetal & infant mortality review committees; prohibits physician from performing abortion if gestational age of fetus is determined to be more than specified number of weeks; provides exception; requires directors of certain medical facilities & certain physicians to submit monthly report to AHCA electronically; requires hospitals participate in minimum number of quality improvement initiatives. Effective Date: 07/01/2022

CS/SB 1808, 1st Eng. (3R) by the Committee on Appropriations, Senator Bean and others—

Immigration Enforcement; Revising the type of data required to be reported by the clerk of the court, county detention facilities, and the Department of Corrections as part of criminal justice data collection; revising the definition of the term "sanctuary policy" to include specified laws, policies, practices, procedures, or customs that limit or prohibit a law enforcement agency from providing specified immigration information to a state entity; requiring each law enforcement agency operating a county detention facility to enter into a specified agreement with the United States Immigration and Customs Enforcement to assist with immigration enforcement; prohibiting a governmental entity from executing, amending, or renewing a contract with common carriers or contracted carriers under certain circumstances, etc. Effective Date: Upon becoming a law

Limitations on Political Contributions; Defining the term "foreign national"; providing that a foreign national may not make or offer to make certain contributions or expenditures, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Ethics and Elections; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 921(HC) in the Committee on Rules

SB 144 (SO) by Senator Hutson—

Identification Cards; Requiring the Department of Highway Safety and Motor Vehicles to issue or renew identification cards at no charge to persons presenting a valid voter's registration card and attesting to financial hardship; prohibiting the department from requiring such persons to present certain evidence; requiring the department to issue identification cards at no charge to certain other persons, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Transportation; and reported favorably by the Committee on Appropriations

CS/CS/SB 1800 (SO) by the Committees on Appropriations, Commerce and Tourism, Senator Boyd and others—

Broadband Infrastructure; Revising the duties of the Florida Office of Broadband to include administering the Broadband Pole Replacement Program; establishing the Broadband Pole Replacement Program within the office; providing that certain denied applicants may reapply in certain circumstances; requiring the office to provide certain reimbursements within a certain period of time, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1802 (SO) by the Committees on Appropriations, Commerce and Tourism and Senator Boyd—

Broadband Pole Replacement Trust Fund; Creating the trust fund within the Department of Economic Opportunity; providing the purpose of the trust fund; providing that moneys credited to the trust fund shall consist of certain funds; requiring that certain funds in the trust fund be used in a manner consistent with federal law or grant agreement for use of the funds; providing that the balance in the trust fund at the end of a fiscal year remains in the trust fund and is available for carrying out the purposes of the trust fund; providing for future legislative review and termination or re-creation of the trust fund, etc. Effective Date: On the same date that SB 1800 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

SB 1476 (SO) by Senator Wright—

Prescription Drug Coverage; Authorizing the Office of Insurance Regulation to examine pharmacy benefit managers; providing a penalty for failure to register as a pharmacy benefit manager under certain circumstances; revising the entities conducting pharmacy audits to which certain requirements and restrictions apply; providing that health insurers and health maintenance organizations that transfer a certain payment obligation to pharmacy benefit managers remain responsible for specified violations, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Banking and Insurance; recommended favorably by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably by the Committee on Appropriations

Similar to HB 357(HC) in the Committee on Appropriations

CS/CS/SB 524 (SO) by the Committees on Appropriations, Ethics and Elections and Senator Hutson—

Election Administration; Requiring the Secretary of State to notify the Attorney General if signatures required for an initiative petition are no longer valid; creating the Office of Election Crimes and Security within the Department of State; revising the frequency with which supervisors of elections must conduct a registration list maintenance program; authorizing the Department of State to identify deceased registered voters using information received by the Department of Highway Safety and Motor Vehicles; requiring specified individuals observing the ballot duplication process to sign a specified affidavit acknowledging certain criminal penalties, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

Reported favorably as a committee substitute by the Committee on Ethics and Elections; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 190 (SO) by the Committees on Criminal Justice, Judiciary and Senator Brodeur—

Controlled Substances; Revising the elements that constitute the capital offense of murder in the first degree; revising the elements that constitute the felony offense of murder in the third degree; prohibiting specified activities involving controlled substances within 1,000 feet of additional specified facilities; providing criminal penalties, etc. Effective Date: 10/01/2022

Reported favorably as a committee substitute by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Rules reports the committee substitute favorably

Similar to CS/HB 95(HC) in the Committee on Rules

CS/CS/SB 1262 (SO) by the Committees on Appropriations, Children, Families, and Elder Affairs, Senator Burgess and others—

Mental Health and Substance Abuse; Authorizing emergency contact information to be released to certain entities; revising the conditions under which a patient's communication with persons outside of a receiving facility may be restricted; requiring a receiving facility to notify specified emergency contacts of individuals who are being involuntarily held for examination; requiring receiving facilities to document that an option to authorize the release of specified information has been provided, within a specified timeframe, to individuals admitted on a voluntary basis; requiring that reports issued by law enforcement officers when delivering a person to a receiving facility contain certain information related to emergency contacts, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1382 (SO) by the Committees on Appropriations, Finance and Tax and Senator Gruters—

Tax Administration; Prohibiting taxpayers from submitting certain records in tax proceedings under certain circumstances; authorizing the Department of Revenue to respond to contact initiated by taxpayers to discuss audits; authorizing taxpayers to provide records and other information to the department; clarifying conditions for application of an exemption for sales taxes for certain nonresident purchasers of boats or aircraft; prohibiting transferors from accepting orders from or delivering alcoholic beverages to dealers with suspended resale certificates within a specified timeframe; revising the period in which, and conditions under which, the executive director of the department may adopt emergency rules, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Finance and Tax; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1426 (SO) by the Committees on Appropriations, Environment and Natural Resources and Senator Burgess—

Environmental Management; Providing for water quality enhancement areas; requiring the Department of Environmental Protection to establish water quality enhancement service areas; requiring the department and water management districts to authorize the sale and use of enhancement credits to governmental entities to address certain adverse water quality impacts and to meet certain water quality requirements; revising the conditions that a developer or homebuilder must certify it meets as part of its application for development approval or amendment of a development order, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; recommended favorably as a committee substitute by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 1048 (SO) by the Committee on Appropriations, Senator Diaz and others—

Student Assessments; Renaming "Next Generation Sunshine State Standards" as "state academic standards"; deleting provisions relating to the coordinated screening and progress monitoring program; providing that certain end-of-year comprehensive progress monitoring assessments are the statewide, standardized ELA and Mathematics assessments for certain students; requiring the coordinated screening and progress monitoring system to identify the educational strengths and needs of students; requiring 2022-2023 school and school district grades to serve as an informal baseline for schools and school districts; providing that school improvement ratings will not be calculated for the 2022-2023 school year, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Education; recommended favorably by Appropriations Subcommittee on Education; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 758 (SO) by the Committees on Appropriations, Education and Senator Diaz—

Education; Establishing the Charter School Review Commission within the Department of Education; requiring the Commissioner of Education to appoint members; authorizing the commission to solicit and review charter school applications; requiring that the district school board that oversees the school district where a charter school approved by the commission will be located shall serve as the charter school's sponsor, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Education; recommended favorably as a committee substitute by Appropriations Subcommittee on Education; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 752 (SO) by the Committees on Appropriations, Criminal Justice, Senator Gainer and others—

Probationary or Supervision Services for Misdemeanor Offenders; Authorizing the Department of Corrections to supervise certain misdemeanor offenders; deleting a prohibition on private entities providing probationary or supervision services to certain misdemeanor offenders; requiring the department to reduce a probationer's or offender's supervision term by a specified amount of time for completing an educational advancement activity; authorizing a private or public entity to provide probation services and other specified programming to misdemeanor offenders; revising who may approve specified contracts, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Criminal Justice; recommended favorably as a committee substitute by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 802 (SO) by the Committee on Appropriations, Senator Gruters and others—

School Safety; Extending the sunset date of the Marjory Stoneman Douglas High School Public Safety Commission; requiring the FortifyFL reporting tool to notify reporting parties that submitting false information may subject them to criminal penalties; requiring the Commissioner of Education to oversee and enforce compliance with requirements relating to school safety and security; requiring certain law enforcement officers to be physically present and directly involved in active assailant emergency drills, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect July 1, 2022

Reported favorably by the Committee on Education; recommended favorably as a committee substitute by Appropriations Subcommittee on Education; and reported favorably as a committee substitute by the Committee on Appropriations

Similar to CS/CS/CS/HB 1421(HC) in the Committee on Appropriations

CS/CS/SB 466 (SO) by the Committees on Appropriations, Health Policy, Senator Torres and others—

Military Corpsmen and Medics of Florida (MCMF) Program; Creating the MCMF Program Office of Veterans Advocacy within the Department of Health; requiring the MCMF Program, through the Department of Economic Opportunity, to assist certain veterans and their spouses with specified tasks; requiring Florida Is for Veterans, Inc., to collaborate with specified entities to implement the MCMF Program, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Health Policy; the Committee on Military and Veterans Affairs, Space, and Domestic Security reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

SB 360 (SO) by Senator Harrell—

Traveling Across County Lines to Commit a Burglary; Deleting a requirement that travel across county lines be for a specified purpose in order to reclassify a burglary offense, etc. Effective Date: 10/01/2022

Reported favorably by the Committee on Criminal Justice; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

Identical to HB 6037(HC) in the Committee on Rules

CS/CS/SB 804 (SO) by the Committees on Rules, Health Policy and Senator Albritton—

Nursing Homes; Specifying functions that do not constitute direct care staffing hours for purposes of required nursing home staffing ratios; revising nursing home staffing requirements; providing that eating assistance to residents provided by certain direct care staff counts toward certain minimum direct care staffing requirements; providing that an unsatisfied or undischarged adverse final judgment in connection with a nursing home facility becomes the responsibility and liability of a new owner if ownership of the facility is transferred, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Health Policy; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 768 (SO) by the Committees on Appropriations, Health Policy and Senator Rodriguez—

Department of Health; Revising the purpose of the department's targeted outreach program for certain pregnant women; requiring the department to encourage high-risk pregnant women of unknown status to be tested for sexually transmissible diseases; removing the Children's Medical Services office from parties required to coordinate in the development of local emergency management plans for special needs shelters; deleting a requirement that certain nursing program graduates complete a specified preparatory course; defining the terms "doctoral degree from an American Psychological Association accredited program" and "doctoral degree in psychology", etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2022

Reported favorably as a committee substitute by the Committee on Health Policy; Appropriations Subcommittee on Health and Human Services recommends the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

CS/SB 944 (SO) by the Committee on Rules and Senator Baxley—

Online Marketplace Transparency; Requiring online marketplaces to require high-volume third-party sellers using their service to provide certain information to the online marketplace within a specified timeframe; requiring the online marketplace to verify such information, or changes to such information, within a specified timeframe; providing that information on valid government-issued tax documents is presumed verified as of the issuance date; requiring an online marketplace to update and require certification of the updated information at least annually, etc. Effective Date: 01/01/2023

Reported favorably by the Committee on Commerce and Tourism; reported favorably by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 1304 (SO) by the Committees on Rules, Judiciary and Senator Gruters—

Public Records/Trust Proceedings; Requiring clerks to take certain actions relating to court records for proceedings under ch. 736, F.S., and ch. 738, F.S., in which a family trust company, licensed family trust company, or foreign licensed family trust company is a party and upon written notice; creating an exemption from public records requirements for such records; authorizing certain persons to inspect such records if certain requirements are met; providing a statement of public necessity, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

SB 7044 (SO) by the Committee on Education (Gruters)—

Postsecondary Education; Providing requirements for lists of required and recommended textbooks and instructional materials for Florida College System institution and state university courses; revising the maintenance requirements of and information that must be included in the statewide course numbering system; prohibiting public postsecondary education institutions from being accredited by the same agency or association for consecutive accreditation cycles; requiring Florida College System institutions and state universities, respectively, to post specified information relating to tuition and fee rates and proposed changes to such rates on their websites, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Appropriations

CS/HM 43 (SO) by the Committee on Rules Committee, Representative Fabricio and others—

Atrocities and Genocide in Cuba; Urges President & Congress to take action to address atrocities & genocide in Cuba.

Reported favorably by the Committee on Rules

CS/CS/SB 1798 (SO) by the Committees on Appropriations, Criminal Justice and Senator Book—

Sexually Related Offenses; Increasing the monetary damages that an aggrieved person may receive as a result of violations relating to sexual cyberharassment; prohibiting the willful and malicious promotion of certain sexual depictions without consent; providing criminal penalties; authorizing law enforcement officers to arrest certain persons without a warrant; replacing the term "child pornography" with the term "child sexual abuse material", etc. Effective Date: 10/01/2022

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Committee on Children, Families, and Elder Affairs reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1950 (SO) by the Committees on Appropriations, Health Policy and Senator Brodeur—

Statewide Medicaid Managed Care Program; Requiring, rather than authorizing, that the reimbursement method for provider service networks be on a prepaid basis; deleting a requirement that the Agency for Health Care Administration provide the opportunity for public feedback on a certain waiver application; revising requirements relating to the databook published by the agency consisting of Medicaid utilization and spending data; deleting procedures for plan procurements when no provider service networks submit bids; providing that cancer hospitals meeting certain criteria are statewide essential providers, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

HB 7065, 1st Eng. (SO) by the Committee on Children, Families and Seniors Subcommittee, Representative Altman and others—

Child Welfare; Requiring the Department of Children and Families and Department of Juvenile Justice to identify and meet the needs of dually-involved children within a specified timeframe; revising information that must be included in a transition plan; requiring prenatal and infant health care delivery programs to include certain father engagement activities; requiring the Department of Children and Families to contract for the development and implementation of the Responsible Fatherhood Initiative and to provide grants to community-based not-for-profit organizations to offer certain mentorship programs; designating the month of June as "Responsible Fatherhood Month", etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Appropriations

CS/CS/SB 1796 (SO) by the Committees on Rules, Judiciary, Senator Gruters and others—

Dissolution of Marriage; Requiring the court to make certain written findings in its awards of alimony; removing the court's ability to consider adultery of either spouse in determining the amount of an alimony award; revising factors that the court must consider in determining the proper type and amount of alimony; revising a provision authorizing the modification of rehabilitative alimony upon completion of the rehabilitative plan to include a certain condition; requiring the court to consider specified factors when determining an alimony award involving the existence of a supportive relationship between the obligee and another person, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Appropriations reports the committee substitute favorably, with one amendment; and reported favorably as a committee substitute by the Committee on Rules

CS/CS/SB 1474 (SO) by the Committees on Appropriations, Commerce and Tourism and Senator Bradley—
