## SB 7044, 1st Eng. (3R) by the Committee on Education (Gruters)—

Postsecondary Education; Authorizing the Board of Governors to adopt a regulation regarding post-tenure reviews for state university faculty; revising the maintenance requirements of, and information that must be included in, the statewide course numbering system; requiring the Board of Governors and State Board of Education to identify and determine accrediting agencies or associations best suited for public postsecondary institutions by a specified date; requiring Florida College System institutions and state universities, respectively, to post specified information relating to tuition and fee rates and proposed changes to such rates on their websites, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2022

Read the second time and amended on March 4, 2022

## CS/HB 7029 (3R) by the Committees on Judiciary Committee, Criminal Justice and Public Safety Subcommittee, Representative Brannan and others—

# Time Limitations for Preadjudicatory Juvenile Detention Care; Authorizes court to order child on supervised release detention care to comply with specified conditions; authorizes court to place child on supervised release detention care for any time period; provides exception; specifies time period for which court may order child to be held in secure detention care; authorizes extension of secure detention; requires specified findings; requires hearing to determine continued need for secure detention. Effective Date: 07/01/2022

Substituted for **CS/SB 7040(SUB)** (Perry) and read the second time on March 4, 2022

## CS/CS/HB 741, 1st Eng. (3R) by the Committees on Commerce Committee, Tourism, Infrastructure and Energy Subcommittee, Representative McClure and others—

Net Metering; Provides terms for public utility net metering programs after specified date; provides schedule of reductions to net metering rate designs that apply to customers with net metering applications that are approved after specified dates; authorizes certain customers who own or lease renewable generation to remain under net metering rules that initially applied to those customers for specified time; authorizes public utilities to petition for approval of certain fixed charges designed to meet specified purposes; provides conditions under which rules must be initiated if penetration rate of customer-owned or leased renewable generation meets specified threshold; authorizes public utilities to recover specified lost revenues upon meeting certain requirements. Effective Date: 07/01/2022

Substituted for CS/CS/CS/SB 1024(SUB) (Bradley) and read the second time on March 4, 2022

#### HB 873 (3R) by Representative Maney and others—

**Pub. Rec./Execution Information**; Provides exemption from public records requirements for information or records that identify or could reasonably lead to identification of any person or entity that participates in execution; provides for retroactive application; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: Upon becoming a law

Substituted for **SB 1204(SUB)** (Broxson) and read the second time on March 4, 2022

## CS/HB 1571 (3R) by the Committee on Criminal Justice and Public Safety Subcommittee, Representative Maggard and others—

**Residential Picketing;** Prohibits person from picketing or protesting before or about dwelling of person with specified intent; requires specified warning before arrest. Effective Date: 10/01/2022

Substituted for CS/CS/SB 1664(SUB) (Perry) and read the second time on March 4, 2022

#### CS/CS/HB 921 (3R) by the Committees on State Affairs Committee, Public Integrity and Elections Committee and Representative Drake—

**Campaign Financing;** Removes limitation on contributions made to political committees that are in opposition to certain constitutional amendments; provides applicability of limitation on political contributions; provides foreign national may not make or offer to make certain contributions or expenditures. Effective Date: 07/01/2022

Substituted for CS/CS/SB 1352(SUB) (Brodeur) and read the second time on March 3, 2022, and amended on March 4, 2022

#### CS/CS/HB 1239, 1st Eng. (3R) by the Committees on Health and Human Services Committee, Finance and Facilities Subcommittee and Representative Melo—

**Nursing Homes**; Specifies functions that do not constitute direct care staffing hours for purposes of required nursing home staffing ratios; requires facilities to determine their direct care staffing needs based on certain assessment & resident care plan; revises nursing home staffing requirements; revises provisions relating to applications for change of ownership; revises provisions relating to facility's failure to comply with minimum staffing requirements. Effective Date: Upon becoming a law

Substituted for **CS/CS/SB 804(SUB)** (Albritton) and read the second time on March 4, 2022

## CS/CS/HB 1557, 1st Eng. (SO) by the Committees on Judiciary Committee, Education and Employment Committee, Representative Harding and others—

Parental Rights in Education; Requires district school boards to adopt procedures that comport with certain provisions of law for notifying student's parent of specified information; requires such procedures to reinforce fundamental right of parents to make decisions regarding upbringing & control of their children; prohibits school district from adopting procedures or student support forms that prohibit school district personnel from notifying parent about specified information or that encourage student to withhold from parent such information; prohibits school district personnel from discouraging or prohibiting parental notification & involvement in critical decisions affecting student's mental, emotional, or physical well-being; prohibits classroom discussion about sexual orientation or gender identity in certain grade levels; requires school districts to notify parents of healthcare services; authorizes parent to bring action against school district to obtain declaratory judgment: provides for additional award of injunctive relief. damages, & reasonable attorney fees & court costs to certain parents. Effective Date: 07/01/2022

Reported favorably by the Committee on Appropriations

#### CS/CS/SB 398 (SO) by the Committees on Appropriations, Transportation and Senator Hooper—

**Transportation Projects**; Revising the requirement for the annual commitment of State Transportation Trust Fund revenues for public transportation projects by the Department of Transportation; providing that the department's program for innovative transportation projects may include progressive design-build contracts; revising the department's authority relating to design-build contracts; revising a dollar limit of proposed budget estimates of construction contracts for which an applying contractor may submit certain financial statements, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Transportation; recommended favorably as a committee substitute by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

## CS/CS/SB 1702 (SO) by the Committees on Rules, Regulated Industries, Senator Bradley and others—

**Building Safety;** Defining the term "milestone inspection"; specifying that the purpose of a milestone inspection is not to determine compliance with the Florida Building Code or the firesafety code; requiring certain associations to periodically have a study conducted relating to required reserves after a specified date; requiring associations to provide for the maintenance, repair, and replacement of condominium property; authorizing boards to adopt a special assessment or borrow money for certain reasons without unit owner approval; revising certification and education requirements for directors of association boards, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Rules

Compare to CS/HB 7069, 1st Eng.(HC) in the Committee on Rules

#### CS/CS/SB 1710 (SO) by the Committees on Rules, Children, Families, and Elder Affairs, Senator Bradley and others—

**Guardianship Data Transparency**; Requiring the Florida Clerks of Court Operations Corporation and the clerks of court to establish a statewide database of guardianship data on or after a certain date; specifying requirements for the database; requiring the corporation to establish a webpage for certain purposes on or after a specified date; requiring the corporation to annually compile and submit certain data to the Office of Program Policy Analysis and Government Accountability (OPPAGA); requiring the Office of Public and Professional Guardians to publish profiles of registered professional guardians on its website, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Committee on Appropriations reports the committee substitute favorably, with one amendment; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/CS/HB 1349(HC) in the Committee on Rules

## CS/SB 486 (SO) by the Committee on Appropriations and Senator Brodeur—

Money Services Businesses; Revising exceptions to general laws and rules for licensees during the Financial Technology Sandbox period; defining the term "virtual currency"; revising the purpose of the Florida Control of Money Laundering in Money Services Business Act; revising criminal and civil penalties for certain violations relating to unlicensed activity involving money services businesses and deferred presentment providers; requiring money transmitters that receive virtual currency for specified purposes to hold a certain type and amount of virtual currency until the transmission obligation is completed, etc. Effective Date: 01/01/2023

Reported favorably by the Committee on Banking and Insurance; recommended favorably as a committee substitute by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations

#### SPECIAL ORDER CALENDAR FOR TUESDAY, MARCH 8, 2022

## CS/SB 342 (SO) by the Committee on Criminal Justice, Senator Perry and others—

Juvenile Diversion Program Expunction; Requiring the Department of Law Enforcement to expunge the nonjudicial arrest record of certain minors who successfully complete a diversion program for specified felony offenses, rather than only for misdemeanor offenses; authorizing a minor who successfully completes a diversion program and is granted an expunction for any offense, rather than only for a first-time misdemeanor offense, to lawfully deny or fail to acknowledge certain information, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

Similar to CS/HB 195(HC) in the Committee on Appropriations

## CS/SB 344 (SO) by the Committee on Criminal Justice and Senator Perry—

#### Public Records/Nonjudicial Record of the Arrest of a Minor;

Providing an exemption from public records requirements for a nonjudicial record of the arrest of a minor who has successfully completed a diversion program; providing for retroactive application; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: On the same date that SB 342 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably as a committee substitute by the Committee on Criminal Justice; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

Identical to HB 197(HC) in the Committee on Appropriations

#### CS/SB 528 (SO) by the Committee on Judiciary and Senator Polsky—

Value of Motor Vehicles Exempt from Legal Process; Authorizing certain natural persons to exempt a specified amount of interest in a single motor vehicle from certain legal processes, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

Identical to CS/HB 265(HC) in the Committee on Rules

#### SB 730 (SO) by Senator Harrell and others—

**Step-therapy Protocols**; Revising the circumstances under which step-therapy protocols may not be required; requiring health insurers to publish on their websites and provide to their insureds specified information; requiring health maintenance organizations to publish on their websites and provide to their subscribers specified information; providing requirements for procedures for requests and appeals of denials of protocol exemptions, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Health Policy; and reported favorably by the Committee on Rules

Similar to HB 459(HC) in the Committee on Rules

#### SB 890 (SO) by Senator Burgess and others—

Telecommunicator Cardiopulmonary Resuscitation; Requiring certain 911 public safety telecommunicators to receive ongoing telecommunicator cardiopulmonary resuscitation training; authorizing public safety agencies and certain other agencies to enter into reciprocal agreements to provide telecommunicator cardiopulmonary resuscitation under certain circumstances; providing requirements for certain employees who answer emergency medical service calls, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Health Policy; recommended favorably by Appropriations Subcommittee on Health and Human Services; and reported favorably by the Committee on Appropriations

Similar to HB 593(HC) in the Committee on Appropriations

## CS/SB 1066 (SO) by the Committee on Banking and Insurance, Senator Burgess and others—

Workers' Compensation Benefits for First Responders; Providing that the time for specified notice in certain cases of compensable posttraumatic stress disorder is measured from the time of the qualifying event or the diagnosis of the disorder, rather than the manifestation of the disorder, whichever is later, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Community Affairs reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

Compare to CS/HB 689, 1st Eng.(HC) in the Committee on Appropriations

#### SB 1518 (SO) by Senator Berman and others—

**Lactation Space**; Requiring at least one lactation space to be provided in each county courthouse; providing requirements for the lactation space; authorizing the use of state or private funds to provide lactation space in appellate courthouses, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Governmental Oversight and Accountability; recommended favorably by Appropriations Subcommittee on Criminal and Civil Justice; and reported favorably by the Committee on Appropriations

## SENATE BILLS ON SECOND READING

CS/SB 228 (2R) by the Committee on Finance and Tax, Senator Rodriguez and others—

Resiliency Energy Environment Florida Programs; Providing that a property owner may apply to a Resiliency Energy Environment Florida (REEF) program for funding to finance a qualifying improvement and may enter into an assessment financing agreement with a local government; authorizing a local government to enter into an agreement with a program administrator to administer a REEF program on the local government's behalf; specifying underwriting, financing estimate, disclosure, and confirmation requirements for program administrators relating to residential real property, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Finance and Tax; and the Committee on Rules reports the committee substitute favorably

## CS/CS/SB 358 (2R) by the Committees on Appropriations, Health Policy and Senator Rodriguez—

Mental Health Professionals; Creating the Professional Counselors Licensure Compact; providing for recognition of the privilege to practice licensed professional counseling in member states; providing for the recognition of the practice of professional counseling through telehealth in member states; providing for the development of the data system, reporting procedures, and the exchange of specified information between member states; specifying that the compact, commission rules, and commission actions are binding on member states, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect upon enactment of the Professional Counselors Licensure Compact into law by 10 states

Reported favorably as a committee substitute by the Committee on Health Policy; recommended favorably as a committee substitute by Appropriations Subcommittee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Appropriations

## CS/SB 410 (2R) by the Committee on Appropriations, Senator Rodriguez and others—

Enforcement of School Zone Speed Limits; Authorizing counties and municipalities to enforce speed limits on certain road areas and at specified periods through the use of speed detection systems; authorizing counties and municipalities to install, or contract with a vendor to install, speed detection systems; requiring counties and municipalities that install speed detection systems to provide certain notice to the public; authorizing counties and municipalities to authorize traffic infraction enforcement officers to issue traffic citations for certain violations, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Education; recommended favorably by Appropriations Subcommittee on Transportation, Tourism, and Economic Development; and reported favorably as a committee substitute by the Committee on Appropriations

## CS/CS/SB 590 (2R) by the Committees on Rules, Governmental Oversight and Accountability and Senator Rodriguez—

Public Records and Meetings/Professional Counselors Licensure Compact; Providing an exemption from public records requirements for certain information held by the Department of Health or the Board of Clinical Social Work, Marriage and Family Therapy, and Mental Health Counseling pursuant to the Professional Counselors Licensure Compact; providing an exemption from public meetings requirements for certain meetings or portions of certain meetings of the Counseling Compact Commission or its executive committee; providing for future legislative review and repeal of the exemptions; providing statements of public necessity, etc. Effective Date: On the same date that SB 358 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and reported favorably as a committee substitute by the Committee on Rules

#### CS/CS/SB 954 (2R) by the Committees on Appropriations, Governmental Oversight and Accountability, Senator Brodeur and others—

**Energy;** Revising the selection criteria for purchasing or leasing vehicles for state agency, college, or university or certain local government fleets; removing a provision requiring the use and procurement of ethanol and biodiesel fuels; requiring the Department of Management Services, before a specified date, to make recommendations to state agencies and local governments relating to the procurement and integration of electric and natural gas fuel vehicles; revising the definition of the term "single-trade inspection", etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; recommended favorably as a committee substitute by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Appropriations

### CS/SB 990 (2R) by the Committee on Transportation and Senator

**Towing Vehicles**; Prohibiting investigating agencies from releasing motor vehicles towed to an agency's storage facility until certain proof of payment is presented to the agency; specifying that investigating agencies that do not obtain proof of payment must pay certain charges within a specified timeframe; revising the timeframe required for sending notices of lien; prohibiting towing companies from releasing vehicles owned by rental car companies, which are towed under certain circumstances, to the person who rented the vehicle unless the rental car company appoints the person as its agent, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Transportation; and the Committee on Rules reports the committee substitute favorably

#### SB 1258 (2R) by Senator Jones and others-

Managed Care Plan Performance; Requiring managed care plans to collect and report specified measures beginning with a certain data reporting period; requiring plans to stratify reported measures by specified categories beginning with a certain data reporting period; requiring a plan's performance to be published on its website in a specified manner; requiring the Agency for Health Care Administration to use the measures to monitor plan performance, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Health Policy; reported favorably by the Committee on Banking and Insurance; and reported favorably by the Committee on Rules

#### SB 1274 (2R) by Senator Broxson-

#### Ratification of Rules of the Department of Financial Services;

Ratifying a specified rule relating to the Florida Workers' Compensation Health Care Provider Reimbursement Manual, for the sole and exclusive purpose of satisfying any condition on effectiveness pursuant to s. 120.541(3), F.S., which requires ratification of any rule meeting any specified thresholds for likely adverse impact or increase in regulatory costs, etc. Effective Date: 07/01/2022

Reported favorably by the Committee on Banking and Insurance; recommended favorably by Appropriations Subcommittee on Agriculture, Environment, and General Government; and reported favorably by the Committee on Appropriations

## CS/CS/SB 1302 (2R) by the Committees on Appropriations, Regulated Industries, Senator Burgess and others—

**Criminal History Records;** Requiring a court to automatically seal certain criminal history records that meet specified criteria; requiring the clerk of the court to seal certain criminal history records, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Regulated Industries; Appropriations Subcommittee on Criminal and Civil Justice recommends the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Appropriations

## CS/CS/SB 1408 (2R) by the Committees on Rules, Judiciary, Senator Perry and others—

**Grandparent Visitation Rights**; Creating a presumption for maternal or paternal grandparent or stepgrandparent visitation of a child under certain circumstances; providing a burden for overcoming such presumption, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Judiciary; the Committee on Children, Families, and Elder Affairs reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

### CS/CS/SB 1610 (2R) by the Committees on Appropriations, Finance and Tax, Senator Rodriguez and others—

**Taxation**; Providing for the eligibility for abatement of ad valorem taxes and non-ad valorem assessments for residential improvements destroyed following certain events; requiring property appraisers to provide specified statements to tax collectors; prohibiting property appraisers and tax collectors from issuing specified notices for parcels meeting certain requirements; requiring property appraisers to notify taxpayers of the abatement of taxes and non-ad valorem assessments under certain circumstances; requiring value adjustment boards to dismiss petitions under certain circumstances, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Finance and Tax; and reported favorably as a committee substitute by the Committee on Appropriations

CS/CS/SB 1670 (2R) by the Committees on Appropriations, Military and Veterans Affairs, Space, and Domestic Security and Senator Hutson—

Cybersecurity; Requiring the Department of Management Services, acting through the Florida Digital Service, to develop and publish guidelines and processes for reporting cybersecurity incidents; requiring state agencies to report ransomware incidents and certain cybersecurity incidents to certain entities within specified timeframes; requiring the Cybersecurity Operations Center to provide certain notifications to the Legislature within a specified timeframe; requiring state agency heads to annually provide cybersecurity awareness training to certain persons, etc. Effective Date: 07/01/2022

Reported favorably as a committee substitute by the Committee on Military and Veterans Affairs, Space, and Domestic Security; and reported favorably as a committee substitute by the Committee on Appropriations
