# **BILLS ON THE CALENDAR**

### SPECIAL ORDER CALENDAR FOR WEDNESDAY, FEBRUARY 28, 2024

#### SB 240 (SO) by Senator Burton and others-

**International Baccalaureate Teacher Bonuses;** Revising the requirements for the calculation of additional full-time equivalent membership and certain bonuses based on International Baccalaureate examination scores of students to include students who earn equivalent scores as determined by the Department of Education, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Education Pre-K -12; reported favorably by the Appropriations Committee on Education; and reported favorably by the Committee on Appropriations

### CS/SB 644 (SO) by the Appropriations Committee on Health and Human Services and Senator Simon—

**Rural Emergency Hospitals;** Subjecting rural emergency hospitals to certain requirements for the provision of emergency services and care; defining the terms "rural emergency hospital" and "rural emergency services"; authorizing qualifying hospitals to apply to the Agency for Health Care Administration for designation as a rural emergency hospital, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Fiscal Policy reports the committee substitute favorably

# CS/SB 148 (SO) by the Committee on Judiciary, Senator Berman and others—

Antisemitism; Defining the term "antisemitism"; providing contemporary examples of antisemitism, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Rules reports the committee substitute favorably

Similar to **HB 187(HC)** in the Committee on Rules

### SJR 1114 (SO) by Senator Hutson-

Public Financing for Campaigns of Candidates for Elective Statewide Office; Proposing the repeal of Section 7 of Article VI of the State Constitution which requires the availability of public financing for campaigns of candidates for elective statewide office who agree to campaign spending limits, etc.

Reported favorably by the Committee on Ethics and Elections; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

### SB 1116 (SO) by Senator Hutson-

**Campaign Finance;** Repealing provisions relating to the Florida Election Campaign Financing Act; deleting provisions governing the public funding of campaigns for candidates for statewide office who agree to certain expenditure limits, etc. Effective Date: On the effective date of the amendment to the State Constitution proposed by SJR 1114 or a similar joint resolution having substantially the same specific intent and purpose if such an amendment to the State Constitution is approved by the electors at the next general election or at an earlier special election specifically authorized by law for that purpose

Reported favorably by the Committee on Ethics and Elections; reported favorably by the Committee on Judiciary; and reported favorably by the Committee on Rules

### CS/SB 330 (SO) by the Appropriations Committee on Health and Human Services, Senator Boyd and others—

**Behavioral Health Teaching Hospitals;** Creating part VI of ch. 395, F.S., entitled "Behavioral Health Teaching Hospitals"; defining the terms "agency" and "behavioral health teaching hospital"; specifying criteria that a hospital must meet to receive designation as a behavioral health teaching hospital; establishing the Florida Center for Behavioral Health Workforce within the Louis de la Parte Florida Mental Health Institute for a specified purpose, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2024

Reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Appropriations reports the committee substitute favorably

# CS/SB 356 (SO) by the Committee on Commerce and Tourism and Senator Avila—

**Notaries Public;** Requiring that certain notarial certificates contain the printed names of specified individuals; prohibiting a notary public from falsely notarizing the signature of a person who is not in that notary public's presence, either in person or online; deleting a provision that prohibits a notary public from notarizing a signature on a document of a person who is not, at the time of the notarial act, physically present or present by means of audio-video communication technology and that provides civil penalties; requiring a notary public to keep at least one tangible journal; requiring the Department of State to retain jurisdiction over the journal records for a specified timeframe for a certain purpose, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

# CS/SB 362 (SO) by the Committee on Fiscal Policy and Senator Bradley—

**Medical Treatment Under the Workers' Compensation Law;** Increasing limits on witness fees charged by certain witnesses; increasing maximum reimbursement allowances for physicians and surgical procedures, etc. Effective Date: 01/01/2025

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Committee on Health Policy; and reported favorably as a committee substitute by the Committee on Fiscal Policy

# CS/CS/SB 864 (SO) by the Committees on Fiscal Policy, Criminal Justice, Senator Collins and others—

Autism Spectrum Disorder Training for Law Enforcement and Correctional Officers; Providing requirements for training officers for interacting with individuals with autism spectrum disorder; requiring the Criminal Justice Standards and Training Commission to adopt specified rules requiring such training as part of basic recruit training or as part of the required instruction for continued employment or appointment as officers, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

### CS/CS/CS/SB 638 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Grall—

Lethality Assessments; Requiring law enforcement officers who investigate an alleged incident of domestic violence to administer a lethality assessment under certain circumstances; requiring the Department of Law Enforcement to consult with specified entities, and authorizing the department to consult with other specified entities, to develop certain policies, procedures, and training necessary for the implementation of a statewide evidence-based lethality assessment; requiring the department to adopt a statewide lethality assessment; form by a specified date; prohibiting law enforcement officers from disclosing in certain statements and reports the domestic violence center to which the victim was referred, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

# SB 7062 (SO) by the Appropriations Committee on Criminal and Civil Justice (Bradley)—

**Public Records/Lethality Assessment;** Providing a public records exemption for certain information pertaining to a lethality assessment administered by a trained law enforcement officer; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: On the same date that SB 638 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably by the Committee on Fiscal Policy

### CS/SB 7032 (SO) by the Committees on Appropriations, and Education Postsecondary (Grall)—

**Education**; Establishing the Graduation Alternative to Traditional Education (GATE) Program within the Department of Education; revising the services to which the one-stop delivery system is intended to provide access; requiring a student's certified school counselor or other school personnel to inform the student of opportunities in the GATE Program; requiring district school boards to notify all candidates for the high school equivalency diploma of adult secondary and postsecondary education options, including specified eligibility requirements; creating the GATE Scholarship Program; requiring the department to administer the program, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Appropriations

# CS/SB 1142 (SO) by the Committee on Fiscal Policy and Senator Hooper—

**Occupational Licensing;** Requiring the Construction Industry Licensing Board within the Department of Business and Professional Regulation to issue registrations to eligible persons under certain circumstances; providing that the board is responsible for disciplining such licensees; providing for the fees for the issuance of the registrations and renewal registrations; requiring the department to provide specified license, renewal, and cancellation notices, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy

### CS/SB 7054 (SO) by the Committees on Appropriations, and Community Affairs (Calatayud)—

**Private Activity Bonds;** Requiring the Division of Bond Finance of the State Board of Administration to annually determine the state volume limitation and publicize such information; repealing provisions relating to procedures for obtaining allocations, requirements, limitations on allocations, and issuance reports; establishing procedures for the issuance of private activity bonds; providing requirements for notices of intent to issue private activity bonds, etc. Effective Date: 01/01/2025

Reported favorably as a committee substitute by the Committee on Appropriations

# CS/SB 260 (SO) by the Committee on Criminal Justice, Senator DiCeglie and others—

**Refusal to Submit to a Breath, Urine, or Blood Test;** Requiring that a person arrested for driving or being in actual physical control of a motor vehicle while under the influence who refuses to submit to a lawful test of his or her breath incident to a lawful arrest be told that he or she is subject to mandatory placement, for a specified period, of an ignition interlock device on all vehicles that are individually or jointly leased or owned and routinely operated by the person; directing the department to require placement of an ignition interlock device before issuing a permanent or restricted driver license to a person who refused to submit to a lawful test of his or her breath, etc. Effective Date: 10/01/2024

Reported favorably by the Committee on Transportation; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

#### CS/CS/SB 532 (SO) by the Committees on Fiscal Policy, Banking and Insurance and Senator Brodeur—

**Securities**; Revising the list of securities that are exempt from registration requirements under certain provisions; revising provisions relating to a certain registration exemption for certain securities transactions; updating the federal laws or regulations with which the offer or sale of securities must be in compliance; requiring that offers and sales of securities be in accordance with certain federal laws and rules; providing that registration exemptions under certain provisions are not available to issuers for certain transactions under specified circumstances; specifying criteria for determining integration of offerings for the purpose of registration or qualifying for a registration exemption; specifying the purpose of the Securities Guaranty Fund, etc. Effective Date: 10/01/2024

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

#### CS/CS/SB 902 (SO) by the Committees on Commerce and Tourism, Banking and Insurance and Senator Boyd—

**Motor Vehicle Retail Financial Agreements;** Revising the definition of the term "guaranteed asset protection product"; requiring entities to refund the portions of the purchase price of the contract for a guaranteed asset protection product under certain circumstances; creating the "Florida Vehicle Value Protection Agreements Act"; authorizing the offer, sale, or gift of vehicle value protection agreements in compliance with a certain act, etc. Effective Date: 10/01/2024

Reported favorably as a committee substitute by the Committee on Banking and Insurance; reported favorably as a committee substitute by the Committee on Commerce and Tourism; and the Committee on Fiscal Policy reports the committee substitute favorably

### SB 938 (SO) by Senator Yarborough-

**Dentistry**; Deleting the role of the Board of Dentistry in the administration of the licensure examination for dentists; deleting the requirement for the board to establish an examination fee; revising requirements for licensure as a dentist; deleting a time limitation on the validity of certain licensure examination results; deleting a board-imposed reexamination fee, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Health Policy; reported favorably by the Committee on Fiscal Policy; and reported favorably by the Committee on Rules

### CS/CS/SB 1046 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Agriculture, Environment, and General Government and Senator Martin—

**Gaming Control;** Prohibiting a person from falsely personating any personnel or representative from the Florida Gaming Control Commission; increasing the criminal penalty for specified violations involving a slot machine or device; prohibiting a person from making false statements or disseminating false information regarding the legality of a slot machine or device to facilitate the sale or delivery of such device; prohibiting a person from, for profit or hire, transporting or procuring the transportation of a specified number of other persons to facilitate illegal gambling, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Regulated Industries; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Fiscal Policy

# CS/CS/SB 1680 (SO) by the Committees on Rules, Judiciary and Senator Bradley—

Advanced Technology; Creating the Government Technology Modernization Council within the Department of Management Services for a specified purpose; prohibiting a person from knowingly possessing or controlling or intentionally viewing photographs, motion pictures, representations, images, data files, computer depictions, or other presentations which the person knows to include generated child pornography; prohibiting a person from intentionally creating generated child pornography, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules

# CS/SB 1616 (SO) by the Committee on Judiciary and Senator Calatayud—

**Electronic Access to Official Records;** Requiring the clerk of the court to make certain information available in a searchable database on the clerk's official website, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Judiciary; and the Committee on Appropriations reports the committee substitute favorably

### CS/CS/CS/SB 764 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Stewart—

**Retention of Sexual Offense Evidence**; Requiring that specified sexual offense evidence be retained by specified entities for a minimum number of years after the collection date; requiring that such evidence be stored anonymously in a secure, environmentally safe manner, and with a documented chain of custody; providing requirements for the transferring, storing, and destruction of such sexual offense evidence, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

### CS/CS/CS/SB 1532 (SO) by the Committees on Rules, Community Affairs, Environment and Natural Resources and Senator Brodeur—

**Mitigation;** Defining the term "applicant"; revising the entities to whom and purposes for which water quality enhancement credits may be sold; requiring the Department of Environmental Protection or water management districts to authorize the sale and use of such credits to applicants, rather than to governmental entities, to address adverse water quality impacts of certain activities; authorizing local governments with land in credit-deficient basins to consider bids from private-sector applicants to establish mitigation banks on such lands, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; reported favorably as a committee substitute by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

# CS/CS/SB 1140 (SO) by the Committees on Fiscal Policy, Regulated Industries and Senator Burton—

**Mobile Homes;** Requiring that a petition for mediation be filed with the Division of Florida Condominiums, Timeshares, and Mobile Homes of the Department of Business and Professional Regulation to determine the adequacy and conformance of the homeowners' petition to initiate mediation; authorizing parties to disputes to jointly select a mediator and initiate mediation proceedings; requiring that specified live-in health care aides have ingress and egress to and from a mobile home owner's site without having to pay charges, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy

### CS/CS/CS/SB 340 (SO) by the Committees on Fiscal Policy, Regulated Industries, Criminal Justice and Senator Yarborough—

**Offenses Involving Critical Infrastructure;** Providing criminal penalties for improperly tampering with critical infrastructure resulting in specified monetary damage or cost to restore; providing criminal penalties for trespass upon critical infrastructure; providing notice requirements; providing criminal penalties for the unauthorized access to or tampering with specified electronic devices or networks of critical infrastructure, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Identical to CS/CS/CS/HB 275(HC) in the Committee on Fiscal Policy

### SB 534 (SO) by Senator Grall-

**Equitable Distribution of Marital Assets and Liabilities;** Requiring a court to consider certain factors when determining if extraordinary circumstances exist; prohibiting certain interspousal gifts unless certain requirements are met; providing that certain actions do not change whether certain real property is marital property; providing that business interest in a closely held business is a marital asset, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Children, Families, and Elder Affairs; and reported favorably by the Committee on Rules

Identical to HB 521(HC) in the Committee on Rules

# CS/SB 1090 (SO) by the Committee on Rules and Senator Martin—

**Unauthorized Sale of Alcoholic Beverages;** Revising the punishment for the unlawful sale of alcoholic beverages; revising the activities that may be declared a public nuisance under local administrative actions to abate certain activities to include persons who commit the unlicensed or unlawful sale of alcoholic beverages more than a specified number of times within a specified period, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Regulated Industries; reported favorably by the Committee on Criminal Justice; and reported favorably as a committee substitute by the Committee on Rules

### SB 818 (SO) by Senator Avila and others-

**Military Leave;** Providing that public officials and employees of the state, a county, a municipality, or a political subdivision, respectively, are entitled to their full pay for the first 30 days of military service, if such service is equal to or greater than a specified timeframe, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; reported favorably by the Committee on Community Affairs; and reported favorably by the Committee on Fiscal Policy

# CS/SB 678 (SO) by the Committee on Criminal Justice and Senator Bradley—

**Forensic Investigative Genetic Genealogy Grant Program;** Defining the term "investigative genetic genealogy"; requiring that certain methods be in accordance with Department of Law Enforcement rules and compatible with certain databases; specifying the intent for certain funding; creating the Forensic Investigative Genetic Genealogy Grant Program within the Department of Law Enforcement, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

### CS/CS/CS/SB 812 (SO) by the Committees on Rules, Regulated Industries, Community Affairs and Senator Ingoglia—

**Expedited Approval of Residential Building Permits;** Requiring certain governing bodies, by a date certain, to each create a program to expedite the process for issuing residential building permits before a final plat is recorded; requiring a governing body to create certain processes for purposes of the program; authorizing a governing body to issue addresses and temporary parcel identification numbers for specified purposes; prohibiting a governing body from making substantive changes to a preliminary plat without written consent, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Rules

# CS/SB 1660 (SO) by the Committee on Judiciary and Senator Torres—
