## CS/SB 1072 (SO) by the Committee on Fiscal Policy and Senator McClain—

**Expedited DNA Testing Grant Program;** Defining the term "private lab"; creating the Expedited DNA Testing Grant Program within the Department of Law Enforcement; specifying potential grant recipients; providing purposes for the grants under the program; specifying eligible uses for such grant funds; requiring each grant recipient to provide a report to the executive director of the department within a certain timeframe, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/HB 847(HC) in the Committee on Fiscal Policy

#### SB 984 (SO) by Senator Gruters-

**Aggravating Factors;** Providing an additional aggravating factor for capital felonies, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably by the Appropriations Committee on Criminal and Civil Justice; and reported favorably by the Committee on Fiscal Policy

Similar to HB 693(HC) in the Committee on Fiscal Policy

## CS/CS/SB 924 (SO) by the Committees on Banking and Insurance, Governmental Oversight and Accountability, Senator Calatayud and others—

Coverage for Fertility Preservation Services; Requiring the Department of Management Services to provide coverage of certain fertility retrieval and preservation services for state group health insurance plan policies issued on or after a specified date; prohibiting a state group health insurance plan from requiring preauthorization for certain covered services, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; reported favorably as a committee substitute by the Committee on Banking and Insurance; and the Committee on Appropriations reports the committee substitute favorably

Similar to CS/HB 677(HC) in the Committee on Appropriations

## CS/SB 916 (SO) by the Committee on Transportation and Senator Rodriguez—

#### Indemnification of Commuter Rail Transportation Providers;

Creating the "Coastal Link Commuter Rail Service Act"; authorizing an agency to assume the obligation to protect, defend, indemnify, and hold harmless certain entities from and against certain liabilities, costs, and expenses in certain circumstances; providing that an employee of an operator is not a coastal link corridor invitee of such operator in certain circumstances; specifying the circumstances under which certain passengers are coastal link corridor invitees of certain operators; requiring that the allocation of liability between certain agencies be allocated as agreed and limited by certain provisions, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; the Committee on Judiciary reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/HB 867(HC) in the Committee on Fiscal Policy

### CS/SB 868 (SO) by the Committee on Commerce and Tourism and Senator Ingoglia—

Social Media Use by Minors; Requiring social media platforms to provide a mechanism to decrypt end-to-end encryption when law enforcement obtains a subpoena; requiring social media platforms to allow a parent or legal guardian of a minor account holder to view all messages; prohibiting minor account holders from using or accessing messages that are designed to disappear or self destruct, or are ephemeral in nature, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Committee on Judiciary reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

## CS/SB 830 (SO) by the Appropriations Committee on Agriculture, Environment, and General Government and Senator Rodriguez—

**Disposition of Migrant Vessels;** Defining the term "migrant vessel"; revising provisions concerning relocation or removal of certain vessels to include migrant vessels; providing procedures for law enforcement officers concerning disposition of migrant vessels, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Environment and Natural Resources; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and the Committee on Fiscal Policy reports the committee substitute favorably

## CS/CS/SB 824 (SO) by the Committees on Fiscal Policy, Transportation and Senator Pizzo—

Specialty License Plates; Increasing the annual use fee for the Florida Wildflower license plate and providing a discount for owners purchasing the plate for more than a specified number of vehicles; directing the Department of Highway Safety and Motor Vehicles to develop certain specialty license plates; providing for distribution and use of fees collected from the sale of the plates, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Transportation; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

#### SB 788 (SO) by Senator Truenow and others—

**Veterans' Nursing Homes;** Defining the term "veteran- and spouse-designated nursing home beds"; authorizing the executive director of the Department of Veterans' Affairs to approve requests to create or modify veteran- and spouse-designated nursing home beds if certain conditions are met; authorizing the department to adopt rules, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably by the Committee on Fiscal Policy

#### CS/SB 398 (SO) by the Committee on Fiscal Policy, Senator Burgess and others—

Awareness Program for Alzheimer's Disease and Dementiarelated Disorders; Requiring the Department of Elderly Affairs to contract for the development and implementation of the Alzheimer's Disease Awareness Program; requiring the Alzheimer's Disease Advisory Committee to evaluate the program and make certain recommendations, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Children, Families, and Elder Affairs; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Fiscal Policy

## CS/CS/SB 364 (SO) by the Committees on Fiscal Policy, Education Pre-K - 12, Senator Osgood and others—

Council on the Social Status of Black Men and Boys; Establishing the council within Florida Memorial University, rather than the Department of Legal Affairs; requiring Florida Memorial University, rather than the Office of the Attorney General, to provide staff and administrative support to the council; authorizing members to appear by communications media technology; providing notice requirements for public meetings or workshops conducted by means of communications media technology, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Appropriations Committee on Pre-K - 12 Education reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

### CS/CS/SB 140 (SO) by the Committees on Rules, Education Pre-K - 12 and Senator Gaetz—

Charter Schools; Revising which persons or entities may apply for a conversion charter school; authorizing a municipality to apply for a charter that it may designate as a job engine charter under certain conditions; revising entities that are included in the Workforce Development Capitalization Incentive Grant Program to include charter schools, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Committee on Community Affairs reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Rules

#### CS/CS/SB 1800 (SO) by the Appropriations Committee on Health and Human Services, the Committee on Health Policy and Senator Calatayud—

**Parkinson's Disease;** Creating the "Parkinson's Disease Research Act"; establishing the Consortium for Parkinson's Disease Research within the University of South Florida; establishing the Parkinson's Disease Research Board; requiring the board to direct the operations of the consortium; requiring the board to award funds to board members for certain purposes, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 1545(HC) in the Committee on Fiscal Policy

## CS/SB 1654 (SO) by the Appropriations Committee on Criminal and Civil Justice and Senator Martin—

Registration of Sexual Predators and Sexual Offenders; Revising reporting requirements for sexual predators; revising reporting requirements for sexual offenders; revising verification requirements, etc. Effective Date: 10/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

Identical to **CS/HB 1351(HC)** in the Committee on Fiscal Policy

# CS/CS/CS/SB 1742 (SO) by the Committee on Rules, the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Regulated Industries, Senator Bradley and others—

Condominium and Cooperative Associations; Prohibiting a person whose community association manager license is revoked from having an indirect or direct ownership interest in, or being an employee, a partner, an officer, a director, or a trustee of, a community association management firm for a specified timeframe; prohibiting a community association manager or a community association management firm from knowingly performing any act directed by the community association if such act violates any state or federal law; authorizing an association board meeting to be conducted in person or by video conference; requiring a cooperative association to create and maintain an online account with the division, etc. Effective Date: Except as otherwise provided in this act, this act shall take effect July 1, 2025

Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Rules

## CS/CS/SB 1620 (SO) by the Committees on Fiscal Policy, Children, Families, and Elder Affairs and Senator Rouson—

Mental Health and Substance Use Disorders; Requiring the Department of Children and Families to require certain providers to use a specified assessment tool; requiring facilities to update treatment plans within specified timeframes; requiring use of a specified assessment tool; providing an exception; requiring the Criminal Justice, Mental Health, and Substance Abuse Technical Assistance Center at the Louis de la Parte Florida Mental Health Institute at the University of South Florida to disseminate among grantees certain evidence-based practices and best practices, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

## CS/CS/SB 1618 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Pre-K - 12 Education and Senator Calatayud—

Education; Deleting the Florida School for Competitive Academics from the list of entities subject to certain audit requirements; authorizing the Office of Program Policy Analysis and Government Accountability to develop contracts or agreements with institutions in the State University System for a specified purpose; requiring the department to take into account underrepresented groups in administering the apprenticeship training program, rather than minority and gender diversity; changing the term "gender" to "sex"; deleting a provision requiring the Commissioner of Education to determine whether school districts have maximized efforts to include minority persons and persons of lower socioeconomic status on their school advisory councils, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2025

Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and reported favorably as a committee substitute by the Committee on Fiscal Policy

## CS/SB 1590 (SO) by the Appropriations Committee on Pre-K - 12 Education and Senator Burgess—

**Educator Preparation**; Requiring the Department of Education to establish a workgroup to update and revise the Florida Educator Accomplished Practices; requiring the department to submit workgroup findings to the Governor and the Legislature by a certain date; establishing guidelines for teacher preparation program uniform core curricula, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and the Committee on Fiscal Policy reports the committee substitute favorably

Compare to CS/CS/HB 875, 1st Eng.(HC) in the Committee on Rules

#### CS/CS/SB 1386 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice, Senator Yarborough and others—

**Assault or Battery on a Utility Worker;** Defining the term "utility worker"; providing for reclassification of certain offenses committed against a utility worker engaged in work on critical infrastructure, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

# CS/CS/CS/SB 1344 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Simon—

Juvenile Justice; Providing for appointment of counsel in certain circumstances; providing for payment of counsel; revising provisions for a child's punishment for contempt of court; revising provisions related to case staffing and to services and treatment related to a family in need of services; authorizing that a child be taken into custody pursuant to a finding of contempt; providing for early truancy intervention; providing for additional services to be ordered if a student is found to be a truant status offender; specifying when a guardian ad litem may be appointed, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

## CS/SB 1310 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Bradley—

Reporting of Student Mental Health Outcomes; Requiring the Office of Program Policy Analysis and Government Accountability to submit an initial specified evaluation to the Governor and Legislature by a specified date; providing evaluation requirements; requiring the office to submit a final review and evaluation to the Governor and Legislature by a specified date, etc. Effective Date: Upon becoming a law

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 969(HC) in the Committee on Fiscal Policy

#### CS/CS/SB 1174 (SO) by the Appropriations Committee on Health and Human Services, the Committee on Children, Families, and Elder Affairs, Senator Jones and others—

Licensure of Family Foster Homes; Requiring the Department of Children and Families to adopt rules to streamline the licensure application process for licensed foster parents who relocate within this state; requiring that such rules include priority review of applications, expedited home studies and background checks, and recognition of prior foster parent training coursework, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Rules reports the committee substitute favorably

Identical to CS/CS/HB 989(HC) in the Committee on Rules

#### SB 1162 (SO) by Senator Leek and others—

Water Access Facilities; Providing sovereignty submerged land leases for Clean Marine Manufacturer facilities; providing competitive grant programs for the construction and maintenance of publicly owned parking for boat-hauling vehicles and trailers, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Environment and Natural Resources; reported favorably by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably by the Committee on Fiscal Policy

Identical to HB 735(HC) in the Committee on Fiscal Policy

## CS/SB 1160 (SO) by the Committee on Governmental Oversight and Accountability, Senator Leek and others—

Benefits for Certain Officers Injured in the Line of Duty; Revising eligibility criteria for health insurance coverage provided to law enforcement, correctional, and correctional probation officers injured in the line of duty and to their spouses and dependent children, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Appropriations reports the committee substitute favorably

### CS/SB 1122 (SO) by the Committee on Education Pre-K - 12 and Senator Burton—

Florida Virtual School; Deleting provisions requiring the Florida Virtual School to give priority to certain students; providing that officers and employees are granted sovereign immunity in addition to the board of trustees; providing that certain expenditures are contingent upon review and approval by the Florida Virtual School president and chief executive officer or authorized designees, rather than the executive director, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Appropriations Committee on Pre-K - 12 Education reports the committee substitute favorably; and the Committee on Appropriations reports the committee substitute favorably

## CS/SB 1102 (SO) by the Committee on Fiscal Policy and Senator Calatayud—

**School Readiness Program**; Revising the criteria for a child to receive priority for participation in the school readiness program; providing requirements for a school readiness program provider to be eligible for specified funding beginning on a specified date, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Education Pre-K - 12; reported favorably by the Appropriations Committee on Pre-K - 12 Education; and reported favorably as a committee substitute by the Committee on Fiscal Policy

# CS/CS/CS/SB 1180 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Gaetz—

**Sexual Images**; Prohibiting a person from possessing with the intent to promote specified depictions that include a lewd or lascivious image; prohibiting a person from knowingly soliciting specified depictions of child pornography; prohibiting a person from knowingly possessing, controlling, or intentionally viewing a visual depiction he or she knows includes an altered sexual depiction of an identifiable minor; providing criminal penalties for persons who possess with the intent to promote an altered sexual depiction of an identifiable person without the consent of the identifiable person, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/CS/HB 757(HC) in the Committee on Fiscal Policy

### CS/SB 1150 (SO) by the Committee on Education Pre-K - 12 and Senator Calatayud—

**School Social Workers;** Providing that persons employed as school social workers are exempt from certain teacher certification requirements; providing an exception, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Appropriations Committee on Pre-K - 12 Education reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

#### CS/CS/SB 1136 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Collins—

Age as an Element of a Criminal Offense; Providing that ignorance of a victim's age, misrepresentation of a victim's age, and a bona fide belief concerning a victim's age are not defenses to certain offenses in which the victim's age is an element of the offense; providing an exception; revising the age requirements for committing the offenses relating to luring or enticing a child, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/HB 777, 1st Eng.(HC) in the Committee on Fiscal Policy

#### SB 1054 (SO) by Senator Garcia and others—

Tampering with an Electronic Monitoring Device; Reclassifying the offense of tampering with an electronic monitoring device to provide graduated penalties; requiring termination of pretrial release of a person who tampers with such a device while on pretrial release, etc. Effective Date: 10/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably by the Appropriations Committee on Criminal and Civil Justice; and reported favorably by the Committee on Fiscal Policy

Similar to CS/CS/HB 437(HC) in the Committee on Fiscal Policy
