## CS/SB 1080 (3R) by the Committee on Rules and Senator McClain—

Local Government Land Regulation; Requiring counties to specify minimum information necessary for certain applications; prohibiting counties from limiting the number of quasi-judicial or public hearings held each month in certain circumstances; authorizing owners of certain parcels to apply to the governing body of the local government for certification of such parcels as agricultural enclaves; revising the expedited state review process for adoption of comprehensive plan amendments; requiring municipalities to specify minimum information necessary for certain applications; prohibiting municipalities from limiting the number of quasi-judicial or public hearings held each month in certain circumstances, etc. Effective Date: 10/01/2025

# CS/SB 1388 (SO) by the Appropriations Committee on Agriculture, Environment, and General Government and Senator Trumbull—

Vessels; Citing this act as the "Boater Freedom Act"; including Clean Marine Manufacturers within the Clean Marine Program; specifying that the Fish and Wildlife Conservation Commission's authorization to establish protection zones includes modifying the allowable means of certain vessel positioning to prevent significant harm to certain springs; authorizing certain grants to be awarded for the construction and maintenance of publicly owned parking for boat-hauling vehicles and trailers; requiring the commission, in coordination with the Department of Highway Safety and Motor Vehicles, to create the "Florida Freedom Boater" safety inspection decal for specified purposes, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Environment and Natural Resources; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and the Committee on Fiscal Policy reports the committee substitute favorably

# CS/CS/SB 1804 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Criminal and Civil Justice and Senator Martin—

Capital Human Trafficking of Vulnerable Persons for Sexual Exploitation; Specifying that a defendant's memorialized confession or admission in cases of capital human trafficking of vulnerable persons for sexual exploitation is admissible during trial under specified circumstances; requiring that an offender who is convicted of committing capital human trafficking of vulnerable persons for sexual exploitation be designated as a sexual predator; prohibiting a person 18 years of age or older from knowingly initiating, organizing, planning, financing, directing, managing, or supervising a venture that has subjected a child younger than 12 years of age, or a person who is mentally defective or mentally incapacitated, to human trafficking for sexual exploitation, etc. Effective Date: 10/01/2025

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and reported favorably as a committee substitute by the Committee on Fiscal Policy

## CS/CS/SB 1822 (SO) by the Committees on Rules, Community Affairs and Senator Martin—

Waste Management; Deleting obsolete provisions that provide legislative findings and require the Department of Environmental Protection to review and update a specified report; preempting the regulation of auxiliary containers to the state; permitting rules, regulations, or ordinances restricting the use of glass auxiliary containers within the boundaries of a public beach; prohibiting a local government and the Department of Environmental Protection, respectively, from issuing a construction permit for certain solid waste disposal facilities in certain counties, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Environment and Natural Resources; reported favorably as a committee substitute by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

## CS/CS/SB 572 (SO) by the Committees on Fiscal Policy, Judiciary, Senator Collins and others—

Dangerous Dogs; Citing this act as the "Pam Rock Act"; requiring certain dog owners to securely confine their dogs in a proper enclosure; requiring, rather than authorizing, that dogs subject to certain dangerous dog investigations which have killed or bitten a human being to a certain severity be immediately confiscated, placed in quarantine if necessary, impounded, and held; requiring that certain dogs not impounded with the animal control authority be confined in a proper enclosure by the owner; requiring the owner of a dog classified as a dangerous dog to obtain dangerous dog liability insurance coverage and provide proof of such insurance to a certain animal control authority, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Agriculture; reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/HB 593(HC) in the Committee on Fiscal Policy

# CS/CS/SB 270 (SO) by the Appropriations Committee on Higher Education, the Committee on Education Postsecondary and Senator Burgess—

Florida Bright Futures Scholarship Program; Revising eligibility requirements for a student who earns a high school diploma from a non-Florida school under certain circumstances; revising student eligibility requirements for the Florida Academic Scholars award to include earning an Advanced Placement Capstone designation from the College Board, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Postsecondary; reported favorably as a committee substitute by the Appropriations Committee on Higher Education; and the Committee on Appropriations reports the committee substitute favorably

Compare to CS/CS/CS/HB 1105(HC) in the Committee on Rules

## CS/SB 468 (SO) by the Committee on Criminal Justice and Senator Collins—

Fleeing or Attempting to Elude a Law Enforcement Officer; Revising the law enforcement patrol vehicle marking requirements for specified offenses; authorizing the impoundment of a motor vehicle involved in certain violations for a specified period, etc. Effective Date: 10/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 113(HC) in the Committee on Fiscal Policy

## CS/SB 490 (SO) by the Committee on Criminal Justice and Senator Collins—

Concealed Carry Licensing Requirements for Law Enforcement Officers, Correctional Officers, Correctional Probation Officers, and Military Servicemembers; Specifying that correctional probation officers have the right to carry concealed firearms, during off-duty hours, at the discretion of their superior officers; authorizing correctional probation officers to perform certain law enforcement functions under limited circumstances; revising the exceptions to the required 3-day waiting period between purchase and delivery of a firearm, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 383(HC) in the Committee on Fiscal Policy

## CS/SB 496 (SO) by the Committee on Regulated Industries and Senator McClain—

Timeshare Management Firms; Revising applicability for provisions governing conflicts of interest between community association managers or community association management firms and certain persons with a financial interest in such associations; deleting a provision requiring managing entities that perform community association management to comply with certain provisions related to community association management firms; requiring the board of administration of a timeshare condominium to meet once per year, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Regulated Industries; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/HB 897(HC) in the Committee on Fiscal Policy

#### CS/SB 540 (SO) by the Committee on Education Pre-K - 12, Senator Collins and others—

**Disability History and Awareness Instruction;** Citing this act as the "Evin B. Hartsell Act"; requiring the Department of Education to develop specified curricula; authorizing the department to consult with the Evin B. Hartsell Foundation to further develop such curricula, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; and the Committee on Rules reports the committee substitute favorably

Similar to CS/HB 447, 1st Eng.(HC) in the Committee on Rules

# CS/SB 600 (SO) by the Appropriations Committee on Transportation, Tourism, and Economic Development and Senator Truenow—

Manufacturing; Revising the duties of the Department of Commerce; establishing the Chief Manufacturing Officer among the senior leadership of the department; providing that the Chief Manufacturing Officer is appointed by and serves at the pleasure of the Secretary of Commerce; requiring the department to prepare a report regarding manufacturing efforts in this state; creating the Florida Manufacturers' Workforce Development Grant Program; requiring the department, in coordination with the Chief Manufacturing Officer and the state Manufacturing Extension Partnership, to review applications submitted and to select specified projects, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Commerce and Tourism; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and the Committee on Appropriations reports the committee substitute favorably

# CS/SB 602 (SO) by the Appropriations Committee on Transportation, Tourism, and Economic Development and Senator Truenow—

Fees/Florida Manufacturing Promotional Campaign; Requiring the Department of Commerce to assess and collect a specified annual fee sufficient to fund the costs of administering the voluntary Florida Manufacturing Promotional Campaign; requiring that such fees be deposited into the Economic Development Trust Fund for a specified purpose, etc. Effective Date: On the same date that SB 600 or other similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably by the Committee on Commerce and Tourism; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and the Committee on Appropriations reports the committee substitute favorably

## CS/SB 614 (SO) by the Committee on Children, Families, and Elder Affairs and Senator Polsky—

#### Public Education of Background Screening Requirements;

Requiring the Agency for Health Care Administration and the Department of Law Enforcement, in consultation with certain agencies, to develop and maintain a care provider background screening education and awareness webpage; providing requirements for resources provided on the webpage; requiring that specified agencies provide a link to the webpage on their respective websites and promote the inclusion of the link in certain media, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Children, Families, and Elder Affairs; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 531(HC) in the Committee on Fiscal Policy

# CS/CS/SB 890 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Health and Human Services, Senator Yarborough and others—

Improving Screening for and Treatment of Blood Clots; Citing this act as the "Emily Adkins Family Protection Act"; requiring hospitals with emergency departments and ambulatory surgical centers to develop and implement policies and procedures and conduct training for the rendering of appropriate medical attention for persons at risk of forming venous thromboembolisms; requiring the Department of Health to contract with a private entity to establish a statewide venous thromboembolism registry at no cost to the state; revising requirements for certain annual inservice training for certified nursing assistants employed by nursing home facilities, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/CS/CS/HB 1421, 1st Eng.(HC) in the Committee on Fiscal Policy

## CS/SB 1002 (SO) by the Committee on Rules, Senator Truenow and others—

Utility Service Restrictions; Including boards, agencies, commissions, and authorities of counties, municipal corporations, and other political subdivisions of the state with the entities preempted from taking certain actions that restrict, prohibit, or have the effect of restricting or prohibiting the types or fuel sources of energy produced, used, delivered, converted, or supplied by certain entities to serve customers; prohibiting the Florida Building Commission or the State Fire Marshal from adopting into the Florida Building Code or Florida Fire Prevention Code any provision that prohibits or requires the installation of multiple types or fuel sources of energy production which may be used for certain purposes; voiding existing specified documents and policies from governmental entities that are preempted by the act, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Rules

## CS/SB 1060 (SO) by the Appropriations Committee on Health and Human Services, Senator Brodeur and others—

**Medicaid Oversight**; Establishing the Joint Legislative Committee on Medicaid Oversight for specified purposes; requiring the Auditor General and the Agency for Health Care Administration to enter into a data sharing agreement by a specified date; providing that the committee must be given access to certain records, papers, and documents, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Appropriations reports the committee substitute favorably

#### CS/CS/SB 1140 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice, Senator Gruters and others—

Criminal Offender Substance Abuse Pilot Program; Creating a substance abuse accountability pilot program in a specified county; providing for eligibility for the program; providing for design and implementation of the program in the county; authorizing subgrants for personnel needs; requiring a report to certain officials by a specified date, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Appropriations Committee on Criminal and Civil Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/CS/HB 1095(HC) in the Committee on Fiscal Policy

# CS/CS/CS/SB 1270 (SO) by the Committee on Rules, the Appropriations Committee on Health and Human Services, the Committee on Health Policy and Senator Collins—

Department of Health; Repealing a provision which provides for the repeal of the definition of the term "messenger ribonucleic acid vaccine"; defining terms for purposes of background screening requirements for persons affiliated with medical marijuana treatment centers; requiring medical marijuana treatment centers to notify the Department of Health through electronic mail within a specified timeframe after an actual or attempted theft, diversion, or loss of marijuana; authorizing certain physician assistants to be issued temporary certificates for practice in areas of critical need, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, or, if this act fails to become a law until after June 1, 2025, it shall take effect upon becoming a law and shall operate retroactively to June 1, 2025, this act shall take effect July 1, 2025

Reported favorably as a committee substitute by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 1299(HC) in the Committee on Rules

# CS/SB 1528 (SO) by the Committee on Military and Veterans Affairs, Space, and Domestic Security and Senator Collins—

Educational Opportunities for Military Children; Requiring that strategies addressed in specified memoranda of agreement between school districts and military installations include the development and implementation of a specified training module; requiring the Department of Education to provide the training module to each district school board, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Military and Veterans Affairs, Space, and Domestic Security; the Appropriations Committee on Pre-K - 12 Education reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably

#### SB 1578 (SO) by Senator Davis—

Coverage for Mammograms and Supplemental Breast Cancer Screenings; Requiring the Agency for Health Care Administration to provide Medicaid coverage for annual mammograms and supplemental breast cancer screenings for certain women meeting specified criteria, subject to the availability of funds and any limitations or directions the Legislature provides in the General Appropriations Act; revising coverage for mammograms under certain individual accident and health insurance policies, certain group, blanket, and franchise accident and health insurance policies, and certain health maintenance contracts, respectively, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Banking and Insurance; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably by the Committee on Fiscal Policy

### CS/SB 68 (SO) by the Committee on Health Policy and Senator Martin—

**Health Facilities Authorities**; Revising the definition of the term "health facility" to include other entities and associations organized not for profit; revising the powers of health facilities authorities to include the power to issue certain loans and execute related loan agreements; specifying requirements for projects financed by loan agreements issued by a health facilities authority, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Health Policy; and the Committee on Rules reports the committee substitute favorably

#### SB 788 (SO) by Senator Truenow and others—

**Veterans' Nursing Homes;** Defining the term "veteran- and spouse-designated nursing home beds"; authorizing the executive director of the Department of Veterans' Affairs to approve requests to create or modify veteran- and spouse-designated nursing home beds if certain conditions are met; authorizing the department to adopt rules, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Military and Veterans Affairs, Space, and Domestic Security; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably by the Committee on Fiscal Policy

Similar to CS/HB 797(HC) in the Committee on Fiscal Policy

#### CS/CS/SB 1800 (SO) by the Appropriations Committee on Health and Human Services, the Committee on Health Policy and Senator Calatayud—

**Parkinson's Disease;** Creating the "Parkinson's Disease Research Act"; establishing the Consortium for Parkinson's Disease Research within the University of South Florida; establishing the Parkinson's Disease Research Board; requiring the board to direct the operations of the consortium; requiring the board to award funds to board members for certain purposes, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 1545(HC) in the Committee on Fiscal Policy

# CS/CS/CS/SB 1742 (SO) by the Committee on Rules, the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Regulated Industries, Senator Bradley and others—

Condominium and Cooperative Associations; Prohibiting a person whose community association manager license is revoked from having an indirect or direct ownership interest in, or being an employee, a partner, an officer, a director, or a trustee of, a community association management firm for a specified timeframe; prohibiting a community association manager or a community association management firm from knowingly performing any act directed by the community association if such act violates any state or federal law; authorizing an association board meeting to be conducted in person or by video conference; requiring a cooperative association to create and maintain an online account with the division, etc. Effective Date: Except as otherwise provided in this act, this act shall take effect July 1, 2025

Reported favorably as a committee substitute by the Committee on Regulated Industries; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Rules

# CS/CS/SB 1618 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Pre-K - 12 Education and Senator Calatayud—

Education; Deleting the Florida School for Competitive Academics from the list of entities subject to certain audit requirements; authorizing the Office of Program Policy Analysis and Government Accountability to develop contracts or agreements with institutions in the State University System for a specified purpose; requiring the department to take into account underrepresented groups in administering the apprenticeship training program, rather than minority and gender diversity; changing the term "gender" to "sex"; deleting a provision requiring the Commissioner of Education to determine whether school districts have maximized efforts to include minority persons and persons of lower socioeconomic status on their school advisory councils, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2025

Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and reported favorably as a committee substitute by the Committee on Fiscal Policy

## CS/SB 1590 (SO) by the Appropriations Committee on Pre-K - 12 Education and Senator Burgess—

**Educator Preparation;** Requiring the Department of Education to establish a workgroup to update and revise the Florida Educator Accomplished Practices; requiring the department to submit workgroup findings to the Governor and the Legislature by a certain date; establishing guidelines for teacher preparation program uniform core curricula, etc. Effective Date: Upon becoming a law

Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and the Committee on Fiscal Policy reports the committee substitute favorably

Compare to CS/CS/HB 875, 1st Eng.(HC) in the Committee on Rules

#### CS/SB 1160 (SO) by the Committee on Governmental Oversight and Accountability, Senator Leek and others—

Benefits for Certain Officers Injured in the Line of Duty; Revising eligibility criteria for health insurance coverage provided to law enforcement, correctional, and correctional probation officers injured in the line of duty and to their spouses and dependent children, etc. Effective Date: 07/01/2025

Reported favorably as a committee substitute by the Committee on Governmental Oversight and Accountability; and the Committee on Appropriations reports the committee substitute favorably

Similar to CS/HB 751(HC) in the Committee on Appropriations

## CS/SB 1150 (SO) by the Committee on Education Pre-K - 12 and Senator Calatayud—
