2025 REGULAR SESSION DATES

- August 2, 2024 Deadline for filing claim bills (Senate Rule 4.81(2))
- January 29, 2025 5:00 p.m. All requests for drafts of general bills, memorials, and joint resolutions, including requests for companion bills must be submitted
- February 28, 2025 5:00 p.m. All drafts of general bills, memorials, and joint resolutions, including drafts for companion bills, must be approved to file in final form
 - March 4, 2025 Regular Session convenes (Article III, section 3(b), State Constitution) 12:00 noon, deadline for filing bills for introduction (Senate Rule 3.7(1))
 - April 19, 2025 Motion to reconsider made and considered the same day (Senate Rule 6.4(4)) All bills are immediately certified (Senate Rule 6.8)
 - April 22, 2025 50th day Last day for regularly scheduled committee meetings (Senate Rule 2.9(2))
 - May 2, 2025 60th day Last day of Regular Session (Article III, section 3(d), State Constitution)

BILLS ON THE CALENDAR

FIRST PUBLICATION ON SECOND READING

SB 1906 (2R1) by Senator Brodeur-

Debt Reduction; Revising requirements for the debt affordability report prepared annually by the Division of Bond Finance to include specified information relating to state debt; creating the Debt Reduction Program within the State Board of Administration for a specified purpose; requiring the Division of Bond Finance to use its best efforts to use specified funds to achieve such purpose, etc. Effective Date: 07/01/2025

Reported favorably by the Committee on Appropriations

SJR 1908 (2R1) by Senator Hooper-

Budget Stabilization Fund; Proposing an amendment to the State Constitution to increase the amount of funds that may be retained in the budget stabilization fund, require an annual transfer to the budget stabilization fund if there is not a revenue shortfall, and allow the legislature to withdraw funds periodically for critical state needs, etc.

Reported favorably by the Committee on Appropriations
