**CS/CS/HB 443 (3R) by the Committees on Education & Employment Committee, Education Administration Subcommittee, Representatives Snyder, Rizo and others—**

**Charter Schools;** Revises provisions relating to charter school codes of student conduct, enrollment, capacity, compliance with law, facilities, ad valorem taxes, student data; revises provisions relating to high-performing charter schools; revises provisions relating to sale, transfer, lease, or disposal of school district property. Effective Date: 07/01/2025

*Substituted for **CS/CS/SB 822(SUB)** (Rodriguez), read the second time, and amended on April 29, 2025*

**CS/HB 1609, 1st Eng. (3R) by the Committee on Intergovernmental Affairs Subcommittee, Representatives Weinberger, Borrero and others—**

**Waste Incineration;** Prohibits local government or DEP, respectively, from issuing construction permit for certain new solid waste disposal facility or waste-to-energy facility in specified areas. Effective Date: 07/01/2025

*Substituted for **CS/CS/SB 1822(SUB)** (Martin), read the second time, and amended on April 29, 2025*

**HB 653 (3R) by Representatives Holcomb, Nix and others—**

**Aggravating Factors for Capital Felonies;** Adds as an aggravating factor that capital felony was committed against head of state, or in an attempt to commit such crime capital felony was committed against another individual. Effective Date: 07/01/2025

*Substituted for **SB 776(SUB)** (Ingoglia) and read the second time on April 29, 2025*

**CS/CS/HB 481 (3R) by the Committees on State Affairs Committee, Natural Resources & Disasters Subcommittee, Representative Lopez, V. and others—**

**Anchoring Limitation Areas;** Restricts local regulation of vessels outside marked boundaries of mooring fields in certain counties; designates specified sections of Biscayne Bay in Miami-Dade County as grandfathered-in anchoring limitation areas; increases prohibited anchoring & mooring distance of vessels & floating structures near public mooring fields. Effective Date: Upon becoming a law

**CS/CS/SB 138 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Criminal Justice and Senator Wright—**

**Driving and Boating Offenses;** Citing this act as "Trenton's Law"; prohibiting a person from driving or being in actual physical control of a vehicle while under the influence of any impairing substance; requiring that a person be told that his or her failure to submit to a lawful test of breath or urine is a second degree misdemeanor or a first degree misdemeanor under certain circumstances; classifying a person's refusal to submit to a chemical or physical test of breath or urine as a second degree misdemeanor or a first degree misdemeanor under certain circumstances; authorizing state attorneys to create driving under the influence diversion programs, etc. Effective Date: 10/01/2025

**CS/SB 306 (SO) by the Committee on Health Policy, Senator Sharief and others—**

**Medicaid Providers;** Requiring the Agency for Health Care Administration to include specified requirements in its contracts with Medicaid managed care plans, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/CS/CS/SB 1742 (SO) by the Committee on Rules, the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Regulated Industries, Senator Bradley and others—**

**Condominium and Cooperative Associations;** Prohibiting a person whose community association manager license is revoked from having an indirect or direct ownership interest in, or being an employee, a partner, an officer, a director, or a trustee of, a community association management firm for a specified timeframe; prohibiting a community association manager or a community association management firm from knowingly performing any act directed by the community association if such act violates any state or federal law; authorizing an association board meeting to be conducted in person or by video conference; requiring a cooperative association to create and maintain an online account with the division, etc. Effective Date: Except as otherwise provided in this act, this act shall take effect July 1, 2025

**CS/SB 7016 (SO) by the Committees on Fiscal Policy, and Ethics and Elections (Gaetz)—**

**Amendments to the State Constitution;** Requiring the Secretary of State to have received the ballot summary and the full text of the proposed revision or amendment to the State Constitution from the sponsor and to have received the financial impact statement from the Financial Impact Estimating Conference before submitting an initiative petition to the Attorney General; revising the criteria that the Attorney General uses when petitioning the Supreme Court for an advisory opinion related to a proposed revision or amendment to the State Constitution, etc. Effective Date: Except as otherwise provided in this act, this act shall take effect upon becoming a law

**SB 734 (SO) by Senator Yarborough and others—**

**Actions for Recovery of Damages for Wrongful Death;** Deleting a provision prohibiting the recovery of certain damages by specified parties related to the decedent in wrongful death proceedings, etc. Effective Date: 07/01/2025

*Reported favorably by the Committee on Judiciary; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably by the Committee on Rules*

Similar to **HB 6017(HC)** in the Committee on Rules

---

**CS/CS/SB 628 (SO) by the Committees on Transportation, Criminal Justice and Senator Martin—**

**Boating Safety;** Citing this act as "Lucy's Law"; revising the definition of the term "livery vessel"; revising and providing penalties for vessel collisions, accidents, and casualties; revising and providing penalties for reckless or careless operation of a vessel; requiring the suspension of driver licenses for boating under the influence and reckless or careless operation of a vessel; requiring a person convicted of a certain criminal violation or certain noncriminal infractions within a specified period to complete a boater safety education course, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Transportation; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/CS/CS/SB 712 (SO) by the Committee on Rules, the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Community Affairs and Senator Grall—**

**Construction Regulations;** Requiring the Department of Environmental Protection to adopt minimum standards for the installation of synthetic turf on specified properties; requiring that, for certain contracts entered into on or after a specified date, local governmental entities approve or deny certain price quotes and provide notice to contractors within a specified timeframe; prohibiting the state or political subdivisions that contract for public works projects from penalizing or rewarding bidders for performing larger or smaller volumes of construction work for the state or political subdivisions when scoring or evaluating certain bids; requiring that elevator car interiors have at least one support rail that meets certain specifications, etc. Effective Date: 07/01/2025

**CS/CS/CS/SB 818 (SO) by the Committees on Appropriations, Rules, Transportation and Senator McClain—**

**Utility Relocation;** Requiring that a specified amount of communications services tax remittances be distributed by the Department of Revenue by a nonoperating transfer to the Department of Commerce in monthly installments to the Grants and Donations Trust Fund within the Department of Commerce for the Utility Relocation Reimbursement Grant Program; revising the percentage by which a certain amount transferred into the Local Government Half-cent Sales Tax Clearing Trust Fund must be reduced, beginning on a certain date; specifying that a county or municipal authority is not responsible for paying the expense properly attributable to such work except as otherwise provided; creating the Utility Relocation Reimbursement Grant Program within the Department of Commerce; providing the purpose of the program, etc. Effective Date: 10/01/2025

**CS/CS/SB 1212 (SO) by the Committees on Fiscal Policy, Banking and Insurance, Senator DiCeglie and others—**

**Firefighter Health and Safety;** Requiring the Division of State Fire Marshal within the Department of Financial Services to assist in decreasing the frequency and severity of fatalities; authorizing the division to recommend a phased approach in adopting certain rules related to firefighting gear; requiring the division to adopt rules relating to education on chemical hazards and toxic substances in protective gear and employers' mental health best practices, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

**CS/CS/SB 1356 (SO) by the Committees on Fiscal Policy, Education Postsecondary, Senator Burton and others—**

**Florida Institute for Pediatric Rare Diseases;** Establishing the Florida Institute for Pediatric Rare Diseases within the Florida State University College of Medicine; requiring the institute to establish and administer the Sunshine Genetics Pilot Program for a specified period; providing institute responsibilities and duties relating to the pilot program; providing requirements for participation in the pilot program and data collection and release in the pilot program, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Education Postsecondary; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

**CS/SB 1360 (SO) by the Committee on Criminal Justice and Senator Leek—**

**Controlled Substances;** Excepting from the Schedule I controlled substance xylazine drug products approved by the United States Food and Drug Administration for certain use; creating the offense of trafficking in xylazine, etc. Effective Date: 10/01/2025

*Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

*Similar to CS/HB 57(HC) in the Committee on Fiscal Policy*

---

**SB 7032 (SO) by the Appropriations Committee on Health and Human Services (Trumbull)—**

**Medicaid Enrollment for Permanently Disabled Individuals;** Requiring that certain persons who receive specified Medicaid-covered services and who are permanently disabled be presumed eligible for continued Medicaid coverage during redetermination processes; requiring the Agency for Health Care Administration to continue to make payments for such services; requiring certain persons to notify the agency and the Department of Children and Families of certain changes in disability or economic status; requiring the agency to seek federal authorization to exempt certain persons from annual redetermination of eligibility, etc. Effective Date: 07/01/2025

*Reported favorably by the Committee on Appropriations*

*Identical to CS/CS/HB 1227(HC) in the Committee on Appropriations*

---

**CS/SB 80 (SO) by the Committee on Environment and Natural Resources, Senator Harrell and others—**

**State Land Management;** Citing this act as the "State Park Preservation Act"; requiring public hearings for all updated conservation and nonconservation land management plans; requiring the Division of Recreation and Parks of the Department of Environmental Protection to comply with specified provisions when granting certain privileges, leases, concessions, and permits; requiring that individual management plans for parcels located within state parks be developed and updated with input from an advisory group, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

*Similar to CS/CS/HB 209(HC) in the Committee on Fiscal Policy*

**CS/SB 716 (SO) by the Committee on Criminal Justice and Senator Martin—**

**Sexual Offenses by Persons Previously Convicted of Sexual Offenses;** Providing mandatory minimum terms of imprisonment for specified sexual offenses when committed by registered sexual offenders or sexual predators; providing requirements for such sentences, etc. Effective Date: 10/01/2025

*Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/CS/SB 270 (SO) by the Appropriations Committee on Higher Education, the Committee on Education Postsecondary and Senator Burgess—**

**Florida Bright Futures Scholarship Program;** Revising eligibility requirements for a student who earns a high school diploma from a non-Florida school under certain circumstances; revising student eligibility requirements for the Florida Academic Scholars award to include earning an Advanced Placement Capstone designation from the College Board, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Education Postsecondary; reported favorably as a committee substitute by the Appropriations Committee on Higher Education; and the Committee on Appropriations reports the committee substitute favorably*

**CS/CS/SB 1618 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Pre-K - 12 Education and Senator Calatayud—**

**Education;** Deleting the Florida School for Competitive Academics from the list of entities subject to certain audit requirements; authorizing the Office of Program Policy Analysis and Government Accountability to develop contracts or agreements with institutions in the State University System for a specified purpose; requiring the department to take into account underrepresented groups in administering the apprenticeship training program, rather than minority and gender diversity; changing the term "gender" to "sex"; deleting a provision requiring the Commissioner of Education to determine whether school districts have maximized efforts to include minority persons and persons of lower socioeconomic status on their school advisory councils, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2025

**CS/SB 1590 (SO) by the Appropriations Committee on Pre-K - 12 Education and Senator Burgess—**

**Educator Preparation;** Requiring the Department of Education to establish a workgroup to update and revise the Florida Educator Accomplished Practices; requiring the department to submit workgroup findings to the Governor and the Legislature by a certain date; establishing guidelines for teacher preparation program uniform core curricula, etc. Effective Date: Upon becoming a law

*Reported favorably by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/SB 1150 (SO) by the Committee on Education Pre-K - 12 and Senator Calatayud—**

**School Social Workers;** Providing that persons employed as school social workers are exempt from certain teacher certification requirements; providing an exception, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; the Appropriations Committee on Pre-K - 12 Education reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably*

**CS/CS/SB 736 (SO) by the Appropriations Committee on Agriculture, Environment, and General Government, the Committee on Environment and Natural Resources, Senator Truenow and others—**

**Brownfields;** Deleting a provision requiring certain property owners to provide information regarding institutional controls to the local government for mapping purposes; revising the conditions under which an applicant who has rehabilitated a contaminated site may submit and claim certain tax credits; deleting the definition of the term "monetary compensation"; revising the date by which the Department of Environmental Protection must issue annual site rehabilitation tax credit certificate awards, etc. Effective Date: 07/01/2025

**CS/CS/CS/SB 1702 (SO) by the Committee on Rules, the Appropriations Committee on Pre-K - 12 Education, the Committee on Education Pre-K - 12 and Senator Burgess—**

**Education;** Specifying sufficient notice and prior warning for immediate arrest and prosecution for school bus trespassing; authorizing a private school in a county that meets certain criteria to construct new facilities on certain property; requiring a charter school sponsor to use a standard monitoring tool to monitor and review a charter school; authorizing a student in a full-time virtual instruction program to participate on an interscholastic athletic team at a public school in the school district in which the student resides or to develop an agreement to participate at a private school; requiring the Commissioner of Education to coordinate with school districts selected by the department to implement a policy for a specified school year prohibiting the use of cell phones while on school grounds or engaged in certain activities off school grounds, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Education Pre-K - 12; reported favorably as a committee substitute by the Appropriations Committee on Pre-K - 12 Education; and reported favorably as a committee substitute by the Committee on Rules*

**CS/CS/CS/SB 1270 (SO) by the Committee on Rules, the Appropriations Committee on Health and Human Services, the Committee on Health Policy and Senator Collins—**

**Department of Health;** Repealing a provision which provides for the repeal of the definition of the term “messenger ribonucleic acid vaccine”; defining terms for purposes of background screening requirements for persons affiliated with medical marijuana treatment centers; requiring medical marijuana treatment centers to notify the Department of Health through electronic mail within a specified timeframe after an actual or attempted theft, diversion, or loss of marijuana; authorizing certain physician assistants to be issued temporary certificates for practice in areas of critical need, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, or, if this act fails to become a law until after June 1, 2025, it shall take effect upon becoming a law and shall operate retroactively to June 1, 2025, this act shall take effect July 1, 2025

**Health Care Patient Protection;** Requiring hospital emergency departments to develop and implement policies and procedures, conduct training, record weights in a certain manner, designate a pediatric emergency care coordinator, and conduct specified assessments; requiring the Agency for Health Care Administration to adopt certain rules for comprehensive emergency management plans; requiring the agency to collect and publish the results of specified assessments submitted by hospitals by specified dates, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Health Policy; the Appropriations Committee on Health and Human Services reports the committee substitute favorably; and the Committee on Fiscal Policy reports the committee substitute favorably*

**CS/CS/SB 1612 (SO) by the Committees on Fiscal Policy, Banking and Insurance and Senator Grall—**

**Financial Services;** Revising the conditions for insurance coverage to be eligible for export; requiring state financial institutions to pay a semiannual assessment for specified time periods; authorizing the office to issue a specified certificate under certain circumstances; authorizing certain elected officers, directors, or committee members of a credit union to be reimbursed for certain expenses, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2025

*Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Appropriations Committee on Agriculture, Environment, and General Government reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

**CS/CS/CS/SB 1842 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Health and Human Services, the Committee on Health Policy and Senator Burton—**

**Health Care Provider Referrals;** Requiring certain health care providers to disclose, in writing, specified information to their patients before making a referral for certain health care services, etc. Effective Date: 07/01/2025

*Reported favorably as a committee substitute by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

**CS/SB 1568 (SO) by the Appropriations Committee on Health and Human Services and Senator Brodeur—**

**Electronic Prescribing;** Revising health care practitioners who may only electronically transmit prescriptions for certain drugs; revising exceptions, etc. Effective Date: 07/01/2025

*Reported favorably by the Committee on Health Policy; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Rules reports the committee substitute favorably*

**CS/CS/SB 1726 (SO) by the Committee on Rules, the Appropriations Committee on Higher Education and Senator Calatayud—**
