SB 2510 Florida Gaming Control Commission

Commission Structure	Deletes the requirement that each of the five members of the commission are from each of the state's appellate districts	No substantive language	Senate
Appointments	Allows a person who has lobbied for a state agency to be appointed as a commissioner or commission employee	No substantive language	Senate
Conforming Changes	<p>Makes conforming changes as it relates to the Division of Pari-mutuel Wagering:</p> <ul style="list-style-type: none"> • Administration of the Pari-mutuel Wagering Trust Fund (PMWTF) • Hearing and notice requirements • Provides that the PMWTF is to be used to fund the operating costs of the commission • License Fees • Game Promotion 	No substantive language	Senate with technical changes clarifying that all revenues of the Pari-mutuel Wagering Trust Fund can be utilized by the commission in its duties.
PMWTF	Deletes the transfer of balance exceeding \$1.5 million from the PMWTF to the General Revenue Fund	No substantive language	Senate

Section 1 – Florida Digital Service	Effective July 1, 2022, transfers via a Type two the Florida Digital Service, with the exception of the State Data Center, to the Executive Office of the Governor.	No substantive language	House – No Language
Section 2 – Contracts and Agreements	Specifies that any contracts or agreements in force between the Florida Digital Serve remain in force with the successor department or entity	No substantive language	Senate Modified (Section 2) – Defines a service level agreement to include a provider of data center services
Section 3 – State Data Center	Consolidates the State Data Center and all records, functions, personnel, contracts, agreements, and equipment into the Northwest Regional Data Center.	No substantive language	Senate modified (Section 1) - Transfers all current SDC personnel, contracts, interagency agreements, and assets to NWRDC
Section 4 – Enterprise Florida First technology Center	Establishes the center within the Executive Office of the Governor Specifies the requirements for the director of the center Requires the designation of a chief data officer	No substantive language	Senate Modified (Section 3) – Removes duties and responsibilities relating to the state data center from the Florida Digital Service
Sections 5-11, 13, and 14	Makes changes to various statutes that conform to the transfer of the Florida Digital Service and State Data Center	No substantive language	Senate modified – Modifies language related to the transfer of the state data center services
Section 12	Designates the Northwest Regional Data Center as the State Data Center and preferred cloud services provider for state agencies	No substantive language	Senate modified – Designates the Northwest Regional Data Center as a state data center service provider for state agencies
New Section			Senate new language (Section 4) – <ul style="list-style-type: none"> • Adds duties and responsibilities relating to the state data center to the Department of Management Services • Requires the DMS to contract with NWRDC to manage and operate the state data center
New Section			Senate new language (Section 5) – Designates NWRDC as a state data center and outlines operational instructions
