Counsel:

In correspondence dated April 23, 2019, I referred to our discussion of depositional testimony being provided in lieu of live testimony at the final hearing. I also noted that the transcripts of such testimony are to be provided at the prehearing conference pursuant to Senate Rule 12.9(3), which was subsequently noted in correspondence sent on May 2, 2019.

The same May 2, 2019 correspondence required the parties to submit, by May 15, 2019, the names, addresses, and nature of testimony for witnesses for whom the parties suggest subpoenas be issued. I received no communication objecting to these requirements or the timeframe.

As of May 15, 2019, the Governor has withdrawn all witnesses and Mr. Israel submitted a list of witnesses for whom he suggests subpoenas be issued; however, two parties are unnamed and no addresses have been provided for potential service.

As a courtesy to the parties, I am extending the deadline to 5:00 p.m., Thursday, May 23, 2019. Failure to provide the information listed below, for each witness identified below, will be interpreted as withdrawal of such witness(es).
